PRESIDENTIAL TAPING: NEW YEAR'S MESSAGE TO THE SOVIET PEOPLE FRIDAY, DECEMBER 27, 1985

Good evening. This is Ronald Reagan, President of the United States. I am pleased to speak to you on the occasion of the New Year. This is a time for reflection -- and for hope. As we look back on the year just concluded, and on the year that is to come, I want to share with you my hopes for the new year, hopes for peace and good will that the American and Soviet peoples share.

Just over a month ago, General Secretary Gorbachev and I met for the first time in Geneva. Our purpose was to begin a fresh chapter in the relations between our two countries, and to try to reduce the suspicions and mistrust between us. I think we made a good beginning. Mr. Gorbachev and I spent many hours together, speaking frankly and seriously about the most important issues of our time: reducing the massive nuclear arsenals on both sides, resolving regional conflicts, ensuring respect for human rights as guaranteed under international agreements, and other questions of mutual interest.

In Geneva, I told Mr. Gorbachev of the American people's deep desire for peace and that the American people do not wish the Soviet people any harm. While there were many areas where we did not agree -- which was to be expected -- we left Geneva with a better understanding of one another, and of the goals we each have. We are determined to build on that understanding in the coming months and years.

One of the most important things on which we agreed was the need to reduce the massive nuclear arsenals on both sides. As I have said many times, a nuclear war cannot be won, and must never be fought. Therefore, we agreed to accelerate negotiations, where there is common ground, to reduce and eventually eliminate the means of nuclear destruction. Our negotiators will soon be returning to the Geneva talks on nuclear and space arms where Mr. Gorbachev and I agreed we will seek agreements on the principle of 50 percent reductions in offensive nuclear arms and an interim agreement on intermediate range nuclear systems.

And it is my hope that one day, we will be able to eliminate these weapons altogether, and rely increasingly for our security on defensive systems which threaten no one. Both the U.S. and Soviet Union are doing research on the possibilities of harnessing new technologies to the cause of defense. If these technologies become a reality, it is my dream to one day free us all from the threat of nuclear destruction.

One of the best ways to build mutual understanding is to allow the American and Soviet peoples to get to know one another better. In Geneva, we signed a new agreement to exchange our best artists, scholars, and musicians. We also agreed to expand the contacts between our peoples so that students, teachers, and young people can get to know each other directly. If people in both countries can visit, study, and work together, too, then we will strengthen the bonds of understanding and build a true foundation for lasting peace.

I also discussed the American people's strong interest in humanitarian issues. Our democratic system is founded on the belief in the sanctity of human life and the rights of the individual -- rights such as freedom of speech, of assembly, of movement, and of worship. It is a sacred truth to us that every individual is a unique gift of God, with his or her own special talents, abilities, hopes, and dreams. Respect for all people is essential to peace. And as we agreed in Geneva, progress in resolving humanitarian issues in a spirit of cooperation would go a long way to making 1986 a better year for all of us.

A safe and lasting peace also requires finding peaceful settlements to armed conflicts which cause so much human suffering in many parts of the world. I have proposed several concrete steps to help resolve such conflicts. It is my hope that in 1986, we will make progress toward this end.

I see a busy year ahead in building on the foundations laid in Geneva. There is much work to be done. Mr. Gorbachev will visit the United States later this year, and I look forward to showing him our wonderful country. In 1987, I plan to visit your country, and hope to meet many of you.

In the name of the American people, I wish you all a happy and healthy new year. Let's work together to make it a year of peace. There is no better goal for 1986, or for any year. Let us look forward to a future of "chistoye nyebo" (CHEE-stah-yeh NYE-bah) for all mankind. Thank you, (spa-SEE-bah-VAHM).

Greetings to Ken Zimmerman and all my Jaycee friends. I hope you are having a productive and enjoyable time there in Tulsa.

I appreciate this opportunity to share a few thoughts with you, and to give you a well-deserved pat on the back for all the fine work the Jaycees have been doing. The community service you provide in the towns and cities across our country is one of the best examples of volunteerism that I can think of. The Jaycees have the energy and have the spirit, the American spirit. You should all be proud to be part of a team that provides leadership to those grassroots efforts that make this the kind of country we all want it to be.

Your President, Ken Zimmerman, is a good example of the high energy and personal dedication for which the Jaycees are famous. If any of you have had trouble getting hold of Ken, it could be because he has been traipsing the country in his van, raising money for the restoration of the Statue of Liberty. The Jaycees have committed half a million dollars to the restoration. Ken's been in the driver's seat in more ways than one to see to it that the goal is reached. When the Statue of Liberty is again proudly holding high its torch, the Jaycees will know they did their part.

Congratulations to the National Retail Merchants Association and your member firms worldwide on this, your 75th anniversary. During this past three-quarters of a century, you've helped to make retailing one of America's leading industries. Today, retail firms employ more than 5-1/2 million men and women and account for annual sales of more than \$300 billion.

In community after community, retail firms serve as the focal point of business; and each month, you get thousands of young people started in the working world by giving them their first jobs. You've helped to provide a steady rise in the American standard of living, and as 1986 opens, you're making available the most extensive range and variety of merchandise at the most competitive prices found anywhere on Earth.

There's something else you're doing -- something for which I want to give you my personal thanks. Throughout the 5 years of our Administration, you of the National Retail Merchants

Association have provided unstinting support for our efforts to get the Federal Government under control and restore our economy to health.

When our Administration took office in 1981, inflation was raging at 12 percent. Today, it's down to less than 4 percent, the lowest rate in almost two decades.

In 1981, interest rates were soaring. The prime rate was at over 20 percent, the highest level since the Civil War. Today

interest rates have fallen dramatically. The prime itself has dropped by more than half, to under 10 percent, and is still falling.

In 1981, growth in the economy had come to a standstill.

Today, we're enjoying the longest economic expansion since the end of World War II -- an expansion which during 1985 alone saw the creation of more than 2 million jobs.

These are solid accomplishments -- historic accomplishments -- in which each of you played a part. Now we face new economic challenges, most notably the double needs to reform our system of taxation and to bring Federal deficit spending to an end.

The Gramm-Rudman-Hollings Amendment, which I signed into law in December, calls for us to deal with deficit spending head-on. It mandates smaller and smaller Federal deficits for each of the next 5 years, until in 1991 the Federal Government has a balanced budget at last.

But while the Amendment tells us that we <u>must</u> bring deficit spending to an end, it leaves crucial questions about just <u>how</u> to do so in the hands of the Congress and the President. And what that means is that I'll need your continuing help to make certain that the Government fulfills its budget obligations in a responsible way.

I think you'll be happy to hear that, as far as I'm concerned, a tax increase is out. I furthermore intend to insist upon the maintenance of a strong national defense as the first duty of the Government to the people. We've come too far in

rebuilding our defenses, and thereby regaining the respect of the world, to squander all that we've so painstakingly achieved.

Instead, our Administration will prepare budgets which eliminate Government inefficiency and curtail needless expenses like vast subsidies for Amtrak and student loans for the rich.

On tax reform, I'll also need your help. We want to bring down individual rates and make corporate rates lower and fairer. With regard to corporate rates, for example, I know that, dollar for dollar, retailers like you pay one of the highest tax rates of any industry in the Nation.

The tax reform bill passed last year by the House has its weak points, but it succeeds in evening out corporate rates and in bringing down tax rates for most individuals. Now the bill goes to the Senate, where we'll have the chance to correct its faults. But believe me, the special interests are going to be there, lobbying just as hard as they can. To assert the national interest, the interest of <u>all</u> the people, we're going to need your support.

My friends, I'm convinced we can succeed on both these issues, giving the people tax reform and the Government a sense of fiscal responsibility. And when we do so, America will enter an era of unparalleled opportunity and unprecedented economic growth.

Once again, happy anniversary, and God bless you all.

PRESIDENTIAL TAPING: COALITION FOR SDI WEDNESDAY, FEBRUARY 26, 1986

Good evening to all of you at the Coalition for the Strategic Defense Initiative.

And may I extend a personal welcome to our SDI supporters from abroad. As your presence here attests, the hope that one day mankind may be freed from the prison of nuclear terror is a hope to be shared by all the peoples and nations of the world.

Three years ago, I went on nationwide television to announce our Strategic Defense Initiative, calling upon the scientific community to turn their great talents and technological prowess to the cause of world peace. I said that this was a long-term effort, a formidable technical task that may not be accomplished before the end of this century. In any effort of this magnitude, there were bound to be failures and setbacks along the way; but the promise of an anti-nuclear defense was too great, the vision of a world safe from nuclear terror too compelling for America not to accept the challenge.

And accept it we did. Today, SDI is advancing more rapidly than even its most ardent advocates would have originally thought possible. It seems as if almost every month, scientists are finding answers to problems that critics called insolvable the month before. In the age of technology, that good old American know-how is a force for progress, the likes of which this world has never seen before.

The technological revolution is redefining our notions of progress. We are on an upward trajectory of invention that will open up a whole new world of possibilities in the 21st century — and perhaps the most exciting of all is that science is becoming the ally of peace.

Sure, there are still the professional nay-sayers. They write articles on the limits of scientific advancement on word processors filled with micro-chip transistors -- each one a tiny computer that represents a 20,000-fold increase in productivity in less than two decades. More and more, it becomes apparent that the limits are only in some people's minds.

It is ironic that many of those who have arrayed themselves against SDI are the very same ones who for decades have been railing against the policy of Mutual Assured Destruction -- or MAD, as it is so appropriately called. Now, when it seems our deliverance is almost at hand, these same critics have turned around and embraced MAD. Now they say that humankind must learn to live forever in this prison of nuclear terror. It's not unlike the "Stockholm Complex," in which the hostages came to identify with their terrorist captors; or the tales you hear of prisoners, after a long confinement, afraid to leave their prison cell.

But this I promise you -- SDI will go forward, we will break our bondage to terror and stride confidently into the sunshine of peace.

In the meantime, we must continue our efforts for deep and meaningful reductions in our nuclear arsenals; but as events have

already shown, SDI has been a catalyst in bringing the Soviets back to the table and moving arms negotiations forward. SDI is also an essential insurance policy — and with the distressing pattern of Soviet treaty violations, it's an insurance policy no responsible President would ever give up.

The fact is, the rapid rate of technological progress makes a strategic defense not only possible -- it makes it inevitable. The basic technologies enabling such a defense are already being developed in the private sector; if we don't use developing technologies for peace, the other side will certainly use them for their own purposes.

There is no question that SDI is an idea whose time has come. If Lorne (Green) will forgive me, I might even say, SDI is a Bonanza for peace. But if we can look forward to a future safe from nuclear terror, it is in large part due to the effort of all of you at the Coalition for SDI and your work here in the United States and around the world. General Graham, Senators Wallop and Hollings, Representatives Kemp, Hutto, Dornan, Courter and Chappell, and all of you here at the Coalition — the good work you are doing today will win you the gratitude of generations to come. In SDI, you are helping to build a lasting, living monument to peace. There is no greater or more noble work to be done.

So thank you all, and God bless you.
