To amend the Sentencing Reform Act of 1984 to permit (1) the Administrative Office of the United States Courts to request appropriations on behalf of the U.S. Sentencing Commission and (2) Federal judges who have taken senior status to serve on the Sentencing Commission.

Discussion

The Sentencing Reform Act of 1984 ("the Act"), enacted as part of the Comprehensive Crime Control Act of 1984, completely overhauled the Federal criminal sentencing system. The key provision of this legislation was the establishment of the United States Sentencing Commission, an agency of the judicial branch. The Commission, whose membership is to be composed of seven members appointed by the President, is to draft guidelines for Federal judges to use in sentencing persons convicted of criminal offenses. The guidelines are intended to ensure fairer and more uniform sentencing of Federal criminal offenders.

Two problems have arisen with respect to the Act as originally enacted. First, the Act authorizes the Commission's Chairman to request appropriations on behalf of the Commission. Because the Chairman (and the other members) has not been appointed, appropriations have not been requested for the Commission. As a consequence, the Commission has not been able to hire staff and begin its work. Second, the Act requires that the membership of the Commission include at least three regular active service Federal judges. According to the colloquy in the Senate, the Chief Justice has questioned this requirement and has expressed some concern about active Federal judges serving on the Commission. (He is evidently worried that an active judge would find it difficult to serve on the Commission while executing his other judicial responsibilities.)

The enrolled bill, which passed both Houses by voice vote, addresses each of these problems. To overcome the Commission's present budget conundrum, the bill authorizes the Administrative Office of the United States Courts to request appropriations on behalf of the Commission, until the Chairman is appointed. The enrolled bill responds to the Chief Justice's concern by authorizing Federal judges who have taken senior status (i.e., who do not have all the responsibilities of active judges) to serve on the Commission.

I am forwarding the enclosed list of judges, recommended by the Judicial Conference of the United States to serve on the new United States Sentencing Commission, for your consideration.

It is my understanding that Congress has passed legislation to allow senior judges to serve on the Commission, as this would be less disruptive to the courts they serve. Therefore, the list includes senior as well as active judges.

While the new legislation is an improvement, I must repeat my concern as to members of the Judiciary serving, if indeed they must accept a "full time" Executive branch appointment to an independent Commission. Realistically, there is not a single Federal Judge in active service who should devote "full time" attention to anything except performance of Article III duties.

Nationally, criminal filings increased by 4.2% between 1981-82. Nebraska showed a 2.3% increase from 88 in 1981 to 90 in 1982. Criminal terminations for all districts also increased by 5.7%. Nebraska had a decrease of 3.3%. Of the total number of criminal cases filed in the district during the twelve-month period ended June 30, 1982, 19 were for fraud, 5 for embezzlement, 12 for forgery and counterfeiting and 9 for larceny. The pending caseload for all courts increased by 5.0% for 1982. Nebraska experienced a 4.0% decline from 50 in 1981 to 48 in 1982. The median interval between indictment or information and trial is shown in the table below.

Of the 183 defendants charged in Oregon, 35 were not convicted. Charges against 30 of the defendants were dismissed by the court; 4 were acquitted by a jury. The balance of 148 defendants were convicted and sentenced. Of that total 112 entered a plea of guilty; 9 were convicted by the court; and 25 were convicted by a jury.

Of those convicted, 1 received only a fine while 45 were placed on probation with an average sentence of 45.9 months. A total of 101 defendants were imprisoned with an average sentence (excluding split sentences, indeterminate sentences and youth corrections act offender sentences) of 114.0 months. The average sentence for all courts in 1982 was 58.6 months and for the Ninth Circuit it was 58.7 months.



UNITED STATES SENTENCING COMMISSION

Judicial Branch (Justice)

AUTHORITY: 28 U.S.C. 991, et seq. P.L. 98-473, Title II ("Comprehensive Crime Control Act of 1984"), Chapter II ("Sentencing Reform Act of 1984"), Sec. 217, October 12, 1984, effective October 12, 1984

- METHOD: Nominated to the Senate and see below
- MEMBERS: NINE (until November 2, 1991, on which date the Chairman of the United States Parole Commission ceases to be a Member, and the total membership is reduced to eight), as follows:

Chairman of the United States Parole Commission, ex officio, non-voting (thru November 1, 1991); Attorney General, or his designee, ex officio, non-voting;

and

Seven voting Members, including a Chairman

Not more than four of the Members shall be members of the same political party. (Bi-partisan)

Members shall be appointed after consultation with representatives of judges, prosecuting attorneys, defense attorneys, law enforcement officials, senior citizens, victims of crime, and others interested in the criminal justice process.

At least three of the Members shall be Federal judges in regular active service selected after considering a list of six judges recommended to the President by the Judicial Conference of the United States.

A Federal judge may serve as a Member of the Commission without resigning his appointment as a Federal judge.

The Chairman and Members shall be subject to removal from the Commission by the President only for neglect of duty or malfeasance in office or for other good cause shown.

UNITED STATES SENTENCING COMMISSION (Cont'd)

Judicial Branch (Justice)

CHAIRMAN: Appointed by the President from among the voting membership, by and with the advice and consent of the Senate

TERM: SIX YEARS, except that the terms of the first Members shall not begin to run until the sentencing guidelines go into effect (______), and the intitial terms of the first Members of the Commission shall be staggered so that:

> two Members, including the Chairman, serve terms of six years;

three Members serve terms of four years; and

two Members serve terms of two years.

A voting Member appointed to fill a vacancy that occurs before the expiration of the term for which his predecessor was appointed shall be appointed only for the remainder of such term. (NOT HOLDOVER)

No voting Member may serve more than two full terms.

SALARY: The Chairman of the Commission shall hold a full-time position and shall be compensated during the term of office at the annual rate at which judges of the United States courts of appeals are compensated.

The voting Members of the Commission, other than the Chairman, shall hold full-time positions until the end of the first six years after the sentencing guidelines go into effect (through ______) and shall be compensated at the annual rate at which judges of the United States courts of appeals are compensated. Thereafter, the voting members of the Commission, other than the Chairman, shall hold part-time positions and shall be paid at the daily rate at which judges of the United States courts of appeals are compensated.

UNITED STATES SENTENCING COMMISSION (Cont'd)

Judicial Branch (Justice)

To establish sentencing policies and practices for PURPOSE: the Federal criminal justice system that assure the meeting of the purposes of sentencing; provide certainty and fairness in meeting the purposes of sentencing disparities among defendants with similar records who have been found guilty of similar criminal conduct while maintaining sufficient flexibility to permit individualized sentences when warranted by mitigating or aggravating factors not taken into account in the establishment of general sentencing practices; reflect, to the extent practicable, advancement in knowledge of human behavior as it relates to the criminal justice process; and develop means of measuring the degree to which the sentencing, penal, and correctional practices are effective in meeting the purposes of sentencing.

NOTE TO THE EFFECTIVENESS OF THIS ACT:

- (1) Pursuant to the provisions of P.L. 98-473, Title II, Chapter II, Sec. 235(a)(1)(B)(i), the Commission shall submit the initial sentencing guidelines to the Congress not later than April 11, 1986 (submitted).
- (2) Pursuant to Sec. 235(a)(1)(B)(ii) of the Act, the sentencing guidelines so submitted shall not go into effect until the day after:
 - (a) the Commission has submitted the initial set of sentencing guidelines to the Congress pursuant to paragraph (1), above, along with a report stating the reasons for the Commission's recommendations;
 - (b) the General Accounting Office has undertaken a study of the guidelines, and their potential impact in comparison with the operation of the existing sentencing and parole release system, and has, within 150 days of submission of the guidelines, reported to the Congress the result of its study; and
 - (c) the Congress has had six months after the date of the Commission's submission of the initial guidelines in which to examine the guidelines and consider the reports ().
- (3) The sentencing guidelines go into effect on the day after the date cited in (c), above.

UNITED STATES SENTENCING COMMISSION (Cont'd)

Judicial Branch (Justice)

NOTE: Although the "Sentencing Reform Act" creates the U.S. Sentencing Commission and calls for the eventual termination of the U.S. Parole Commission, questions remain as to how this transition would be accomplished.

> The Act provides for the termination of the U.S. Parole Commission on November 1, 1986, but then permits those Commissioners who are in office on that date to continue serving in their respective positions through November 1, 1991. Because the law was not clear in this matter, we contacted Deputy Assistant Attorney General Ron Gainer who advised us on December 13, 1984, that the Department of Justice was also not clear on this provision and that technical, corrective legislation might be sought from the 99th Congress early in its First Session. He will advise us once this matter is clarified.

Once the question is resolved, new, updated authority sheets will be prepared for both the U.S. Sentencing Commission and the U.S. Parole Commission.
