BOMBING INCIDENTS. ON SEPTEMBER 16, 1988, A [REDACTED],
WASHINGTON, D. C., ARREST WARRANT WAS ISSUED FOR TSUTOMU
SHIROSAMI IN CONNECTION WITH THE ATTEMPTED BOMBING OF THE U.S.
EMBASSY, JAKARTA, INDONESIA, ON MAY 14, 1986. SHIROSAMI HAS BEEN

UNKNOWN BUT BELIEVED TO BE IN THE BEKKA VALLEY OF LEBANON.

INVESTIGATION OF THIS MATTER IS BEING COORDINATED BY THE
INTERNATIONAL TERRORISM-GLOBAL UNIT, FBIHQ.
