Here is that note on people still on my conscience, who went beyond the call of duty and should be in the government.

Jerry Carmen - Smart, tough, reliable enough to run General Services Administration.

<u>Max Hugel</u> - Organized Nashua; also worked statewide in New Hampshire, then came to Los Angeles as a volunteer and set up voter groups for me and did a Herculean job with every voter group -senior citizens and youth, ethnics, Blacks, Jews, Hispanics, labor and veterans. I believe that the scope and drive of this effort did as much as anything else to carry the industrial states. I'm happy to take him into the obscurity of the CIA and include him here because I want you to be aware of his very special contribution.

<u>Mary Costello</u> - Had retired to San Diego upon Len Hall's death after 20 years as his secretary. When I became campaign director, I called her to Los Angeles and got her to work as my full-time secretary on a volunteer basis in view of straitened circumstances of our campaign. Has worked day and night for nine months. Now going to live in house she and her sister were building north of Santa Barbara, when I got her to come into the campaign. She is very capable and should be considered if there is to be a western office in the Santa Barbara area.

Charlie Wick - You know and we've talked about.

<u>Fred Ikle</u> - You know, needs level 2 or 3 in State, Defense, international communications, AID, intelligence. Widely respected on Hill and in foreign policy community.

<u>Bill McCann</u> - Runs insurance company with offices around country. He campaigned in primaries in New Hampshire, Vermont, Massachusetts, Florida, Illinois and New York. Raised close to a million dollars. When, in the closing weeks of the campaign, we got some grousing about early supporters not being used sufficiently in the election campaign, I got McCann to head up an operation, called Reagan Pioneers, to bring early supporters into the kind of spontaneous activity we had in the primaries. He did this energetically and well. He'd like to be Ambassador to Ireland. There's a New Yorker, Bill Fine, who gets himself in the newspapers as the next Ambassador to Ireland. He helped on the announcement dinner and did a fund-raiser in New York City, but his contribution does not compare with McCann's.

<u>Gil Robinson</u> - Heads large public relations firm he built in New York. As volunteer, handled public relations for November 1979 announcement dinner in New York, has taken on additional spot chores in campaign and inaugural. Baldridge wants him in Commerce but maybe not at level which he could take. Works well with Charlie Wick and would be good in ICA or AID.

<u>Mark Fowler</u> - Handled all our legal problems with networks and FCC without compensation, including demands for time for Unity dinners, Commitment 80, handling suits and complaints filed with FCC by Carter-Mondale. Seeks FCC Chairmanship.

<u>Bill Middendorf</u> - Ran Washington fund-raiser, campaigned all over south and east as surrogate. Finance Chairman of Inaugural. Should be Chairman, EXIM Bank.

Dom DeCarlo - New York Assemblyman who chaired Reagan for President in New York from your announcement. Expert in criminal code and experienced prosecutor. Interested in Assistant Attorney General-Criminal.

Bernie Kilbourne - New York State Republican Chairman. You'll recall we won 60 votes in primary. Shortly thereafter Kilbourne helped lift this over 100 by action of uncommitted County Chairmn. That jump from 60 to 100 sealed nomination. Kilbourne wants public affairs or legislative liaison spot at Assistant Secretary level.

You really have the long experience and training for the increased voltage your new job brings.

President Reagan has just finished his speech -- consistent and good -- and the National Anthem by the woman from Paso Robles nothing quite like it!

Now I wonder if you received the two letters I sent you in September and November? I sent them to your Sacramento home after talking to your wife and Amanda. 
