Dear Phil:

I've found that your particular concern about the effects that the California Desert Plan will have on the mining interests of the region are currently being examined. The Bureau of Land Management is in the process of proposing a modification in the Plan's surface mining regulations for public lands. The proposal would allow for the use of Notice of Intent procedures in CDCA areas which are classified as either moderate or intensive use, if no more than five acres would be disturbed. This change would streamline the procedure for mining in part of the desert, in accordance with the intent of the Plan.

A key feature of the Plan is its ability to be modified, if changes are necessary. While certain areas have been designated for particular uses, the program's multi-use guidelines have been designed to meet future changing needs of the land. The Plan commits the Bureau of Land Management to an annual review of the program, which will allow consideration of policy changes and accomodation of new uses on a regular basis.

Thank you again for your thoughts on the matter. I hope you will keep me informed.

SUBJECT: Use of Federal Funds for Anti-Administration
Lobbying

I represented the Administration at the annual conference of the Western Gerontological Society in Seattle, Washington last week. This conference was made possible in large part by federal funds.

The President of that society was quoted extensively in the local press denouncing the Reagan Administration as "anti-people" and hostile to older Americans. (See attached article).

Directors of national policy centers funded by the Administration on Aging had a symposium on "Advocacy in the Public Interest" where the impression was clearly left that these centers were coordinating political advocacy behind the scenes in opposition to the proposed Reagan budget cuts. There was no question but that the spokeswomen for these federally funded centers were opposed to the Administration views and philosophy. This, of course, is their prerogative as individuals, but not it seems to me as Directors of federally funded programs. The centers in question were the National Aging Health Policy Center, University of California; the National Aging Policy on Women, University of Maryland; and the National Aging Policy on Housing, University of Michigan. They are funded by the Administration on Aging.

I would recommend that the Administration either:

- (a) quit funding these quasi-political/lobbying operations; or
- (b) put the policy centers on notice that lobbying and political activities are improper for federally funded programs.

Elderly urged to collaborate to save services

Increasing in numbers and proportion of the population, the elderly are the pioneers in a nation beset with profound social and demographic changes, Dr. Carl Eisdorfer, president of the Western Gerontological Association, told its general assembly yesterday.

In the midst of such change, older people must take action or lose the gains they have made over the years with increased federal recognition and support, Eisdorfer said.

The outspoken chairman of the Department of Psychiatry and Behavioral Sciences at the University of Washington urged members at the meeting to form coalitions in the face of federal budget cuts which "selectively address the most needy" in senior programs. Older people must make friends and consider "collaboration with the enemy" to preserve the advances they fought so long for.

"It is far better to do than to be done

unto," Eisdorfer assured the mixed audience of older and younger people who work in programs for the aged throughout the West.

"We can't afford to take the drip-coffee approach and wait for things to drift down, hoping everybody will be a little better off," Eisdorfer said. "We must become lean and mean."

Eisdorfer will remain as president of the group even though he will leave soon to become chairman of the Montefiore School in the Albert Einstein School of Medicine in The Bronx, N.Y.

Eisdorfer assailed the Reagan administration for exhibiting a "peculiar kind of technophilia" and "bizarre kind of psychophobia" in which people are valued less than equipment, behavioral research less than biological.

"It is probably the best example I have seen this century of the 'let them eat cake'

philosophy," he said.

Citing Japan as an example of a nation that values people above profits, Eisdorfer said there are better ways to solve the United States' productivity problems than by setting the rich against the poor, the haves against the have-nots.

Japan, Eisdorfer said, had an overall return on investment of 10 per cent in 1979 compared with the United States' 16 per cent. "It's a difference in the attitude towards people," Eisdorfer said.

Later, during testimony before a congressional committee, Eisdorfer renewed his attack on the administration budget cuts in senior programs, particularly for research. Citing research contributions in nutrition and alternatives to institutional care, Eisdorfer said the most important knowledge is that yet to be discovered.
