Dear Mr. Anderson:

President Reagan's recollection of boyhood July Fourths ("What July Fourth Means to Me," Parade, June 28, 1981) was warm and charming.

Indeed, Presidential assistant Michael K. Deaver's folksy yet reverential assurance that the President wrote it himself conjured up a fleeting image of Lincoln drafting his noble Gettysburg Address. ("This 4th of July message is the President's own words and written initially in his own hand. I thought your readers might like to know that, and that he wrote it on a yellow pad at Camp David the week before last.")

What a surprise, then, to discover that when the President came to the account of some signers of the Declaration of Independence, he borrowed not only the concept but whole sentences and paragraphs from material published in a sheet distributed some years ago by a national business organization (see attached). (This might, of course, exist in a different form which served as the President's immediate "source.") It makes one wonder how much of the rest of the article is in the President's "own words."

I'm sure that a President has more pressing things to do than write original pieces for the newspaper. But then, why represent his work as something it's not? Where I come from it's called "plagiarism."

Thank you for your prompt reply to my letter regarding your denial of passes for private tours of the White House for Congressman Downey's constituents.

I truly regret to see that you have missed the point of my letter. Whether or not Mrs. Reagan was directly involved in your refusal to grant these passes is irrelevant.
