I want to express my appreciation for your willingness to experiment with the new briefing format. I believe -- and I think the President believes -- the new approach has served extremely well.

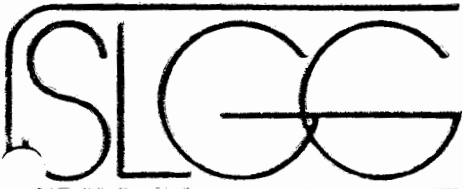
The remainder of the substantive briefing materials will be distributed today. A Summit trip book will be distributed Saturday to members of the official party -- with complete schedules and related logistical details.

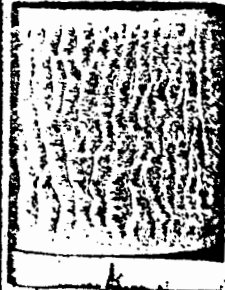
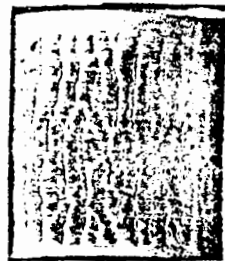
