

Dear Secretary Baldrige,

As a past president and eight year member of the California Fish and Game Commission, under then Governor Reagan, I would urge you to take a hard look at the new Pacific Fishery Management Council recommendation for the taking of anchovies off California and participation in this fishery and others by the Soviet Union.

Because marine biology is an inexact science, I also feel that the 420,000 ton quota set by the PFMC is dangerously high (approximately four times higher than quotas allowed by the Commission, and eight times higher than the fisherman have been able to catch in the past).

In my lifetime I have watched one of the most prolific areas in the world deteriorate into at best a mediocre marine fishery; all this under the watchful eye of government marine biologists.

The fact that there is a bottom in the barrel seems to be elusive. Inviting foreign nations to participate in our already ailing fisheries is a dangerous step. Russia has already overfished it's own waters, and is forced to range far and wide. Mexico has geared up just below the border to fish without restrictions by their government and, with the Russian precedent will probably want to participate in our fisheries when their resources run out.

This action, coupled with offshore drilling policies will make it increasingly difficult to elect Republicans in this state.

Only a small segment of the commercial fisheries would benefit from increased take and foreign participation, while the rest including the related recreational industries and fishing public would suffer from this abuse of the forage fish population.



Dear Senator Hayakawa:

I am writing this letter to recommend to you Judge William J. Rea, of the Los Angeles Superior Court, for appointment to the United States District Court in Los Angeles. Judge Rea is an eminently qualified judge for this position, and has not only my support but the support of many experienced attorneys in Southern California.

It is my understanding that there are one or two appointments available for vacancy in the United States District Court in Los Angeles. Judge Rea has made application for appointment to one of these positions, and I, and the members of the American Board of Trial Advocates, wholeheartedly recommend Judge Rea for this appointment.

Judge Rea is a republican who was appointed to the Los Angeles Superior Court bench by then-Governor Ronald Reagan. He has served on that bench with distinction. During his tenure as a judge of the Superior Court in Los Angeles, he has served in many capacities. In Los Angeles County, the Central Court is located in downtown Los Angeles and there are branch courts located in several areas, including Van Nuys. Judge Rea left the above law firm and moved to Orange County where he became a partner in the law firm of Moore, Graves, Madory & Rea. Since I practiced both in Los Angeles, and commencing January 1, 1961 to the present date in Orange County, I have had ample opportunity to have cases with Judge Rea, contact in various political activities, as well as community affairs. Throughout all of this period of contact, when Judge Rea was an attorney, I came to admire and respect him. He has a conservative, no-nonsense, and lawyer-like approach to all cases and problems. He is a firm believer in the doctrine of stare decisis and believes that this should be an integral part of the judicial system.

Since being appointed to the Superior Court, Judge Rea has displayed an evenness of temper, a capacity to look at all sides of a lawsuit, and a knowledge of the law that has endeared him to all segments of the Bar, both plaintiff and defendant. All attorneys are certain when they appear in front of him that they will receive fair and equal treatment, and that he will follow the law.

As you can see from this letterhead, I am the current President of the American Board of Trial Advocates. This organization is a national organization. In order to qualify for membership in this organization, an individual must have actual experience in handling trials in court. A minimum of 20 jury trials in a court of major jurisdiction must have been handled by the attorney before he is even eligible for membership. His application is then reviewed by other trial lawyers; and only after his background, integrity, and reputation have been checked, is he accepted to membership. I mention this only because of the fact that Judge Rea is not only a member of this organization, and was while he was a practicing attorney, but is one of the former National Presidents of this organization. This, again, speaks very highly of him and his abilities to act as both an administrator, arbiter of disputes, and illustrates his renown as a trial lawyer.

In my opinion, it is extremely important that a Federal Judge, sitting in the District Court in Los Angeles, or any other district, has a broad experience as a trial lawyer so as to be able to handle all types of cases from a standpoint of both civil and criminal litigation. Judge Rea has this experience not only as a trial attorney, but is an experienced and seasoned trial judge who has presided over both criminal and civil matters. Hence, he is highly qualified, has the proper approach to make certain that the


