Decision Day

THE SENATE VOTES today on the sale of a group of advanced airborne warning and control system aircraft. No arms transaction has stirred such controversy since President Roosevelt transferred 50 obsolescent destroyers to Britain, which stood alone and beleaguered early in World War II.

In the course of the current controversy, we believe far too much emphasis has been made of the fact that the aircraft would be going to an Arab nation. And that this, per se, represents a threat to Israel. There is much, much more to be said for the Saudi Arabian viewpoint. A reasonable and just decision must consider these points.

The Saudi Arabians have, time after time, stood against the Khadafys and other irresponsible leaders of oil producing nations who have wanted, through OPEC oil cartel pricing meetings, to bleed Western industrial oil consumers white. Over the last five years, constantly increasing oil prices have been the single most important cause of inflation which has been ruinous throughout the Western World. In the face of this pressure, the Saudis have not only held the line of pricing, but have, in fact, upped production to produce an oil market glut to help to contain inflation.

THE SAUDI ARABIANS have, in fact, often stood alone and against their Arab brothers in this pricing fight, a fight in which the United States has been the principal beneficiary.

They have behaved with total responsibility toward their trading partners.

Along with their Western partners, the Saudis share apprehension over the intentions of the Soviet Union in the Middle East. Recent developments have sharply increased the need of the United States for dependable, stable allies in the Islamic world. Anwar Sadat has been removed by assassination, Iran is experiencing anarchy and chaotic bloodbath, and Afghanistan is under Soviet occupation. The Saudi Arabians become, thus, not just important oil producers but vital allies in an area of turmoil.

FINALLY, THERE IS the "realpolitik" of the Saudi oil. This alone cannot be the determinant of American policy, but it can never really be overlooked either.

The sale, we believe, must not be painted as an aberration of traditional United States support for Israel, a support which we have

Nancy Reagan's

DOES THE AMERICAN public really want visiting dignitaries to be served state meals on marked-down, end-of-the-month sale china? Of course not. It wouldn't have done to have Charles de Gaulle turning up his patrician nose at a plastic plate. And it won't do to have Queen Elizabeth eyeing the chips on a jelly-glass beaker.

We may be guilty of some slight exaggeration in these examples, but, really, what is the current furor all about? There seems a squirrelly notion abroad that Nancy Reagan somehow overstepped some vague bounds of propriety by accepting, for the White House, the donation of a full set of first-class dishes and plates.

WHAT NONSENSE. The money for the china was provided by a private donor. And the White House should certainly be able to receive and entertain its guests of state with all appropriate pomp and circumstance.

Any substantial outlay of funds of this sort.

\$209,508, to be exact — can contribute to a sense of unease. But, in context, we think the country's interests have been well served. Artistic excellence and diplomatic niceties have their place. That goes for the placesettings, as well as the general sense of style and elegance that the Reagans have been at pains to emphasize at the White House.

And it is pleasing that Nancy Reagan doesn't take her own image too seriously, as evidenced in her asking a New York audience the other night whether it had heard of her latest program: The Nancy Reagan Home for Wayward China.
