Dear Mike:

Yesterday I had lunch with Jack O'Connell, a former associate and now a lawyer in Washington. He is probably closer to King Hussein than any other American. In response to my inquiry, O'Connell had the following to say about the recent visit:

King Hussein was delighted with his entire stay in the U.S. He feels that he hit it off with President Reagan and that as a result the problems of Carter's years have been wiped away. The King was impressed by the President's strength and evident belief in principles. He is convinced that the President is the strongest American leader since President Eisenhower. King Hussein is hopeful that this is the beginning of a close relationship, because he believes that he has an important role to play in Middle East peace-making and regional security in cooperation with the U.S.

O'Connell and I agreed that it might be useful for the President to receive from King Hussein a report on the Arab Summit meeting which will take place in Fez, Morocco, on November 25. If the President were to request such a report through normal channels, it would provide a follow-up to the visit and in that sense keep the ball rolling. Further, reporting from such Arab meetings in the past has tended to be spotty since ambassadors who speak with the

Thank you for your recent message. I appreciate the time you have taken to write.

Today our nation faces many difficult problems. At home we are experiencing economic difficulties which are the legacy of the mistaken policies in the past. Abroad we are threatened by the military strength possessed by the enemies of freedom and the window of vulnerability which has opened within our defense systems. Finding solutions to these problems will demand that our Nation make hard choices.

President Reagan has set a course which will lead us on the path to National renewal. His Program for Economic Recovery is aimed at reducing the rate of government spending while stimulating the productivity of the private sector.
