Thank you for your prompt response to the letter from Ken Johnson inviting Secretary Block to address the San Jose Rotary Club. As you may imagine, local interest in the agricultural community, particularly related to the med-fly situation, has increased immeasurably in the last month or so and serves to emphasize any message the Secretary would deliver.

It is our hope that Secretary Block will be visiting California early in 1982 and will be available to address our organization on one of the subjects suggested in our prior correspondence. We meet on Wednesdays for lunch at noon followed by a program of 30-45 minutes, at the Holiday Inn, 282 Almaden Blvd., San Jose. There will be 300 to 350 Rotarians present and, if you would permit, we would expand our regular format and invite the San Jose Chamber of Commerce to participate; this will increase attendance to 700 or more.
