A friend of mine, Thomas F. Kelly, is running for the Congressional District 13 seat (presently held by Norm Mineta of San Jose).


Tom will be in the Washington area from January 28th to February 5th, attending the National Republican Committee Candidates Workshop.

Dear Mike:

It was good to visit with you today. Thank you for taking the time to see Mr. Iacocca.

I think that his comments to you evidences his grave concern over the problems that the housing and automobile industries continue to experience. As you well know, our industry is experiencing its worst sales in over a quarter of a century. When one industry loses \$12 billion in four quarters and at the same time watches the oil companies profit to the tune of \$21 billion during that same period, one wonders if the averages mean very much. All of Michigan and other auto manufacturing states are suffering greatly. There is not a great deal of confidence among those who presently hold jobs that they will have that job next month. I think what Lee was trying to say is that if Reaganomics doesn't kick in fairly soon, how are we going to deal with the very severe wounds that are left in its tracks. I know that he, and the entire Chrysler management team, is supportive of the President's program but feel a deep sense of responsibility to work with all factions of our democratic process to seek targeted relief if the net result would be a restimulation of the economy and brings hundreds of thousands of people back to work.

Please know that we all share the same goals but that the nerve endings with Chrysler management are frayed only because we have gone through so much in the last few years. We appreciate your support. We continue to try and do our best in the current economy. We look forward to the "trickle down" when people will again be able to borrow at reasonable rates and get back into the credit intensive purchases which we have all become accustomed to. That's the American way, I hope!

Realizing your heavy schedule makes it difficult to get together for a visit, what is the best means of contacting you with respect to possibly having lunch or at least a brief visit in your office?



I hope 1982 will be a healthy and happy one for you and your family.

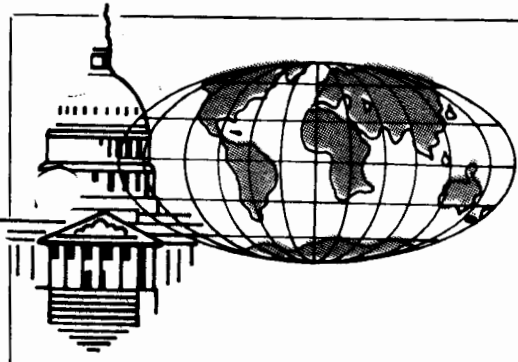

Many thanks for arranging and taking part in our meeting on Monday.

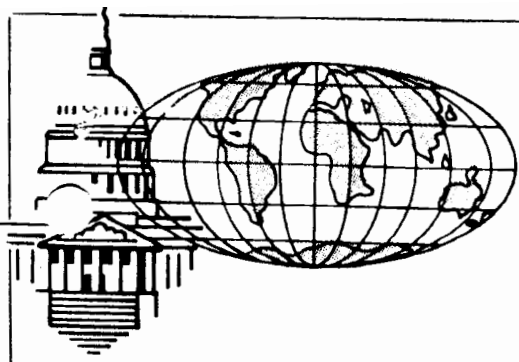
