



Good morning ladies and gentlemen, and welcome to the First General Session of the U.S. Chamber's 70th Annual Meeting.

It's great to see so many of you here from all corners of our nation. But I wonder: who's minding the stores -- and the factories, the farms and the offices?

Ladies and gentlemen, as the outgoing Chairman of the U.S. Chamber of Commerce, it is customary for me to report on my travels and activities of the past year -- and there have been many. But if you will excuse me, I'm not going to do that. We face a challenge today that is simply too urgent to dwell on past victories. Suffice to say, it has been a great honor to serve as your Chairman. And I am so proud of this organization and all of you here for the leading role you played in changing the course of economic history this past year.

But today we stand at a critical juncture. This nation, its leaders and its business community are being tested as never before. At stake is whether we can summon the will and courage to stay on the economic course we know is right -- even though the going has gotten very rough.

It is no secret that a growing number of Americans are disillusioned with the current state of our economy. And they should be. I am too. My heart goes out to the unemployed worker struggling to feed his family and hoping that recovery will come in time. It goes out to the thousands of small businessmen who are teetering on the edge of bankruptcy. For some, recovery is already too late.

Seeing our fellow Americans suffer like this should make us angry. But we must not allow that anger to give way to despair. And above all, we must not confuse the medicine with the illness.

There are those who would have us believe that President Reagan's economic program caused the current recession -- even though the program started last October, while the recession began last August.

There are those who suggest that we face high interest rates and record budget deficits because Congress cut your taxes too much -- even though tax revenues will still go up year by year.

There are those who say that the federal budget -- which has doubled since 1975 and tripled since 1970 -- has already been slashed to the bone.

And there are those who propose major tax increases as a response to the current recession -- the same course followed by a President named Herbert Hoover in 1931.

Ladies and gentlemen, the challenge we face today is no longer economic in nature. Oh, don't get me wrong, we have plenty of economic problems. But we also have a program in place -- tax cuts, spending cuts and regulatory reform -- that is addressing those ailments. It is working and it is going to produce a new era of prosperity for all Americans.

If you have any doubt that the course we have charted is working, let me remind you of a few facts. Since January 1977, we have been under the influence of two basic economic philosophies.

President Carter talked conservatively at times, but his economic policies were pure liberalism. The tax burden increased 75 percent during his tenure and government spending increased almost 60 percent.

Now, when Jimmy Carter took office inflation stood at 4.8 percent. The prime interest rate was 6.25 percent -- imagine that! And unemployment stood at 7.5 percent.

And yet the economy he and a liberal coalition in Congress turned over to Ronald Reagan was saddled with an inflation rate of 12.4 percent. A prime interest rate of 21 percent. And for all that inflation and increased government spending, unemployment was virtually untouched at 7.4 percent.

I don't review this sorry record to condemn a President who tried his best. I do it to remind you of the situation that Ronald Reagan faced when he took office -- the most serious economic calamity since the Great Depression.

Today after just 15 months, a major victory has been scored against inflation -- which was the number one problem President Reagan and the 97th Congress were elected to deal with. The double-digit spiral has been broken. And so far in 1982, inflation has been running at an annual pace of about three percent.

In addition, interest rates have dropped since the President took office, although not as far or as fast as we would like. And American workers and businesses at all income levels have been given the largest tax cuts in our history. We even have some early evidence that since the first round of those tax cuts took effect on October 1st, tax collections, both corporate and individual, are running far above anyone's projections. If this trend continues, the deficit for fiscal 1982 could be tens of billions of dollars less than anyone had forecast.

Dare I say it? Can supply side economics work?

You bet it can and it will. And I'll tell you why I am so confident. The strategy of cutting taxes and government interference to encourage investment, growth and jobs in the private sector is precisely the formula upon which this nation was founded over 200 years ago. Every supply side tax cut in this century has produced the same desired results. And it will this time. The 10 percent tax cut coming in July will lead our economy to a healthy and sustained recovery.

This is no reckless gamble. There is nothing new or radical about what the President has done. It is only new and radical to the bureaucrats and special interests who have parked their derrieres along the banks of the Potomac for the past 40 years living off the taxpayers' dollars. To the rest of us -- an overwhelming majority of Americans -- it is simple common sense.

This is why I say that the challenge we face today is not economic, but a test of our patience and resolve. And I am here to ask your help.

You know, it doesn't surprise me that Tip O'Neill, Walter Mondale or Lane Kirkland are ready to throw the President's program into the garbage heap. Tip has said, and I quote, "I've been one of the big spenders of all time. There's no question about that." He devoutly believes in big government and I respect him for his consistency. But what disturbs me is that many of the same legislators who voted for the President's program last year -- who campaigned up and down the country for it -- are now running from it like rats from a sinking ship. Except that this ship isn't sinking.

They seem to have lost the will and the backbone to make the difficult cuts that must be made. They shake in their shoes every time a special interest wails about a budget cut or the media present another doomsday report. And so rather than challenge the distortions and yes, the lies, they are ready to opt for the easy way out -- or so they think. They are ready to raise your taxes.

Let me see if I can understand the reasoning of the tax hike proponents. They argue that interest rates are too high because the deficit is too big. So far so good. But then they argue that the deficit is big because you and I got too much of a tax cut. Maybe someone should remind those folks that the American worker got a so-called cut of exactly 1.25 percent last year. And that was more than eaten up by inflation and rising social security taxes.

We are then asked to believe that if Congress completely backtracks on the policy it enunciated just last year, and raises taxes, that the financial markets will suddenly discover their long lost confidence and interest rates will magically drop. But show me a time when this has happened.

As bad as the deficit is, there is no evidence that a smaller one brought about by tax increases will reduce interest rates. In fact, in 1982, government's borrowing demands will consume 32 percent of all the funds raised in U.S. credit markets. If you think that's too high, you're damn right it is. But in 1975, Uncle Sam consumed 42 percent and interest rates dropped anyway.

Nor is there any evidence that Congress will use additional taxes to reduce the deficit. But there is plenty of evidence to suggest that it will simply increase spending. At the same time that Congress has been howling in protest over the President's proposed budget deficit, various committees have added \$2.2 billion to his budget for energy and interior programs. Refused to cut the \$1.9 billion budget for alternative fuels and energy conservation. Voted to spend anywhere from \$2 - 5 billion in additional commodity price supports. All told, committee chairmen predict that they will bust the President's 1983 budget by at least \$29 billion. So much for the sanctimonious lectures about budget deficits coming from Capitol Hill!

And there is not even any evidence that a tax increase now would in fact generate additional revenues. I am convinced that a major tax increase in this time of recession would result in a bigger deficit. If that sounds like supply side hocus pocus, I wish you could ask Herbert Hoover. In 1932, his response to a severe recession was to raise taxes to reduce the deficit. Well, despite the higher tax rates, he never saw those additional revenues -- or reelection, for that matter.

This, then, is the message I am asking you to communicate to our allies in Congress. Help us put a steel rod up their spines. And for those who worry about their political prospects if they stick with the President, I suggest they should have more to worry about if they don't.

At the same time, the business community must lead the pack on other great issues. Trade is one example. We will not be

successful in our efforts to rebuild the American economy without increasing our exports -- and yet international economic policy remains at the bottom of the foreign and economic policy totem poles in Washington. This is a grave mistake that has been plaguing our government for some time, and sadly, it has not changed yet under this administration. We must adopt a coherent, activist plan -- directed from the highest levels of government -- to increase trade as a percentage of our GNP.

Another serious issue that the business community must take hold of is immigration. This will emerge as one of the most serious problems we face in the coming decade, ladies and gentlemen. It is a problem because we must carefully balance our proud heritage as a nation of immigrants and refugees on the one hand -- with the need to control what has become an unmanageable flood that we can't accomodate with existing jobs and resources. Not only should Congress and the administration examine immigration statutes carefully, but we must bolster immediately the personnel of the immigration service. As it stands now we have twice as many guards patrolling Capitol Hill than we have patrolling all of our borders. I believe that business has a responsibility in this regard too. We must never condone employers who knowingly hire illegal aliens.

Ladies and gentlemen, if we can inspire action on these fronts -- and above all, convince Congress to preserve our tax cuts and reduce spending, then we will succeed in our mission to rebuild America. We are so close to victory now. Let's not sacrifice the economic future of the next generation on the altar of a few months of bad statistics in 1982. You have never let your country down before and I know you will not do so now.

I am optimistic about the future of this great country -- far more so than when I stood before you at this time last year to begin my term as Chairman. And one of the biggest reasons for my optimism is the man who will be joining us in just a few minutes. As I was thinking about what to say to you today, I came across some of candidate Ronald Reagan's speeches from the 1980 campaign. I was amazed at how closely he has adhered to his promises he made then. Amazed -- because that is such a rare thing in American politics. More than any other President during my lifetime, President Reagan has kept his word to the American people. Just as he has kept his word by joining us today -- as he promised he would last year.

Ladies and gentlemen, when Ronald Reagan first outlined his bold economic program to the American people during a campaign stop in September 1980, he made these comments about his goals: "I am asked, can we do it immediately? My answer is no. I am asked, is it easy? Again my answer is no. It is going to require the most dedicated and concerted peacetime action ever taken by the American people for their country." Ladies and gentlemen, for yourself, your family and your country, this is the challenge we must meet today: The most dedicated and concerted action we have ever taken to make our nation number one again -- a land of hope, freedom and opportunity for all Americans. For to paraphrase an old English verse:

There will always be an America,
And America will always be free,
If America means as much to you
As America means to me.

Privacy, free speech clash in handbill ordinance

CARMELITES' well-known love of privacy has collided once again with the First Amendment, and the Constitution has won the first round.

The Carmel City Council introduced on first reading April 20 an amendment to the city ordinance which regulates distribution of handbills on private property.

The handbill ordinance passed by the council in 1979 is "overly broad" and presents constitutional problems related to freedom of speech guarantees under the First Amendment, City Atty. George Brehmer informed the council.

That ordinance flatly prohibits distribution of handbills — a term which also includes circulars, leaflets, pamphlets, and newspapers — on private property where the occupant doesn't want the literature.

Brehmer suggested that the ordinance be amended to prohibit the distribution of literature on private property only when the resident or occupant has placed a "No Handbills" sign on the premises.

"The proposed (amendment) brings present (restrictions) into compliance with existing case law by allowing distribution of handbills in cases where the owner, occupant or tenant does not voice an objection," Brehmer advised in a memo to the council.

"This is consistent with the constitutional right of free speech."

The current ordinance makes it illegal "for any person, either directly or indirectly, to distribute, deposit, place, throw, scatter or cast any handbill in or upon any private yard, grounds, walk, porch, steps, mailbox, vestibule, house, residence, building or any other private property after the person has been informed by the owner, occupant, tenant, or other person having control of the private property that the handbill is not wanted."

The amendment would specify that a distributor of handbills had been notified that the literature is unwanted "if a sign is posted near the front or main entrance door or in any other place where such person would reasonably be expected to notice it, stating 'no handbills' or some other similar

statement."

The amendment would also make it illegal to continue to deliver handbills where they are unwanted and accumulate, and would place an "affirmative obligation" on the distributor to remove accumulated handbills.

IF HANDBILLS are allowed to accumulate for more than two days, continued distribution would be an infraction of the law.

Planning Director Robert Griggs said the planning commission will attempt to define "what size restriction to specify as an allowed sign" under the handbill ordinance amendment.

"We will have to have something," Griggs said. "Probably something in the area of one square foot."

Oak moth larva feeding

Homeowners and tree lovers, the oak moth larva is feeding now and will continue to feed on your oak trees for the next several weeks. If you don't mind the mess or the worms, then forget about spraying the little varmints. However, if you hate the fallout of if your trees have been denuded in the past, then consider spraying now to control these voracious insects. If your tree has been stripped of its leaves in the past, fertilize them to improve their vigor.

In the next several months, especially if the weather continues to be warm, keep a close watch on your pine trees. Bark beetles will begin showing up in ever increasing numbers from May through October. Over the next several weeks I'll provide readers with descriptions of these insect pests, how to recognize them and how to correct the problems these insects cause. We regret our inability to comply with your request.

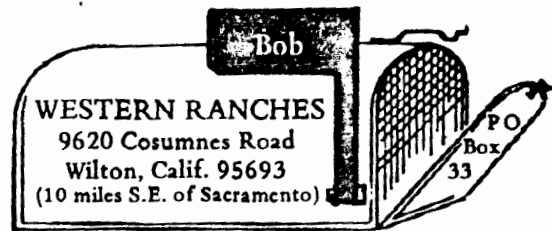
