I feel that you would be interested in the following story, its a great example of slanting the news.


On Tuesday, during the 2:30 newsbreak on WCAU-Radio, the following story was reported. President Reagan met with Republican members of Congress on the budget before taking off on "another" five day vacation.

My feeling was that the word "another" was grossly unfair, so I called the station and spoke with Gesa Sklaroff, the announcer. After identifying myself by name, as a Republican, I told her my feelings and she was very understanding of my position.

She informed me that just before the 2:30 break, she clipped the item from the A P ticker and went on the air with it. She told me that immediately upon reading it she realized that it was probably unjust and she would delete the word "another" in future newscasts.

In my opinion, this is just another example of how a re-write man on an A P newsdesk in New York or Washington can and does inject his feelings at will about the President.


In recent years, sentiment has increased in the Congress to enact legislation that would restore protection of the law to children before birth. It may be possible for the 97th Congress to take that important step. I write simply to express my own hope that we will not miss this long delayed opportunity.

A few weeks back I said that, "We must, with calmness and resolve, help the vast majority of our fellow Americans understand that the more than one-and-one-half million abortions performed in America in 1980 amount to a great moral evil and assault on the sacredness of life." Whether or not our fellow citizens will understand the duty we owe to future citizens depends largely on what action the Congress takes.

I know that on this issue, sad to say, as on many others of great importance, there are sharp differences of opinions as to which action is the best one. Naturally, I hope that these differences will be resolved in favor of the common goal.

But most important, it seems to me, is that the Congress consider one or more of the proposals in the near future. And I want you to know that you have not only my best wishes but also my prayers for success.


DEAR MR. DEAVER:



Enclosed are letters to President Reagan from my eighth grade Special Education class. I'm sending them to you because I told the class that I would try to help them get answers before school let out June 15.


This is a class of eight (8). None of them are particularly retarded but educationally disadvantaged. I was hoping that since it was such a small class that I would implore you to find a way they could meet the President while he's in town next week. There is no way any of them could buy tickets at \$1000. For that matter I'm not able to either. I thought Daves' activity on campaign staff and my activities might help. It sure didn't get us a job. Many of these boys parents incomes are barely above poverty level.

Since I began working with this class they've come a long way. On May 26 they take a test on the Constitution which is required of all eighth graders. I've tried to involve their personal lives in government so it didn't seem so remote. These letters and the answers are a big part of this. There is no way they can compete with other eighth graders but they are really trying hard. One of them, Steven Greive, has developed a real interest in Presidents, particularly Washington. Most of these kids problems stem from lack of exposure.

I decided to get involved in Special Education because I had extra time on my hands. To flog a dead horse, after I talked to you in Santa Barbara I made contact with Wendy Borchardt just once and it seemed to die there. I still want to work for the President. I would think now you might need some real Reagan loyalists.

In spite of my own disappointment these kids worked hard on these letters. Some of them had never written a letter to anyone before. They put a lot of thought in trying to find something to say. I hope you can be of assistance Mike, in at least getting them letters back. I can be reached at school (number on letterhead) or at home 213-359-6475.
