I attended the President's reception on June 24th and hoped I would see you, but no such luck. I was asked because of all the volunteer community work I have done and that pleased me greatly. Thought the reception was excellent - good food and friendly and warm atmosphere. Cesarina Loustalot of Santa Ynez went along with me. We went to New York first - took in a grand show - and altogether had a marvelous time.

I have been asked to do a favor for a friend of mine who is aquainted with the famous artists, Eva and Americo Makk (see the information enclosed). They would like to do portraits of Nancy and President Reagan. Americo painted a portrait of former President Carter which he says is hanging in the White House. On February 26th, the Treasury Department released to the Congress the general and technical explanations of the tax revision proposals announced by President Reagan in his State of the Union Address. I am enclosing a portion of the proposal regarding the recommendation to repeal business energy tax subsidies after December 13, 1982. However, please note that the proposals contain transition rules intended to protect taxpayers who have relied upon existing law incentives from loss on their investments.

When we went into this, we thought we would have those benefits through 1985, but now it looks like they will be no more after the end of the year.

I have seen tremendous progress toward the emergence of this new industry just since about July 1981. The best and most active of these companies, Zond Systems Inc., has in the space of less than one year created a wind farm capable of generating over 225 megawatts of electricity per year. The plan for the remainder of 1982 and 1983 will create a wind farm capable of producing over 41,000 per year. This extraordinary rate of expansion is entirely due to the existing energy tax credits and a hell of a lot of work.

If we could keep the energy tax credits for even two years, I think this new industry would make it on its own. It is a risk filled industry now, and we do need the support now.

If you can think of some way to help us, I believe it will help create a new industry in the alternative energy field and prove to be a good thing for the country.

The wind that blew us around for years just might be put to work to solve some of the country's energy problems. And with the growth of the alternative power industries, the Mojave, with its wind and sun, could be a great source of power for the years to come.
