THE LIFE YOU SAVE ... by Paul Aurandt

The phrase was what had first attracted Mike's attention.

"Cafe coronary."

So called because it ordinarily occurs at a table where food is served and it gives the appearance of a heart attack.

It has nothing to do with a heart attack; it is entirely something else. It is a "cafe coronary."

A person is eating -- either too quickly or too much in one bite -and the food sticks in his throat, clogs his air passageway so that he cannot breathe. Unaided, he will be dead in minutes.

And the term "cafe coronary" was sufficiently intriguing to get Mike to listen to THE REST OF THE STORY.

A doctor named Henry J. Heimlich had developed an emergency treatment for the condition:

First, the rescuer positions himself behind the victim, putting his arms around the victim's stomach. One fist is placed with the thumb inward between the navel and the bottom of the rib cage. The other hand grasps the fist. Four quick inward thrusts will usually dislodge the food caught in the victim's windpipe. -2- ROS The Life You Save ...

Mike was fascinated by this revolutionary treatment which was being referred to as the "Heimlich Maneuver." Mike memorized the procedure. Chances were he would never need to use it, yet he figured it was better to know without needing than to need without knowing.

Every once in a while Mike would review the steps: Get behind the victim. Put your fist in his stomach between the sternum and the navel. Grasp the fist with the other hand. Give four quick thrusts inward and upward.

So the Heimlich Maneuver was in the back of Mike's mind -- when he got on that airplane with his friend back in 1976.

They were somewhere in mid-flight when Mike's friend, who had been eating -- suddenly clutched his throat.

Clutching one's throat with both hands is a universal sign for choking: it is the victim's way of telling bystanders what is wrong -- especially that he is not having a heart attack.

Again, this friend of Mike's was clutching his throat, was turning blue, was not making a sound. Mike remembered that if you can hear the victim gagging, wheezing or coughing, you should leave him alone. But his friend was silent. Mike knew he must act quickly or his friend, starved for oxygen, would soon be dead.

And Mike acted quickly.

Recalled and applied the technique ... the "Heimlich" technique. And his friend did not die. .

-3- ROS The Life You Save ...

Most of us neglect the learning of emergency life-saving techniques -such as the Heimlich Maneuver, CPR and so on.

Most of us are subconsciously convinced it could never happen to us ... You and I may re-think that conviction because of what happened to Mike six years ago.

He saved one life -- and altered the history of the world.

Today Mike is Michael Deaver, with an office directly adjoining our White House oval office -- Deputy Chief of Staff to the President of the United States.

The friend he rescued with the Heimlich Maneuver in an airplane in 1976 -- was Ronald Reagan.

P.S. The offending food -- that stuck in his throat -- was a confection repopularized at that time by the man who was then President of the United States.

President Reagan almost choked to death on a peanut! Now you know THE REST OF THE STORY.

Rod Rude of ARCO placed a call to you on August 10, 1982, on my behalf, requesting a meeting. He notified me that you would be out of town, and that you of an aide asked that I put my request in a letter. I will attempt to be brief and to the point.

This letter is to confirm the understanding reached at our meeting October 15, 1982 with regard to the above-referenced project.

This review resulted in suggestions for changes that would further reduce project costs. Further suggestions were made to avoid such changes that would cause further delay for major redesign or resubmission to the City of Long Beach for a revised use permit.

I felt a sincere commitment by all parties at that meeting to make this project feasible and to seeing that it went forward. In a conference call later that day with members of the development team in California, I conveyed all the concerns raised at the meeting and asked all parties to work over the holiday weekend to reduce costs as much as possible consistent with the above. Of special concern were a rexamination of the HVAC system, parking and roof structure. I asked for a specific report on Tuesday October 12, 1982. That report was issued in writing by the Mr. R. contractor and specifically addressed each area of concern. A copy was also made available to your office. In another conference call in which I asked for the professional judgments of each member of the development team, it became evident that further cuts such as reduction to one elevator, or removal of disposals would reduce the quality of the building below acceptable levels. It should be noted that you specifically questioned whether cuts such as those would be in the best interest of the project and we agreed with your judgment.

After reviewing this entire process it is evident that the design constraints which have resulted in a high cost for the project were imposed early in processing by Fund Reservation requirements and by requirements of the City of Long Beach. As presently revised, I believe the sponsors have done everything prudent to reduce costs within those limitations. The amount we are now requesting is \$6,419,810.

At our October 15, 1982 meeting we reviewed the proposed changes and Linda Cheatham of your staff indicated that after reviewing the proposed changes with the Los Angeles Area Office that all reasonable and prudent changes had been made and that, by and large, the costs associated with the changes appeared reasonable.

Further we discussed other line-items in the pro forma 2013 prepared by the project consultant and submitted in the October 12, 1982, package which totalled \$6,507,000. We agreed that land value would be limited to the \$536,000 provided in the July 19, 1982 Firm Commitment despite the additional interest charges incurred since by the sponsor. Finally we agreed to reduce the project contingency from 3% to 2% thereby reducing the mortgage by another approximately \$65,000.

All of the changes recited above have resulted in a mortgage request that will represent a reduction in excess of \$400,000 from the Firm Commitment issued July 19, 1982. The preparation of a request for the exact mortgage will be prepared by the project consultant based on the assumptions made above.

Although this process has been difficult for all parties, I believe there was a good faith attempt on the part of all parties to resolve a difficult issue and we sincerely appreciate your time, your consideration, and of course your approval.

Dear Charles:

Thank you for your letter of October 8 about the proposal for an exhibition by the United States in Beijing for the spring and summer of 1984.

I have asked the National Security Council to look into this and find that they have in fact been in touch with the backers of the project and with the various government agencies which have been approached. The main concern has been that the estimated cost of the exhibition exceeds what has been spent by either the U.S. Information Agency or the Department of Commerce for an exhibition anywhere, and the prospects for obtaining such sizable government funds in this budget environment are not good.

However, there are arguments that can be made for an exhibition along the lines proposed, and I suggest it would be useful to have the backers provide a briefing in the near future to an interagency group which would include all the U.S. agencies with a potential interest. This would enable the backers to take account of their latest design plans and discussions with the Chinese and to deal with all of the U.S. organizations involved at one sitting, which I understand has not been possible to date.

I am asking Charles Wick to arrange such a meeting and preside over the gathering. We will be better equippped to make a judgment on the merits of the project and the prospects for either government or private financing after the briefing.

Dear Mike:

As you probably know there is a proposal pending for an exhibition by the United States in Peking, China for the spring and summer of 1984. This would be handled in a manner similar to the exhibition which our country presented in Moscow in 1958 which received a visit from then Vice President Nixon with much publicity.

It seems to me that this proposal is currently on dead center. Charlie Wick of the U. S. Information Agency is understandably concerned about underwriting this project which would probably cost about \$20 million. The Department of Commerce has an obvious interest and it also would impact on the strategic concerns of both the CIA and Defense. I spoke with Bill Casey this morning about the project and he thought it would be worth bringing my concerns to your attention. It seems to me that it is important that President Reagan have the option of making a visit to China to open this exhibit in the spring of 1984. I don't have to spell out to you the ramifications of such a visit at that particular time. I would hope that you would give the importance of this option some thought and take whatever action is necessary to have funding for this exhibition contained in the 1984 Budget.

In my view this expenditure can be justified for a host of reasons including national security interests. It has many more obvious direct and indirect benefits than a great many items in our current defense and strategic areas of expenditures. The danger is that the project might fail since no one is willing to assume responsibility for funding. Leadership is needed to bring together those whose views would be relevant such as Bill Casey, Mac Baldridge Charlie Wick and David Stockman. I am also convinced that there is // no real possibility of substantial private funding for the project. If the exhibition is to happen at all our government must be prepared to underwrite its costs for the simple reason that the benefits outweigh the expenditure of funds. Good luck with your labors and let's keep our fingers crossed for a happy evening on November 2. With warm personal regards,

SUBJECT: Proposal for an Exhibition by the U.S. in Beijing

I have received a letter from Charles McWhorter in New York about a proposal pending for an exhibition to be held by the U.S. in Beijing, China, in the spring and summer of 1984. Charles notes that you are understandably concerned about underwriting this project, which he estimates would cost about \$20 million. He makes a strong pitch that the President have the option of making a visit to China to open this exhibit, and expresses the view that the expenditure can be justified for a host of reasons. He is also convinced that there is no real possibility of substantial private funding for the project and that the government would have to be prepared to underwrite its whole cost.

I have asked the National Security Council to look into the matter, and they have given me a rundown on the history of the proposal and the separate approaches made to USIA, Commerce, State and other interested parties, along with some assessment of the pros and cons.

I think it would be helpful now if you could orchestrate and preside over an interagency gathering which would allow the backers of this project to present an up-to-date briefing to all of the interested U.S. agencies at one sitting. In addition to your own people, this should include appropriate representatives from Commerce, State, OMB, the NSC, and possibly DOD and CIA. This will give the backers of this project a fair hearing and enable us to make a better judgment about the merits of this project and the prospects for either government or private financing.

I am attaching copies of the letter from McWhorter and my reply, and asking the NSC staffers involved to be in touch with your people for any detailed coordination or support that may be needed.

Various trucking industry trade journals and magazines state that "there will be a strong attempt by 'the Administration of the ninety-eighth Congress--with the Department of Transportation spearheading the drive---to write a sunset provision for the Interstate Commerce Commission'".

As a member of the household goods portion of the trucking industry, I feel that a movement of this sort would be evidence of bad faith on the part of the Administration and the Congress.

When the Motor Carrier Act of 1980 and the Household Goods Carriers Act of 1980 were enacted, they contained provisions that there would be annual oversight hearings by committees of Congress for a period of five years to see if these Acts were meeting their goals and whether any amendments, changes, or omissions should be made. Right away my question is how can oversight hearings be effective when the very body entrusted with the regulation of this industry, namely the Interstate Commerce Commission, is to be abolished prior to the end of the five year period?

Currently, the household goods industry is either meeting or has just met with this oversight committee, and I think that you will find that our industry can see many faults with the Household Goods Carriers Act which, indeed, need correction. Basically, I think that under the regulation of the Interstate Commerce Commission, our country has always been provided with the least expensive and most efficient transportation system the world has ever seen. I sincerely feel that many of the measures allowed by the Act of 1980 are wrought with discrimination between shippers, absolutely uneconomic practices, and in several cases measures that actually work to the economic detriment of the shippers and general public.
