Dear Mr. Deaver:

As a life-long Republican I feel I should convey to you, not only my own thinking, but the thinking of vast numbers of people in my community.

I ^{was} one of the organizers of the Young Republicans in Wisconsin nearly 50 years ago, and a conservative Republican while President Reagan was still a Democrat. Second, may I remind the President that wise men change their minds, fools never do.
