Dear Peter:

I am writing this letter to clear up any questions which may still exist with regard to the Federal funding of the 1984 Summer Olympic Games to be held in Los Angeles.

It is true that a number of Federal departments and agencies, including the Department of Defense, have budgeted funds for the '84 Games. These budgeted funds are, however, in all cases, an attempt to anticipate non-specific needs based upon prior Olympic experience. They are not funds which have been approved for any specific use for any department or agency. In all cases we will review any requests which your Committee may have for Federal funds on a case by case basis. Funds may only then be approved if an appropriate Federal role has been identified.

I would also like to clarify for you and your Committee members that Mike McManus and I should be the one contact point for all of your requests to the Federal Government.

We would also like to discuss with you at our February meeting your feeling about the appropriateness of a requirement of reimbursement from your Committee of any expended Federal funds for extra ordinary/nonusual Federal activities. Naturally, reimbursement would only be required out of profits realized after all Olympic expenses had been met.

I look forward to our February meeting and thank you for your help in these matters.



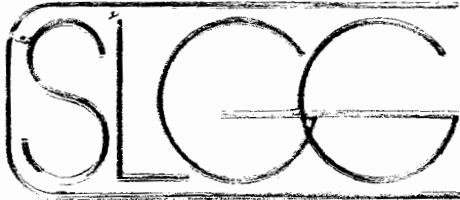

Dear Mike:

When we last saw each other, you indicated that I call Bill Sitman to avoid Shirley's stone wall. Well I tried Bill, and got Shirley. She suggested since she couldn't schedule an appointment, it would be best for me to write a letter. I'll be brief.

The Democrats are taking the initiative in finding ways to assist the small business community, i.e., a newly formed Democratic National Committee's Small Business Council. Dear Michael:

While we have been preparing for conventional military conflict with the Soviet Union, the Japanese have invaded our country, conquered our industries, and are in the process of colonizing American commerce.

I note from some of the work I have been doing in the computer industry, the enormous challenge America faces today in creating a viable strategy to compete with the Japanese, who have invested enormous amounts of money and manpower, to say nothing of the fact that they have purchased the best American technology, in gaining a technological lead over this country.

In talking with people around the country, I find an enormous desire to develop a competitive American strategy. I would suggest that you might very well have Dick Wirthlin do some polling for you, and it would be my intuitive judgment that you will find that the desire for such an effort domestically could in fact mean as much to Ronald Reagan in 1984 as the Panama Canal did in 1976.

I have assembled a World Class team, including the Nobel Laureate in Physics, Kenneth Wilson; General Robert E. Chapman, who was the Director of Computer Resources at the Air Force; the interest of Merrill Lynch; the founder of Planning Research Corporation, and on and on, who are ready, willing and eager to take on the task of constructing an American response in a very viable and meaningful way.

I think this is an issue that you will need to consider very carefully. It can be one of the single focal points of this Administration and can really mean a great deal to the record that this Administration carves as it addresses the responsibilities of society.
