



Dear Mr. Deaver,

I had the privilege of attending the President's and Mrs. Reagan's state dinner for Her Majesty, Queen Elizabeth and Prince Philip in San Francisco last week. You and your staff deserve special plaudits for a very elegant evening. The food was outstanding and the wines, which I understand were your personal choices, were superb; these fine examples of America's "premier grande cru" wines topped off a delectable meal service.

There is, however, one complaint that I want to register and that concerns the guest list. The San Francisco Bay area boasts one of the largest (if not the largest) collection of Nobel Laureates in Science, and one of the most important concentrations of biological and physical scientists in the world. Indeed, it is the showplace to which foreign visitors come first to learn about the new advances in biotechnology and the marvels of electronics and computers. And yet, I was the only scientist in the entire party! In my view the presence of one scientist was a gross under-representation of one of the major intellectual forces in our nation.

The President has been outspoken about the necessity to upgrade the teaching of mathematics and science in our Nation's schools and universities. The President has rightly perceived our dependence upon the advances in science and technology and has committed the Nation to achieving leadership in these fields. However, the impact of the President's message, with which I concur, is blurred or diminished if, during such grand occasions, the spotlight is focused on business, sports, entertainment and media figures and ignores the scientific leadership on which we depend to achieve the President's goals.
