### REDUCING UNEMPLOYMENT CAN BE ACHIEVED BY CREATING INCENTIVES FOR SMALL BUSINESSES TO DEVELOP ACCORDING TO TOP CEO

SEATTLE, May 27, 1983--"In order to reduce unemployment in this country we have to create incentives for people who want to take the risk of starting a new business," according to J. Peter Grace, chairman and chief executive officer of W. R. Grace & Co., in a speech here today to the Independent Petroleum Association of America. "It's tough enough staying in business, let alone trying to start one from scratch," he added. Mr. Grace has been chief executive officer of W. R. Grace & Co. since 1945.

In his wide ranging economic speech, Mr. Grace proposed eliminating the capital gains tax which would create the incentive for someone willing to start a business. "Why would anyone take the initial risk of starting a business only to see Uncle Sam tax him at a rate of 20 percent if he manages to make money?" he asked rhetorically.

He noted that during the time period that the capital gains tax was increased from 25 percent to almost 50 percent, stock values went down. "After the reduction of the capital gains tax in 1979, just the reverse happened," he said, noting that tax rates went down and stock values increased.

He also pointed out that equity capital offerings, of companies with less than \$5 million of net worth, i.e., mainly newly formed businesses, reached a high in 1969 of 698 when the tax was 25 percent, and dropped to a low of 4 in 1975 when the tax reached 45 percent.

"The reduction in the maximum tax rate on capital gains to 20 percent in 1981 helped push small business equity offerings to a record \$1.8 billion, more than twice the 1980 amount," he said. "Just think what elimination of the capital gains tax could do for businesses trying to start up.

"The main beneficiaries of the reduction of this tax are clearly small businesses," he said. Mr. Grace illustrated that 66 percent of all new jobs are created by firms with 20 or fewer employees.

"Small business creates more than just jobs," Mr. Grace said. "Firms with less than 1,000 employees generate 24 times as many technological innovations per research dollar as do businesses with more than 10,000 employees."

Mr. Grace, who championed the cause of reducing the maximum capital gains rate from its 49 percent high, feels that complete elimination of the tax would further help create more offerings, and thus more jobs.

In addition to calling for elimination of the capital gains tax, Mr. Grace concluded his remarks by outlining his action recommendations:

1. Reduce federal government expenditures progressively from current 25.2 percent of GNP to below 20 percent.
2. Adjust all personal and corporate income for inflation before taxing.
3. Cut top personal tax rate to 36 percent.
4. Encourage productive work by shifting the tax burden from income to consumption.
5. Eliminate government interference in the energy industry including price controls and windfall profit taxes.

Mr. Grace also said that we should "get off President Reagan's back, while he tries to get the government off our back." He added that "We should help the new program to succeed or we'll be enslaved economically forever."
