

PROCEDURES FOR SPECIAL WHITE HOUSE TOURS

Special tours are defined as not public or general tours but arranged for specific constituents or groups.

The following procedures shall be observed:

 Upon receipt of such a special tour request, the Deputy Director of the Visitors' Office checks the Directors of the following offices by telephone to confirm availability of the House:

> Ushers Office Social Office Presidential Scheduling

- 2. If each of these offices confirms availability, an acceptance letter is sent to the group, a copy of such letter with date, time, etc., highlighted shall be sent to Ushers, Social and Presidential Scheduling offices.
- 3. Every Monday the Tour Office will send a written summary showing what (if any) afternoon tours are scheduled for that week. This written report (see attached) will go to Mike Deaver and to the Ushers', Social and Scheduling Offices.
- 4. The Director of the Tour Office will attend weekly meetings of the Advance Scheduling and Social Offices held by the Chief of Staff, East Wing. These meetings follow the Long-Range Scheduling meetings and establish location and responsibility for executing all Residence and Rose Garden events.
- 5. The Director of the Tour Office will personally receive and note all set-up memos from the Scheduling and Social Offices and immediately notify both offices of any last minute conflict. In addition, Bill Sittmann will be notified of any last minute conflict.

- 6. If any previously unscheduled events are placed on the President's schedule and require the use of the Residence, the Scheduling Office will confirm with the Tour Office that there is no conflict with tour commitments.
- 7. In the case of some error or controversy, the tour guides will immediately inform Bill Sittmann, the Director of the Visitors'Office and the Chief of Staff, East Wing prior to cancellation of any tour. They will seek resolution to any problem of tour cancellation. This decision will not rest with the Ushers' Office or with the tour guides.

Dear Mr. President:

It is my understanding from a number of sources that you are presently scheduled to visit Guam sometime in early November as part of your trip to the Far East. This is indeed good news. President Nixon was the last President to visit Guam. In the years since, the wish has often been expressed by island leaders that our nation's highest elected leader visit Guam--America's westernmost region--and see first hand the benefits democracy has brought to the territory of Guam.

Over the Fourth of July Congressional recess, I was privileged to lead a Congressional delegation to Guam, Japan, the Philippines, and Saipan to review military facilities and other matters in these areas. We found our reception most warm, particularly in Guam which is one of the most patriotic locations under the American flag.

I can assure you that you will be most welcome in Guam. Further, I believe that you and your staff would greatly benefit from a visit with the local residents, even if it was only for a few hours. While we all recognize the pressures attendent with your tasks at hand, Guam is American and the large military population there and the civilian population have all expressed their hope that you will find the time to meet with them and see the territory which is America's front line of defense in the Pacific.

In this connection, some concern was expressed on Guam earlier this week when your Deputy Chief of Staff, Mr. Michael Deaver and others in his group left Guam without meeting with local officials or the press. Their isolation during that time has led to speculation that your own trip would be brief and marked by limited contact with islanders. I sincerely hope this will not be the case. Guam is American soil and my constituents await your coming with far more enthusiam than you will ever find in Japan or the Philippines.

Because of our physical isolation, we often do feel that our needs do not receive the full attention of the U.S. Government. This is why I strive so hard to bring Congressional delegations to Guam. Your presence there would certainly boost morale for the local military population and assure Americans in Guam that the White House appreciates their role in the defense of this nation and recognizes the significance of the territory to our country. Over the past few months, there has been a growing concern on Guam about our relations with the United States. While there is never a question in the Public's mind about continued strong ties with the U.S., we are concerned that neglect from Washington has eroded our ability to be self-governing and prosperous in the territory. Further, while we see almost daily signs that the U.S. is negotiating new alliances with our sister islands in the Trust Territory, providing them with huge sums and other benefits, we see no signs that this country is interested to any large degree in working to improve Guam's economic condition or political status. I believe that your visit to the territory would be a welcome sign that this nation does have the best interests of Americans in Guam at heart and indicate that there is indeed a future for Guam within the American political sphere.

I would certainly welcome the opportunity to assist your office on the upcoming Pacific trip. And, if your schedule permits, I would welcome the opportunity to personally extend to you on behalf of the people of Guam a warm welcome to the territory.
