Dear Jay:

Thank you for your letter enclosing a copy of your letter to the President requesting an environment message.

While I understand and appreciate your interest in having the President issue an Environmental Statement, many of us here have concluded that a single statement may not be sufficient or achieve its desired result. The President charged EPA Administrator Bill Ruckelshaus with several priority items, including a thorough review of options for dealing with the acid rain dilemma, when he was sworn in last spring. And now, the Administration is deeply engaged in several issues relating to the environment which will in the long run prove more important and have more lasting impact than a Presidential statement.

I appreciate your thoughtfulness in providing a copy of your letter to the President. As we continue to address environmental questions in the months ahead, I will keep your views in mind.

Dear Mr. ^{Mike} Deaver:

Attached is a copy of a letter I sent today to the President concerning your apparent decision not to proceed with a Presidential Environmental Message. I was first informed of this decision by members of the White House staff when I attended a reception honoring conservationists from Costa Rica in the Rose Garden last week. I have since confirmed this decision through EPA staff.

~~For the reasons stated in my letter, I think the decision to cancel the Environmental Message is a mistake.~~ It leaves the perception that the President's interest in environmental issues is entirely a function of their political salience, to be ignored once the heat is off.

As you know from your own polls, support for strong environmental programs runs deep within the modern American society. The public will not accept an economic program that lacks visible and effective environmental policies.

A strong non-partisan Presidential statement of this Administration's environmental programs and policies, is still needed. We would appreciate any assistance you could lend in this matter. Thank you.

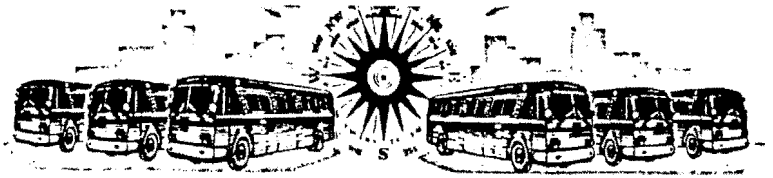




Dear Mr. Deaver:





Dear Mr. President:

This is a "birthday note" marking the first anniversary of your signing into law the Small Business Innovation Development Act (P. L. 97-219).

At the White House ceremony on July 22, 1982, you pointed out that the Small Business Innovation Research program would require a partnership of the Executive branch of the Federal government and small business in the private sector.

The first full year of the developing "partnership" will not be over until the close of the fiscal year on September 30. Only 100 of the estimated 750 grants for innovative research anticipated to be made have yet been made. But this legislative anniversary date should not pass without your receiving at least this summary view from the private sector as to how each of the two "partners" handled the first SBIR year.

We can all, I think, take pride in the magnificent response of the Nation's small high technology companies to the SBIR program. More than 8,700 proposals have been submitted to the eleven Federal agencies conducting research grant solicitations. (Although it may not be a wholly relevant comparison, 1,000 proposals were made by academic people in response to a recent research grant solicitation made by one of the major oil companies.)

The outpouring of proposals in response to the SBIR program confirms the serious -- even dangerous -- under-utilization of small high technology firms as a part of our national science base. Informal discussions with agency personnel confirm that the quality of the proposals is generally high. The estimated 750 grants to be made

this year (one of every 14 of the 8,700 proposals) will call for no compromise with excellence.

The entrepreneurial owners and managers of these firms, moreover, are ready to go the extra mile of voluntary self-help to strengthen the whole private sector. More than 900 small technology business, professional and other opinion leaders have already volunteered for the "National Innovation Network" which this Institute is organizing. We will designate 100 of them this week as State Co-Chairmen and as the founding members of the Institute's "Technology Venture Presidents' Council".

On the government side, your Administration and the SBIR's supporters in Congress can take pride in the generally diligent Federal agency efforts to get the program under way speedily and well. All of us hope, of course, that the program's management and small business' response will improve in each succeeding year. The sunset provision in the law means that the program has, effectively, just four more years to prove itself finally.

Our Institute will try to assemble a useful consensus from participants and responsible observers about lessons from the first year. We will, of course, make the results available to the agencies for such use as they may have for them.

We have also, we believe, laid the basis for a still broader private sector direct and indirect involvement in the SBIR program. Many well-qualified small technology firms have yet to hear about it. Others do not yet know that it is a substantial step forward from past Federal small business procurement practices which have discouraged them. We are particularly anxious to find ways to improve the working relationships between participating small high technology firms on the one hand and the rest of the private sector on the other: large companies, universities and the financial community. Very promising support activities are under discussion in a number of states, and in some local governments.

Whether one looks at the future of the SBIR program from the standpoint of the Federal government or the private sector, it is clear that continued and recurringly visible Presidential support for it is indispensable. Congressional supporters of the legislation, particularly Senator Warren Rudman and Representatives Bedell, Gore, McDade and others have provided the Nation with an excellent example of responsible, vigilant oversight. Without your support when needed, their efforts would have been far less

effective.

We should like respectfully to suggest two ways in which this continued Presidential support may be expressed. On October 10, our Institute will be holding a major function at the Franklin Institute in Philadelphia. We are planning to make it a major event for both the scientific and business communities. The site has been carefully chosen to underscore the historic American linkage of "Basic Science, Industrial Technology and Entrepreneurship." The program will be notable one, featuring each of those private sector elements which must work together to maximize the benefits of the SBIR program. Several hundred technology entrepreneurs -- including SBIR winners and members of our Technology Venture Presidents' Council will be present. Of course we would be honored to have the President address the closing dinner, but we appreciate the demands of your schedule. As an alternative, we would be delighted to have a five to fifteen minute videotape message which we will show as a highlight of our program. On the succeeding Saturday (October 15) you could use it in your national radio broadcast.

Once again, we believe your support of the SBIR program has served our country well and we are grateful for it. You may rely on our continued commitment to its success and our readiness to help in any way we can.

To save time, I'm taking the liberty of sending copies directly to John Rousselot, Jim Sanders and Craig Fuller.



You have asked for our views on the request from James Roosevelt that the President meet with him and several other individuals associated with the effort to restore FDR's Presidential Yacht, Potomac. The effort is a joint project of the Port of Oakland and the Association for the Restoration of the Presidential Yacht Potomac. The latter organization, which has filed for 501(c)(3) status with the IRS, is actively involved in raising funds for the project.

Assuming that the Association is granted 501(c)(3) status, we would have no objection to several of its members, and others involved in the restoration project, meeting with the President to advise him of their efforts. We would, however, object to any effort to use the meeting to involve the President in fundraising. We have already denied a request filed on behalf of the Association to use the Presidential Seal in fundraising for the restoration effort.

Should a meeting be held, Mr. Roosevelt and his colleagues should be made fully aware in advance that the fact of the meeting, or any statements or photographs flowing from it, may not be used to aid their fundraising. Such a limitation may remove their main purpose in seeking the meeting.



Summary

I want to report to you on our successful efforts to support Ambassador Kirkpatrick's Security Council speech on the Soviet air massacre. USIA produced a 10-minute VCR on flight KAL 007, using recorded comments of the Soviet pilots who stalked and shot down the plane. The VCR decisively refuted Soviet claims that they had warned the plane, had fired only tracer shots, and that the plane had been flying without navigational lights. At about the same time that Ambassador Kirkpatrick played the tape for a fascinated audience of delegates and reporters, the Soviet Government reluctantly admitted shooting down the Korean plane.

A copy of the tape is attached.

Background

USIA, working in conjunction with other agencies, prepared a videotape showing the flight path of the ill-fated Korean plane, and the comments of the Russian pilots who tracked and finally shot it down. English translations, identification of speakers, and printed Russian texts appear on the screen over the pilots' voices.

Ambassador Kirkpatrick played the tape for the U.N. Security Council as part of her presentation, and later at a press conference at USUN. Veteran observers believed that this use of videotape as part of a Security Council debate is unprecedented. At about the same time, the Soviet Government finally admitted shooting down the plane, confounding their own U.N. ambassador who chose not to reply directly to the evidence of the tape.

A fascinated group of delegates and journalists watched the tape on five specially provided TV monitors - one of which was set up behind the Soviet Ambassador as a focal point for photographs. The VTR was the principal topic at the press conference Ambassador Kirkpatrick held at our U.N. Mission following her speech. Judging by many of the questions and comments made informally, the journalists present seemed to consider the tape as "the smoking gun", which definitively refuted the Soviet's various and conflicting accounts of the disaster.

Soviet Ambassador Troyanovsky did not even try to reply to the tape. At about the same time that Ambassador Kirkpatrick spoke to a hushed U.N. audience, the Soviet Government finally announced that they had, indeed, shot down KAL 007.

Comment

This innovative use of television demonstrates the impact a carefully produced and well coordinated program can make. The alternative - releasing the printed text and audio tapes of the pilots' transcript - would not have achieved the same dramatic effect and newsworthiness. The tape is being played by TV stations around the world, forcefully driving home the reality of the Soviet's brutal act - and the inadequacy of their explanations.
