Deaver gets a birthday to remember

It started with President Reagan's dedication of the Michael K. Deaver statue in Lafayette Park across from the White House. That was followed by the ticker tape parade in New York City for "Deaver Day."

Then, there was the presidential visit to Bakersfield, Calif., to see the Deaver boyhood home. President Reagan watched a TV special, *The Life and Times of Michael Deaver*, and accepted a Pulitzer Prize on Deaver's behalf for his book, *Twelve Great Men Who Have Known Me*.

If none of those events sound familiar, there's a good reason. They never happened. They're all part of a long-running White House scam to celebrate Deaver's birthday on Wednesday.

As deputy White House chief of staff, Deaver's job is to oversee Reagan's schedule. During planning sessions every Wednesday this month, a "Deaver event," like the parade, appeared on the schedule for April 11 — Deaver's birthday.

The joke peaked Wednesday when about 60 White House officials arrived to take Deaver to work in a decorated yellow school bus — in place of his usual limousine.

The quiet of Deaver's Washington neighborhood was shattered before 7 a.m. when presidential assistant John Rogers emerged from the bus shouting through a police bullhorn, "Mr. Deaver, your house is surrounded. Come out immediately."

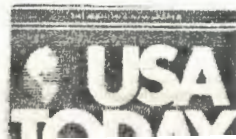

Dear Mr. Deaver:

As co-sponsors of PROJECT PERFECT FIT we are pleased to report that, at the halfway point of this year's campaign, the response to our efforts has been extremely positive. Through a combination of public events and television coverage we believe we have begun raising the public's consciousness of the benefits of physical fitness.

The capstone event of PROJECT PERFECT FIT will occur on May 5 on the Ellipse, when we will administer a new fitness test to 1,000 Washington area residents. The test has been designed by the National Fitness Foundation so adult Americans will have a means of comparing their personal fitness against others in their age groups.

PROJECT PERFECT FIT needs to enlist your support in making the May 5 event a success. Between the hours of 9:00AM and Noon, 500 invited participants, all of them representing groups or individuals who have lent support to PROJECT PERFECT FIT, will be tested. A \$2.00 per person fee will be paid by PROJECT PERFECT FIT, and through the good offices of AT&T, data processing will be performed on the scene so each individual will be able to see his or her results and receive the new National Fitness Card the same day. In the afternoon, 500 members of the general public will be tested on a first-come, first-served basis.

We have allocated twenty (20) testing slots and five (5) alternate slots in your name. We need to know by April 27th whether you will be able to fill your allocation. Please contact Terese Domanski's YMCA office at 862-9757 as soon as possible with an indication of the number of participants ages 18 and over that we can expect.


Incidentally, there will be entertainment, including music and fitness demonstrations, throughout the morning. And each participant will be given a REAL FIT PEOPLE teeshirt, courtesy of NBC's REAL PEOPLE, as a thank you for his or her support.

PROJECT PERFECT FIT's event on the Ellipse will serve as the Washington kick-off event of National Testing Week, during which more than 500,000 Americans will be tested across the country.

Additionally, you can inform your friends that on April 28, at 7:00PM on Channel 4, they can learn about the fitness test during a 30 minute special program, TAKE THE TEST AMERICA, which stars many superstar athletes and former Redskin coach George Allen as they explain and take the test.

We hope you will be able to be with us on May 5, along with a contingent of your friends who share an interest in physical fitness. By joining forces in this important project we can all help make ours a healthier and more perfectly fit community.





Dear Mr. Deaver:

The letter to The President that I sent to you evidently landed on Mr. Ryan's desk as I have a refusal from him this morning.

This distresses me very much for several reasons:

1. The President took a personal interest in the rebuilding of Wolf Trap's Filene Center which was manifested by his telephoning me personally on two occasions and sending a representative from his office to our initial meetings to help in any way possible.

2. Politically this seems an excellent chance for people to recognize The President's interest in the performers and performances in the whole area of the performing arts. In this field he is not particularly strong and we at Wolf Trap feel this would add strength and confidence to this segment of our citizens.

3. Interest in Wolf Trap is nation-wide as shown by the number of donations we have had--approximately 17,000 from people in every state of the Union and nine foreign countries. These gifts range from monies in children's piggy banks to the \$1 million donated by Mr. and Mrs. David Packard.

So again, I repeat Wolf Trap's request that The President speak at the Dedication of the new Filene Center at the first and only National Park for the Performing Arts.





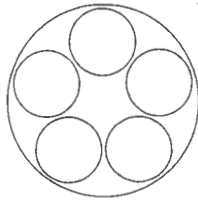

Mrs. Kirkpatrick Says NATO Is Greatest Postwar Success

Jeane J. Kirkpatrick, the chief United States representative at the United Nations, said yesterday that the North Atlantic Treaty Organization "is a colossal success, the greatest single success of the post-World War II years."

Mrs. Kirkpatrick, who spoke at a luncheon at the Waldorf-Astoria sponsored by the National Committee on American Foreign Policy, added that disagreements within the alliance were overshadowed by "a potential Soviet threat to the security of Western Europe and a belief that the Atlantic alliance is the best available option for protection from that threat."

Mrs. Kirkpatrick said that despite changing economic and military factors that create occasional strains within the alliance, "relations between the United States and its NATO allies today are very good and very strong."

She said that although "it is not a perfect marriage," cooperation among the NATO nations will survive because cooperation is based on "more than nostalgia."

THIS TELEGRAM IS OUT OF DESPERATION. OVER THE PAST THREE YEARS ON BEHALF OF A COALITION OF CHRISTIANS THAT INCLUDES SOME OF THE 1500 BLACK BISHOPS, PASTORS AND LAY MINISTERS AND A WIDE RANGE OF ALL RACES AND DENOMINATIONS, I HAVE TRIED TO SCHEDULE A CONFERENCE IN THE WHITE HOUSE TO INCLUDE A DROP-BY VISIT BY THE PRESIDENT. THIS GROUP HAS REPRESENTED MILLIONS OF CHRISTIANS AROUND THIS COUNTRY WHO ARDENTLY SUPPORT YOU IN YOUR PRESIDENCY.

A LETTER WAS SENT TO YOU MR PRESIDENT ALMOST A YEAR AGO, AND THEN PRIOR TO THAT LETTERS OF INVITATION WERE SENT TO YOU, PLUS TELEGRAMS, REQUESTING THAT YOU SUPPORT SUCH A CONFERENCE BY ACCEPTING OUR INVITATION FOR A DROP-BY VISIT. AFTER WRITING YOU IT WAS RECOMMENDED WE GO THROUGH MR BLACKWELL'S OFFICE. THEN AT A LATER DATE AFTER NO RESPONSE, LETTERS WERE SENT AT INTERVALS TO CAROLYN SUNDSETH, THEN TO FAITH WHITTELSEY, AND WE TALKED TO DEE JEPSON. ALSO I SPOKE WITH ED MEESE WHO SAID HE WOULD CONVEY TO YOU MR PRESIDENT, MY REGARDS, AND HE SAID, "THE PRESIDENT THINKS A LOT OF YOU, JOHNNY."

THE FINAL BLOW CAME WHEN I WAS REFERRED TO MR DEAVER'S OFFICE TODAY. ONE OF HIS PERSONNEL FOR HIS PERSONAL SECRETARY ANSWERED MY CALL SHE SAID THAT MR DEAVER WAS NOT IN. I STARTED TO EXPLAIN THE REASON FOR

MY CALL. I TOLD HER THAT WE HAD LITTLE TIME AND EXPLAINED WHY I NEEDED TO TALK TO MR DEEVER, THAT WE HAD ENCOUNTERED DIFFICULTIES IN TRYING TO GET A DROP-BY VISIT BY THE PRESIDENT TO AN UPCOMING CONFERENCE OF CONCERNED CHRISTIANS TO BE HELD ON MONDAY MAY 7 1984 IN THE OLD EXECUTIVE OFFICE BUILDING. THE YOUNG LADY SAID, AND I QUOTE, "IF YOU DON'T THINK THAT THE PUBLIC AFFAIRS OFFICE IS DOING ITS JOB, PUT IT IN WRITING." WITH THAT REMARK THE TELEPHONE WAS FORCEFULLY HUNG-UP. SO, MR PRESIDENT, I AM PUTTING IT IN WRITING AS SHE SUGGESTED (I DO NOT BELIEVE A CALL FROM ANY CITIZEN, WHOEVER IT MIGHT BE, SHOULD BE HANDLED IN THIS WAY).

I THEREFORE REQUEST YOU GIVE THIS YOUR PERSONAL ATTENTION. I DO NOT HAVE TO TELL YOU THAT I HAVE BEEN YOUR LOYAL FRIEND OVER THE MANY YEARS I HAVE KNOWN YOU. AND I HAVE BEEN A FRIEND WHO HAS A DEEP AND

ABIDING LOVE FOR YOU, AND FOR NANCY.

I AM MAKING THIS PERSONAL REQUEST MR PRESIDENT, THAT YOU MAKE A DROP-BY CALL ON MONDAY BETWEEN THE HOURS OF 3 TO 5 TO GIVE ENCOURAGEMENT TO THE REPRESENTATIVES OF THE MANY CHURCHES AND CHRISTIAN ORGANIZATIONS WHO LOVE YOU AND SUPPORT YOU. 


