Re: Folder in Michael Deaver collection

While I was reboxing the unprocessed portions of Mr. Deaver's collection, checking the folders against the new Deaver inventory, I came across an entry for a folder titled "Outgoing Memoranda/Requests for RR Letters." However, I was unable to find such a folder anywhere in Deaver's collection. The material in question originally consisted of an entire partial OA (OA 8545).

I brought this issue to Diane, and we looked for the material. We determined that at some point, OA 8545 had been transferred to the collection of Holly Stewart (Office of Private Sector Initiatives). However, since it had originally been considered part of Deaver's collection, and had been included in his inventory when the Office of the Deputy Chief of Staff was arranged, we decided to leave a folder for it in his collection. The folder will simply note that the material was transferred to Ms. Stewart's collection.
