Dear Mike:

Last week I spoke with your deputy, Mike McManus, who told me that our request to run Patti's wedding had been turned down. I asked Mike to tell you that I would be coming back to you to see if there is any way we can resolve this.

We would love to negotiate. We really want to put the President and Patti on our cover. What we are looking for is a good color photo of the Father of the Bride with his daughter. Tuesday, August 14th is a closing day for us. The magazine would appear on the stands the following week, August 20----the day the Republican convention starts.

Everyone is aware that Patti, like most young women, does not want to turn her wedding into a three-ring circus.

Our L.A. correspondent, Suzanne Adelson, interviewed Patti earlier this year when she became engaged. I gather that Patti like the story and liked Suzanne. Suzanne has been in contact with Larry Thompson, Patti's manager. He is more than willing to help out if this project gets an okay. Suzanne would do any reporting necessary with an assist from the Washington bureau, but I stress, what we are really looking for is that wonderful photograph os the President and his daughter to put on People's cover. Because of the time difference between California and New York, we are wondering if there would be an opportunity to photograph them an hour before the ceremony, so the picture could be telegraphed to New York. Our photographer, a White House photographer, or a photographer Patti feels comfortable with, would be assigned. Needless to say, we would only want color pictures for that particular week, because after that, it would be too late for us, given our weekly lag between going to press and appearing on the stands.
