Harriet Tubman, who was known as the conductor of the underground railroad, said of her first escape from slavery, "When I found I had crossed that line, I looked at my hands to see if I was the same person. There was such a glory over everything."

Dear Mike and Carolyn:

I am enclosing the draft invitation list for the dinner Dr. and Mrs. Cheek will host for you on November 30, 1982 at their home.

We are considering this list as a draft until the two of you can review it -- making both additions and deletions.

We are trying to accomplish two things against this list: to invite your friends and colleagues as well as people we are trying to reach out to, in order to make a public expression of our gratitude for your unique and very special relationship with Howard University. With these and your own personal and professional/political relationships in mind, please do not be hesitant about altering the list, as required.

Mrs. Cheek is hoping to entertain 50-70 people for cocktails and dinner; we need, therefore, a list of 125-150 invitees.

We plan to mail invitations in "waves", with the "National List" going out first, to allow out-of-town people the chance to make travel plans. All invitations should be in the mail no later than October 29, 1982.
