You asked me to give some thought to the problem of exactly the right person to be selected to replace Mr. McCoy as the Chief of Staff for Mrs. Reagan.

Dr. Robert Filep could be an ideal chief of staff for Nancy Reagan. He is from California, and he is an efficient, personable and good manager. He has been well liked by all of those people who have worked with him.

As you may remember, he was chosen and ready to take the job as an Associate Director here, but his wife -- a professor -- was not granted tenure by the board of directors of her college, which was a mean, small gesture on its part. However, I now understand that, after much work, Mrs. Filep has now worked it out so that she may be granted tenure and would be available to come to Washington.

My personal experiences with Bob Filep go back as far as 1962, when I ran for Congress. He was my campaign manager and directed my staff. Because of the way he handled subsequent political campaigns for my clients in gubernatorial and senatorial races, I utilized him both in politics and, as time went on, for projects that I encountered in my business and as chairman of the New York Board of Trade. I guess in life you always keep going back to those people who performed well for you.

I always found Bob unfailingly cheerful, efficient and a person who exercises good judgment. I think wisdom and judgment are the key elements in a job as chief of staff, because not only does one encounter managerial problems, but there are political and public relations problems arising for Mrs. Reagan. Her image is very important, and, as we have discussed, you and I -- and I am sure Mrs. Reagan -- are not happy with the way some issues have turned out in the media. I think a very careful handling and projection, with respect to timing, could be extremely helpful, and I am positive this could be turned around if the right person were appointed as her chief of staff.

Bob Filep's background presents a quite unusual combination:

- \* He holds a Ph.D. and has taught as a professor at the Annenberg School of Communications at the University of Southern California.

- \* He is an expert in computer and space-age technology, and I believe he has demonstrated his leadership as president of several professional scientific organizations.

- \* He has consulted with some of the top people in business and industry organizations, and was a U.S. delegate to an international space conference not long ago.

- \* He is a former Air Force officer.

It is also very important to have the right family team. Bob's wife has a Ph.D. and is a professor. She also worked in the White House Press Office with Jim Haggerty during the Eisenhower Administration, so she understands the White House.

Bob is a good family man. He has a daughter who is 13 and a son who is 11. Even at a busy time during his life, Bob took time out to be the Little League manager for his son's team so that he could spend time with him.

He is 49 years of age.

Dear Mr. Deaver:

A few months ago, Bill Skelton strongly recommended to you that I be given serious consideration for a major post within the Administration, as a principal policymaker dealing with the drug abuse issue.

On October 5, Dominick DiCarlo, Assistant Secretary of State for International Narcotics Matters, offered me the post of Special Assistant, a Schedule C equivalent of a GS-15. On October 9, I met with Ron Mann and Becky Dunlop in Presidential Personnel, providing them with not only my credentials but also copies of my various papers, including recommendations for block grants and other innovations which I proposed six years ago, and are now part of Administration policy. I also provided numerous references of prominent Republicans and citizens well known to the Reagan Administration.

Yet, in all of this time, I have not been able to get a political clearance. Becky Dunlop received one or more rumor-monger calls alleging that I had a close relationship with a former official of the Carter Administration. When I was Special Assistant for Federal-State Relations on Narcotics under Governor Rockefeller and later as Director of the National Association of State Drug Abuse Program Coordinators, I did indeed have a working relationship with Dr. Bourne, who held top drug abuse positions in both the Nixon and Carter Administrations. But, since I left that post in 1977, I have had four brief encounters with Bourne, hardly what I would call a close relationship. Moreover, I was a leading critic of Carter Administration drug abuse policies.

Even more to the point, I am shocked that Presidential Personnel would give more weight to rumor-mongers than they would to endorsements from DiCarlo, Skelton, Dr. Richard Palmer (former head of the AMA), Dr. Evron Kirkpatrick, Richard Parsons (who directed Ford Administration drug policies) and countless others. I believe the calls were inspired by a disgruntled job seeker.

Two weeks ago, Becky Dunlop said she was reconsidering; two weeks ago, Lyn Nofziger said he was inquiring. Forgive my impatience, for I certainly mean no disrespect for any of these officials, but I have been attempting to work for this Administration for more than a year.

I believe in this President, and want and can help Ronald Reagan succeed. As a political scientist, I am keenly aware that he has the most unique opportunity since Roosevelt to forge a realignment of the political process. But, his Administration needs a few more, well-qualified people.

Dear Mike:

Thanks for the appreciation card I received this morning. What I do in our country's and our President's behalf is quite time consuming, often expensive and sometimes has required difficult research to be sure I am giving you the straight dope. Some feel what I do is a waste of time, that the work is going to file 13 on receipt. In spite of this, I do not feel happy unless I am actively working for the turn-about. In fact, besides helping Pres. Reagan and our country, perhaps there is an overriding factor, our critical financial position compared to ten or twenty years ago. Inflation has frozen us out of so many things we used to be able to afford to do. Now we are concerned about just staying solvent!

I am attaching a letter to Congresswoman Claudine Schneider of Rhode Island, where I was raised and still have many friends. I have attempted to start this "Gypsy Moth" expanding her thinking about her poor constituents, the great way of life we have and the fact that we should be prepared to fight to keep it, if necessary. She may be a lost cause, but so might Dru and I have been prior to my hearing Barry Goldwater in 1963.

But, there is an additional factor here, James Reza, a latin of Mexican descent who has come up the hard way. He travels south of the border on business and has first hand knowledge of what is going on down there that has largely gone unreported. He is unquestionably one of "us" and is a good speaker. However, I am concerned that our opponents may harrass him. He is a brave man and says he is willing to face this problem if it arises. In fact, because he is a fighter he is already being harrassed by lefties in his area. He should be invited to Washington to tell his first hand story where it counts. The only problem is that for such a visit his expenses would have to be covered. He is already giving his "all" down here.

Please look into this. James has a kind of first hand ongoing knowledge and the ability to recognize what he has seen that is hard to find. In fact, he would be a good candidate for an advisory position on Latin American affairs.

Dear Congresswoman:

I am a Rhode Islander who has been moved to Texas by my job requirements. My home was in Saunderstown where I grew up. For thirty years I have worked as an engineer, though I am not a graduate. For the last twenty my wife and I have been in the independent manufacturer's representative business, specializing in municipal and industrial water and waste treatment.

In addition, we have spent twenty-five continuous years in active Republican work. We started when being a Republican in Texas was rather unpopular as over 90% of the people were Democrat - even though they had voted for Hoover and then for Eisenhower. To be a proud Republican working for the good of this country just got most doors slammed in one's face.

Since then we Republicans have worked our state through an almost complete about-face. The biggest cause was a new Republicanism, first sold to us in 1963 by Barry Goldwater. Our intent changed from just trying to outdo the Democrats at the same game to a completely new set of issues in how to produce prosperity, a life to be proud of again, and how to defend it and keep it. In some ways the new Republicanism was a combination of what some would consider "liberal" ideas and others that would be considered "conservative". We do call ourselves conservatives because our ideas contrasted greatly with those of prosperity through more and more controls, taxation and spending. The best that fifty years of this could produce was the direction of Lyndon Johnson and Jimmy Carter. It didn't take a scholar to realize that trillion dollar debts and multiplying deficits could only lead to complete financial collapse and that deficient military capability could only lead to the Soviet form of slavery. Then about 1974 we discovered Ronald Reagan who personified the issues we believed in.

It is very disappointing to me that the Claudine Schneider my Rhode Island friends were bragging about last summer would use her influence to try to wreck the Reagan programs, who would join a movement, the "Gypsy Moths", a group sworn to such an end. How can you have fiscal responsibility and yet maintain the programs of wasteful give-aways and endless poverty? Why don't we try to produce jobs, give our poor something to be proud of in the same way our ancestors did?

I come from shipping people in Pautuxet. My ancestors worked up from nothing. One was Daniel Aborn who skippered a privateer, "Chance", out of Pautuxet;

another was Pardon Sheldon who skippered the "Hanover" from the same home to the Baltic and the China coast. Both of these men were lost at sea. My grandfather was put on a train in 1856 at age sixteen with nothing but a ticket to Boston. In 1903 he returned to Rhode Island and began a year after year four month visit to the old Saunders House (Saunderstown). He had become a successful merchant and real estate business man in Savannah, Georgia, with hardly more than a grade school education.

What I am getting at is that our poor will always remain poor on welfare and those of us in the lower middle class are fast being reduced to that same level. We all must make the most of it or we'll all be Soviet puppets eeking out a meager life without choice. Let us not kill the goose who can and will give us the golden eggs of a prosperous future.

Let us all study the programs being offered to us and then seek to put them into operation. Let us put an end to the Volkens who would manage our money to accelerate the bust, for only with a sound and stable money system can we achieve the results we desire.

Attached you will find some economic history and a diagram of the "Table of Prosperity" we so badly need. In addition, if we are to stay free, we must always be ready, willing and able to defend it - just like our New England ancestors did.

In the foregoing I have tried to show you that it is absolutely essential that we have, let us call it the "four legs to prosperity". But, in addition, we must never forget that there will be no prosperity unless we follow the example of our forefathers. These demonstrate that we must have not only the tools for defense, but also a determined will that we cannot, must not, permit the means for life, the American way, to be taken from us. Our good life will not remain for long without that will and the materials required for us to win. History has proven that the aggressor has only contempt for weakness. This is as true today as it was in those of Kubla Kahn, Napoleon and Adolph Hitler.

One more item that has had little publicity in our nation: Do you realize how close the Soviets are to puppetizing the whole of Central America? It began with Cuba in the late fifties. Now with our misplaced regard for human rights, particularly with Panama and Nicaragua, we have permitted, no, aided the Soviets through their Cuban lackies to infiltrate and spread their terror from Panama clear up through Mexico. We have replaced the alarm and distaste of Somosa's treatment of trouble-makers with the horror of Soviet total domination in both Panama and Nicaragua.

Both Latin and Anglo businessmen engaged in Mexican-American trade have told about Soviet propaganda and (terrorist) training that is operating almost completely open. One of these centers is as close as Monterrey. It is our own citizens of Mexican extraction who are most concerned. An overnight coup could happen whenever Moscow is ready. Probably the tanks and missiles will appear at the same time.

If the United States does not soon help our friends among the latins to become strong, the Soviets with a twenty year headstart will suddenly have a Central American police state next door. You are where you can check out the truth of this; I suggest you do it because we do not want Soviet tanks, missiles and Migs as close as they are to Poland. Ask any Polish or French American what war on your front lawn or back door means. The hour is late. The choice is also for you and the Gypsy Moths.

One of these people, James Reza of Fort Worth, who travels to Mexico on business, is willing to correspond with you or come to Washington to speak on the various related subjects such as illegal aliens, bilingualism, Soviet-Cuban infiltration and what goes along with infiltration. He said this morning that they are now openly established in Cuidad Acunia, just across the Rio Grand from Del Rio, Texas. He can be considered an expert in his field and a good example of a Republican volunteer.

Mr. Reza is a good speaker and knows his subjects. We have heard him locally, but he said this morning he had never yet been invited to Washington. Should you want him to come up, his costs would have to be covered because he is just an ordinary Latin American (Mexican descent), and one of us in the lower middle class.



Dear Joe:

Thank you for the opportunity to meet with you and discuss the position of Business Liaison. I gather from you, the Secretary has some pre-conceived ideas about the position and its applicants. I would like to submit to you some thoughts that I have which establish my creditability for the position.

My aggressive, high energy approach to business has enabled me to be successful in a number of small companies that I have been responsible for starting.

Having had these opportunities to start small companies, has also provided me challenges and I have acquired the ability to make fundamental decisions based on established business practices. This coupled with a portion of common sense, goes a long way in providing me with a keen sense of direction and how to be successful. Having been appointed to Public Service (Commissioner - State of California Housing and Community Development) by then Governor Reagan, I understand the essential need to establish an ongoing creditability in order to be effective. It takes a certain amount of vitality to be effective in Public Service. There are many frustrations. SUBJECT: FURLOUGH DURING APPROPRIATIONS LAPSE

At midnight, November 20, 1981 the continuing resolution providing appropriations for the Executive Branch for fiscal year 1982 lapsed. The President has vetoed the continuing resolution subsequently adopted by the Congress because it exceeds budget projections. Accordingly, the Executive Branch is now without funds.

The Anti-Deficiency Act, 31 U.S.C. Section 665, prohibits any government official from obligating or expending funds in the absence of an appropriation and this includes funds for non-essential personal services. It is necessary, therefore, that we furlough all employees whose work is not essential to the projection of the national security, the preservation of essential health and law enforcement services, the protection of life and property, and the orderly phasing down of government functions during the appropriations lapse.

You are hereby notified that you are being furloughed, effective noon on November 23, 1981. You should secure your files and close your office at that time and vacate the building. It is important that you remain within telephone reach of the White House Office so that you can be contacted, if necessary, and can be notified when the availability of appropriations permits termination of the furlough. Furloughed personnel are not to return to the Office until recalled. If you become aware of some essential work left uncompleted in your office, telephone the appropriate official remaining on duty.



I am a little reluctant to keep pressing my case for Craig Roberts but today I had lunch with Larry Silberman who expresses the same concern many of us hold, namely, that Ed Meese is hesitant to take the leadership in bringing to the President ideas and programs, that Baker is moving more and more into control of the triumphant and while he is a good man particularly in organization he doesn't inherently have the dedication to the policies which elected the President which we feel are essential to preserve, rightly or wrongly. There is a broad consensus here that Ed needs the kind of guidance that Craig Roberts would give, if he were willing to accept it, in the White House. The only one that can change that situation, in our opinion, is the President himself. I feel and I know this is shared by others that, unless a strong right-hand is developed through Ed Meese, there will be a continuation of conflict which is detrimental to the President and his Administration. Consequently, if Craig is not going to get the Federal Reserve job and I have reason to believe that my proposal of his name was one of the reasons for Marty Anderson's name being leaked as a potential for the Fed, you would be doing this country a great service if you could convince President Reagan that he has to take his stand, as he did before, on the programs that elected him and that he needs a Craig Roberts to put them in the proper perspective.

This is generally the thinking that I tried to get across to you on our last telephone conversation but since then I have talked to three of your friends here who are just as concerned as I am and feel that Craig is the man who could give the necessary leadership.

Dear Jus:

I am terribly disturbed because I feel our President is in deep trouble basically because he has not surrounded himself with the strong leadership that is vital to bring us out of the chaotic condition of the financial world which has been developing over the last thirty years. He was elected because he promised specific tax reductions and a sound fiscal monetary policy based on the reduction of the governmental expenditures and a lessening of governmental controls. A balanced budget was assured. Congress, however, failed to give him the tax program which he advocated and the reduction in expenditures necessary which many of us felt at the time was not enough. The securities market is telling you and his own Cabinet members are suggesting that there is a recession which we cannot deny but this will increase the Federal deficit and means that we are in the unusual dichotomy of a tight monetary policy and a stimulative fiscal policy. There is no way to turn this country around under these conditions.

As a result, the Keynes and other liberals in the newsmedia are beginning to say I told you so it wouldn't work. Our Secretary of Treasury has certainly not exerted the leadership vital for that all-important post. I need not tell you that there have been too many differences of opinion expressed at the Cabinet level which is grist for the mill of the commentator. The answer to this, in my opinion, is an urgent appeal to the President to reassert his leadership making it clear to those who disagree with his basic philosophy that their tenure will be limited. In order to accomplish this means strengthening materially the second tier advisors for it certainly would be inappropriate to, at this time, make a shift at the Cabinet level. Ed Meese needs a man like Craig Roberts whose experience and excellent mind would be of tremendous value to him and the President. I am concerned because I hear that Meese is sponsoring Marty Anderson for the Federal Reserve job. Marty is a protege of Burns who certainly doesn't stand out as a great leader while at the Fed. Anderson, I'm afraid, will blow <sup>with</sup> the wind which is what the Fed has been doing. The members of the Fed themselves are anxious to have Jordan who is on the Economic Advisory Council and again one who will not


disturb the cabbage patch.

One of the great promises Reagan made was that business and individuals would be able to plan ahead. Today, with suggested changes in taxes, that thought is being undermined. The plan for reduction in expenditures is less than it should be but a dedication towards reducing expenditures over a period of time will re-establish the confidence vitally needed in fiscal affairs. Of course, Bill Simon would be the ideal advisor in the Treasury Department but I see the difficulties there. He would be of tremendous value to the President if he would see him on a monthly basis, merely on fiscal and monetary policies.

You are the only one I know who can place this before the President effectively but the seriousness of the situation, in my mind, requires you to take this important message to him for, if he doesn't change the thinking of those around him, he is in deep trouble and this we would all hate to see.



Anything you can do to push his name for this job would be a great service to this country.
