Dear Chairman Pendleton:

On July 28, your acting staff director wrote and requested additional details to support the President's statement at his press conference on July 26, that he had appointed women to over one thousand executive positions in his Administration. Your acting staff director in his letter also requested further specifics about the President's statement that the Reagan Administration's record of women appointments compared favorably to that of President Carter at mid-term. In an effort to help the Commission in its continued monitoring of equal employment opportunity in the Reagan Administration, we are pleased to provide you with the requested information.

The President's reference in his press conference to the more than one thousand women appointed to executive positions in his Administration encompassed direct full-time and part-time Presidential appointments, and non-career senior executive service and Schedule C managerial positions (at or above the GS-13 level, \$34,930 per annum). As shown on enclosure five, the total number of women appointments thus far in the Reagan Administration is over 1,200 (as of August 16, 1983). To this Administration's credit, females have constituted fifty-seven percent of all Schedule C appointments (1697 of 2978) and fully forty percent of appointments at or above the GS-13 level (584 of 1460).

In order to demonstrate the accuracy of our comparative figures, extensive data is enclosed detailing the records of Presidents Reagan and Carter

on appointments of women during the first two years of their respective Administrations. */ All data have been uniformly tabulated and interpreted in arriving at the appointment totals for each President.

Full-time Appointments

A comparison of all full-time direct presidential appointments shows that President Reagan selected 4% more women during the first two years of his Administration than did President Carter (105-101). **/ When one excludes Federal judicial appointments, President Reagan's full-time women appointments are 9% higher than President Carter's (99-91). Moreover, these figures do not include ten women whom President Reagan had selected for full-time positions before January 21, 1983, whose names had not yet been announced pending completion of standard pre-appointment security and other clearances.

Part-time Boards and Commissions

President Carter's female appointment totals for part-time boards and commissions are misleading. Nearly a quarter (23%) of Carter's female appointments to part-time posts were made to two commissions, created to deal solely with women's issues, which are

*/ While much of this information had previously been compiled and reviewed by our Office, the computer records available to us from the Carter Administration were incomplete and inaccurate. In an effort to ensure a complete and accurate response, we undertook a thorough review of President Carter's appointments, based on original source material from the White House Executive Clerk, and computerized the resulting data.

**/ The enclosed summary of direct Presidential appointments of women during the first two years of each Administration covers persons in the following categories: (1) persons appointed to office (including those who have since left office); (2) persons who were nominated, but who were either withdrawn or had not been confirmed at the two-year point; (3) persons whose intended appointment had been announced, but who had not been nominated or appointed at the two-year point; and (4) full-time "holdovers" serving at the pleasure of the President.

now defunct. Excluding these commissions, the total number of Reagan women appointments to part-time positions in the first two years is 6% higher than Carter's (276-260).

Altogether, omitting judges and the aforementioned commissions, the total number of direct Presidential appointments of women made by President Reagan in the first two years of his Administration is 7% greater than the number made by President Carter during the comparable time period (375 to 351). Specific examples of President Reagan's appointments of women to significant positions show conclusively that he is far ahead of President Carter in selecting females to serve at the highest policy levels. As you know, he is the first President to have three women serving concurrently in his Cabinet, and the first to appoint a woman to the United States Supreme Court. On his own staff, he has appointed women to 24 senior (i.e., commissioned officer) positions, including two who have served as Assistant to the President for Public Liaison and the first woman ever to serve as Assistant to the President for Presidential Personnel. */

While we believe the President's record on appointments of women is impressive, it is equally as important that the Commission understand the philosophy that guides the President in making all his appointments. The President himself aptly summarized that philosophy in his address to the American Bar Association's Annual Meeting on August 1, 1983, stating:

"We aim for a cross-section of appointments that fully reflects the rich diversity and talent of our people. But we do not, and

will never, select individuals just because they are men or women, whites or blacks, Jews, Catholics, or whatever. I don't look at people as members of groups; I look at them as individuals and as Americans. I believe you rob people of their dignity and confidence when you impose quotas. The implicit, but false, message of quotas is that some people can't make it under the same rules that apply to everyone else."

Finally, Chairman Pendleton, I would note that we have supplied to the Commission a considerable amount of information about appointments in this Administration. To assist us in reviewing our own appointments it would be helpful if you would forward copies of the Commission's requests to the Carter Administration for similar information and the dates you asked for the information. I would appreciate copies of all evaluations of the Carter Administration data that the Commission has done so that we can be certain all comparisons are accurate and fair.

PERISCOPE

How Many SS-20s Does Moscow Have?

Capitol Hill and U.S. intelligence sources charge that the Soviet Union has 50 percent more nuclear warheads aimed at Western Europe than the number commonly accepted. The Soviets are known to have deployed two SS-20s, both armed with three warheads, at each of 240 launch sites in the European part of the U.S.S.R. But according to several official Washington sources, intelligence photos and other evidence suggest that there is a third three-warhead missile hidden in the vicinity of each launch site. These sources also say that some of the hidden missiles were in place for as long as three years before they were discovered, raising serious questions about U.S. ability to verify Soviet claims.

Odds On for a Reagan Rerun

What are the odds that President Reagan will decide to run for a second term? One senior White House aide puts them at 90-10 in favor of a re-election bid. And while the improving economy may be Reagan's most potent campaign weapon, this aide views it as the one thing that might persuade him not to make the race. Reagan talks longingly of returning to his California ranch, the aide says, once the economy is on the mend and he can leave with a sense of having accomplished his mission. Other staff members are concerned that the president's recently improved poll numbers have created a false air of invincibility around the White House. One cautious adviser points out that support for Reagan is "all very squooshy" with significant soft spots like truckers and steelworkers, who have suffered the negative effects of Reaganomics.

Soviet Contributions to Peace

The Soviet Union is surreptitiously pumping \$30 million annually into the West German peace movement, including the Green Party, which holds 27 seats in Parliament, according to a secret investigation by the Bundesnachrichtendienst, West Germany's equivalent of the Central Intelligence Agency. The funds are channeled into the country through front groups and used mostly to buy routine supplies such as megaphones, posters and office equipment. The findings of the investigation have not been released, possibly because Chancellor Helmut Kohl wants to avoid a controversy before his July visit to Moscow.

A Three-Way Arms Deal

The next shipment of U.S. arms to Taiwan may come from Israel. Taiwan wants to buy additional American-made M48 tanks, the mainstay of the Taiwanese Army. Even though the tanks are an outdated model, a direct sale would anger Peking, which frowns on any U.S. aid for the Nationalist regime in Taipei. But ignoring the request would anger President Reagan's right-wing supporters. One alternative that the Reagan administration has begun to explore is having Israel sell some of its M48s to Taiwan. Preliminary indications are that the Begin administration would be willing to cooperate.

The Governors' Gripe With the White House

The scandals at the Environmental Protection Agency have had an unexpected side effect: strained relations between the White House and the nation's governors. Governors from both parties wanted James Medas, the second-ranking White House

aide for liaison with state and local governments, to be promoted to the top job. Medas was in line for the post until he came under scrutiny during a congressional hearing because of a meeting he held with former EPA Assistant Administrator Rita Lavelle, who is under investigation for political use of EPA funds. Although Medas is not suspected of any wrongdoing, simply being mentioned in the hearing made him too controversial for promotion. The governors now fear that Medas will resign rather than continue in the No. 2 job.

The Wrong Woman for the Job

President Reagan recruited former ambassador to Switzerland Faith Whittlesey to be his ambassador to women, but she has been anything but diplomatic in the job. Since becoming assistant to the president for public liaison in March, Whittlesey has alienated feminists with her opposition to the Equal Rights Amendment and her tepid support of such administration initiatives as equalizing pension benefits for men and women. In a political-strategy session with the president last week, Whittlesey stunned her male colleagues with the assertion that the "gender gap"—the disproportionate displeasure with Reagan among female voters—is overrated. White House planners who believe otherwise have vowed to limit Whittlesey's role in policy decisions on that sensitive issue during the campaign. A new working group on the women's vote has already been formed, with deputy chief of staff Michael Deaver in charge.

A Trade Dispute Within the Administration

The Reagan administration is involved in another dispute over trading with communist countries—but unlike last year's squabble over the Soviet natural-gas pipeline, this problem is strictly intramural. Officials of the U.S. Commerce Department have been trying for more than a year to persuade the Defense Department to drop the licensing rules Communist-bloc countries must follow to buy American-made items such as personal pocket computers, electrocardiograph machines and digital thermometers. Although all the products contain sophisticated computer chips, the Soviet Union and its allies can purchase similar goods from other countries with little trouble. In addition, Commerce has asked Defense to abolish licensing requirements for such nonstrategic materials as baby formula, disposable diapers, panties, sausages and commercial refrigerators. But the Defense Department refuses. A senior Commerce Department official attributes the problem to institutional stubbornness. "They just won't decontrol. It's mindless."

Panama's Alarming Cash Flow

Senate investigators have discovered that in recent months Panama's central bank has shipped hundreds of millions of dollars in U.S. currency to the Federal Reserve Bank of New York. William Roth, chairman of the Senate Permanent Subcommittee on Investigations, has launched an inquiry to determine who is moving the money and why. One strong possibility is that Panama has become a new stop on the laundry route for South American drug-trade profits. Roth will hold hearings on the results of the probe later this summer. He is also preparing legislation designed to help U.S. enforcement agencies penetrate the secrecy of Caribbean and South American banks used by drug dealers and white-collar criminals to mask their financial transactions.

SUBJECT: Recommended Appointment for Maureen Reagan

You have requested our views regarding Jim Coyne's efforts to obtain a position on a private board of directors for Maureen Reagan. Coyne has been advised by William A. Delphos, Vice President of the Overseas Private Investment Corporation (an agency of the Federal government), that he has surveyed the international network of associations and councils that he works with to determine which of those private organizations might have boards of directors on which Maureen Reagan could serve. As a result of this survey, Delphos has provided Coyne with a list of organizations in which Maureen might be interested.

Thank you for requesting our advice regarding this matter. We believe that it is wholly inappropriate for officials of government agencies to be involved in assisting Maureen Reagan, in any way, to obtain a position of employment. We hold this view regardless of whether the positions identified for Maureen are private or Government positions; the appearance of impropriety will exist in either case, as the individuals who are assisting Maureen are employees of the Federal government. The likelihood of the creation of an appearance of impropriety is exemplified by the facts in this instance; here, a government official is recommending positions for Maureen with the private sector associations and entities that are affected, either directly or indirectly, by the performance of his official responsibilities.

In view of the appearance problems created by such activities, we recommend that no one in the White House staff or the Federal government participate in any search for suitable positions of employment for Maureen.

As of Jan. 5, 1983, I still had not received either the information on the committee or an invitation to serve. I called Ms. Christian and she seemed quite surprised that I had not received anything. The next week I received this annual report (copy enclosed) and as of this date, that is all I have received.

I hope this all litany doesn't sound like I am complaining about something not happening that may not have been meant to be, I just wanted you to know why I have been so quiet on this, it certainly is not because I am not grateful for your recommendation, I most assuredly am.

I didn't even tell Carolyn until I received the first call from Ms. Christian and that was only because she said it was The White House calling and Carolyn was curious. It would be nice, however, to find out if anything is forthcoming, so I can relax one way or another. Again, thank you sincerely for all you have done.

I had lunch with Fritz yesterday and after lunch he insisted I come up to his office, which I did. I noticed that he had a new picture of the President (with QE II on mount) and commented on it and Fritz laughed and said "That's what I invited you up to see" I am jealous, Good ole Fritz, he is so funny and STILL very impressionable.

Carolyn sent us the picture of all of you Christmas Eve at the White House. It is really terrific and you all look great. Fritz is getting a travel itch again and wants to go somewhere in April or May. He thinks Mexico City would be fun to take Libby and Griff to but I have a feeling our travel will be severely restricted this year. We did enough traveling last year to suffice for this year also.

I was just thinking about your trip west with the Queen and I called Shirley to see when it was. I know you told me late Feb. or early March but I couldn't remember exactly when. I really hope we will have a chance to see you when you are out, I know you said you would only be in Sacramento briefly but we would of course be delighted to come to San Francisco if there was something or somewhere ^{where} we could see you.

I guess I have rambled on enough for now. I did want to tell you about my lunch with Dave (I suppose you know he is selling out his interest in Cafe Natoma.) and also about the appointment situation and of course to strenuously advise you that we would like to see you out West in the very near future. SEE YOU SOON.
