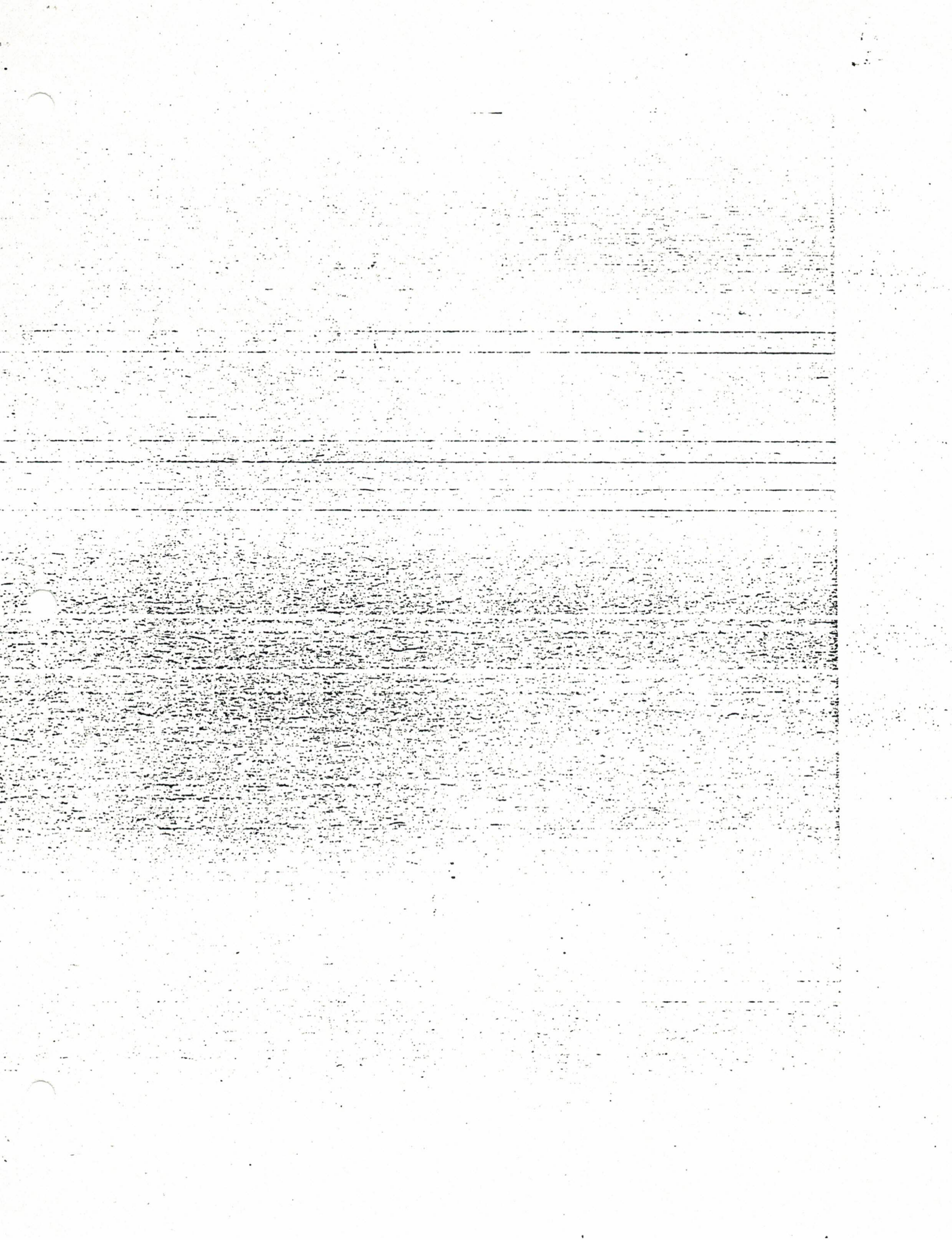

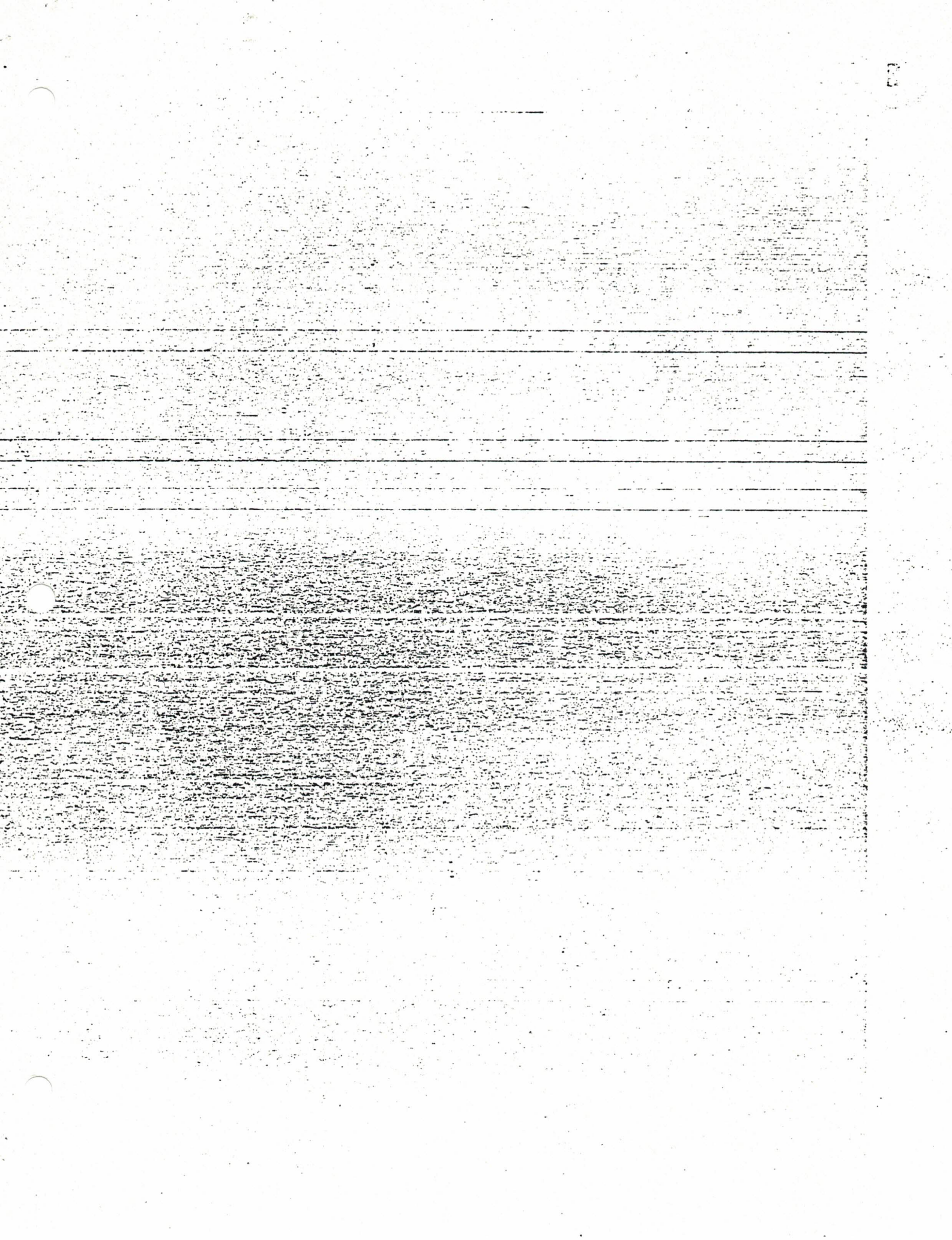

SUBJECT: Proposed Speech by Prime Minister Thatcher in
Oklahoma

You asked for my recommendation on Richard Wirthlin's idea of Mrs. Thatcher giving a speech in Oklahoma in connection with her visit to the United States for the Williamsburg Summit.

I am strongly in favor of Mrs. Thatcher giving such a speech. The timing would coincide well with our own efforts to win passage of the Defense budget in May. Mrs. Thatcher is an eloquent orator on the ideas of freedom, democracy and a strong defense.

I do not, however, think that the White House should support this particular proposal. After preliminary inquiries, we have found out that Mr. Holihan, the primary sponsor of this proposal, is not the representative of the kind of established, strong organization which would give the best setting to an address by Mrs. Thatcher. Therefore in your reply to Mr. Wirthlin, you should not commit the White House to support this proposal - rather you should suggest that they approach directly the British Embassy, which will be arranging the visit. I will alert the Embassy about this group.

Re: Proposed visit from Mrs. Margaret Thatcher

I recommend White House encouragement and support of: first, an invitation for the Prime Minister, Mrs. Thatcher, while visiting here end of May to take the opportunity to deliver a 'Churchillian' speech at a large gathering in the Mid-west. This would serve to rally conservatives, and inspire Americans on the success of Western free enterprise, the need for Anglo-American and allied cooperation to defend our freedom, and the path for real peace understanding instead of one-sided disarmament or 'Freeze' in the face of the Soviet threats. Secondly, acceptance by the Prime Minister to receive a prestigious award for 'courage and integrity' in the real battle for peace. This is a separate but parallel project in our real peace campaign to effectively counter the Freeze momentum and its growing political implications.

As you know I have worked on the Thatcher U. S. Speech idea for some time, receiving significant support for it here and in England. Last week I returned to London to deliver details of the two invitations, one from Marc Nuttle, Director of the Free Enterprise Foundation in Oklahoma for the Speech event, and the other from Dr. Ernest LeFever of the Ethics and Public Policy Center here in D. C. for the Shelby Cullon Davis Award.

I met with Jeffery Pattie, M.P., Minister of Defense for Procurement, and also the Private Secretary to Michael Heseltine, Senior Minister of Defense, and Peter Blaker, Minister of State for the Armed Forces, as they are aware of my past work and are primarily responsible to the Prime Minister in countering the so-called peace offensive. I also met with John Gummer, M.P., newly appointed to take the government's message to the Churches, and spoke with Winston Churchill, M.P. who also heads up the Conservative Party's Campaign for Defense and Multilateral Disarmament.

Mr. Pattie, most encouragingly agreed to take the proposals higher up to the Prime Minister's Private Secretary and others for support. Mr. Pattie rang me early today to confirm that within the Ministry of Defense, his colleagues had discussed the matter with interest and significantly a 'ruling-note' had been circulated. He confirmed further of "the positive interest in the right quarter" as the requested signal to hopefully explore the matter more officially.

He suggested that what was needed now was a similar encouragement of support and recommendation from the White House, preferably a note from the President personally to the Prime Minister, so that the scheduling factors could be best considered by both parties as early as possible and the event arrangements necessary gotten underway. He also suggested that I contact the British Ambassador, or his Private Secretary to brief them and enlist their cooperation once communication had been received.

Mr. Pattie and I hope these matters can be brought by yourself to the earliest personal attention of the President, Ed Meese, and whoever else you feel should be advised or consulted so this real peace project can proceed. If there is anyone I should meet to give either a brief or detailed presentation, or any other way I can help, please call me. This is a very strategic opportunity for both the Reagan administration to counter the Freeze, insure installation of Cruise, and give further support to the Thatcher Government in the forthcoming general election that will largely hinge on this peace issue.

Mrs. Thatcher is the most popular woman in America, and as an international statesman visiting down in the U. S. heartland she can deliver the whole conservative message of peace and economics with a clarion call that will be heard afar and respected by the majority. It is 30 years since Winston Churchill gave us his stirring warning on the real issues at Fulton, Missouri. America and a new generation in particular need another such reminder and inspiration.

I enclose for reference my letter to Micheal Heseltine which gives more details of the Award and the Speech event, together with letters from Dr. Lefever and Marc Nuttle. I also include supporting letters from the American Security Council, Dan McMichael of the Scaife Mellon Foundation, Micheal Deaver, Lady Hamilton, and my colleague, John Housh of the Fairness Committee Against Tax Funded Politics. The project is also endorsed through Mr. Nuttle by Milton Friedman and Ed Noble. It now awaits the go ahead from the Whitehouse. Thank you for your help and vision.

Dear Sir,

Although you and I have not met, I am known to your colleagues Ministers Blaker and Pattie for my work formerly as the American founder, initial funder and full time Director of The Coalition for Peace Through Security, which has now achieved its early goals and will carry on.

I have recently been appointed in Washington as the Chairman of The Nuclear Freeze Sub-Committee to co-ordinate the activities of all the counter-freeze, pro-peace through strength groups with others promoting the multilateral view, and also to liaise with The White House. There are now over 35 organisations and 20 Senatorial and Congressional representatives in the Committee. It is hoped this too will be a transatlantic endeavour as it is now more appreciated in Washington that there is a linkage between the UK/European and the U.S. unilateral disarmers.

I am recalled to the U.S. this Sunday for a fortnight to co-chair meetings with The American Security Council, the oldest and most well known of the private strategic groups to counter specific Pro-Freeze efforts in early March. I enclose details of the Sub-Committee and a letter from the Council with the next to last paragraph introducing the following idea.

I have been entrusted by a colleague, Dr. Ernest LeFever of The Ethics and Public Policy Centre to deliver a book, and information to you which includes a copy of a letter, the original of which he would like to be handed to The Prime Minister. The contents are self-explanatory urging a future U.S. visit and a speech to clarify the nuclear debate that assails both our countries. But in addition, Dr. LeFever has asked me to privately sound out the possibility of The Prime Minister, Mrs. Thatcher, accepting The Shelby Cullom Davis Award later this year when she is in the U.S. for the Trade Talks.

This particularly prestigious conservative award is given for "integrity and courage" and this year it is hoped to enhance the allied strategy for real 'peace with freedom and justice'. It was first awarded to Ambassador Jeanne Kirkpatrick, and I include copies of the presentation, a letter from President Reagan, details of the dinner and the extensive guest list, the originals of which I have available for presentation to The Prime Minister. I have been assured the President wishes to be in attendance this year.

I also enclose two memos from the 'Centre' to me, asking to be drawn to your attention about the forthcoming transatlantic Seminars on 'Ethics & Nuclear Arms', the first to be held in London in mid-May. It is planned to be helpful and relevant to our mutual defence debate concerns. I would draw your attention to the question raised in the 2nd memo and would appreciate any private advice so I may be helpful in return.

Echoing the appeal to The Prime Minister to speak out in America, I enclose an earlier communication from Mr. Dan McMicheal of the Scaife-Mellon Foundation (who with his colleague Mr. Richard Larry, in strictest confidence, through various channels have been the major source of funding for our "Coalition", and now my continuing Anglo-American work). It is significant to encourage the large private resources to carry on the good fight over here and for them to appreciate the issues and challenges of the forthcoming General Elections that must be won at all costs.

I have been working privately for sometime on this real peace project, and hope the enclosed letter from Micheal Deaver at The White House may introduce the second updated and complimentary proposal that I have also been entrusted to deliver a copy to you, and the original to The Prime Minister for your earliest consideration.

My close colleague Marc Nuttle, a primary consultant to the National Republican Party, was one of the key speakers at the successful conference organised by The Coalition last March, on new campaigning, fundraising and opinion forming techniques for the 80's. Mr. Nuttle is an 'insider' who comes with the highest contacts and recommendations. In his proposal, I particularly draw your attention to page 2 under heading "History - "at that time the idea was presented to the President and received a favourable response".

Further on, specific White House interest has been updated and now awaits a signal of favourable response on the possibility to proceed, so it can be pursued more officially with a direct communication from The President endorsing this private opportunity. The idea already has the support of Dr. Milton Friedman, Edward Noble and others, and whatever The Prime Minister or yourself wishes or requires can be so arranged, if she consents to come and perform this important mission.

I enclose a copy of the official invitation from the Private Enterprise Foundation, a background letter, details of a similar dinner/event for Dr. Friedman last year and full particulars of the individuals and organisations involved.

I would appreciate either being able to see you briefly, or in view of your schedule, perhaps being able to speak to you on the telephone (my number is 01-935 3521) before I leave on Sunday. Or thereafter I can be contacted at my Washington office, and would look forward to receiving some communication of interest on these two closely related proposals that I can pass on up. Meanwhile I would also like to have your recommendations on how the originals of these letters can be delivered or presented to The Prime Minister. I can return from Washington for a meeting within seven days if you should require additional briefing and information. Thank you for your time and consideration, and I trust this is all helpful.

Dear Prime Minister Thatcher:

As a private American citizen who has participated in the nuclear arms debate for more than two decades, I would like to urge you to consider a visit to the United States to make your views known on this crucial issue, even as you did in your singularly convincing presentation at the United Nations last June. The sheer clarity and honesty of your speech is an example of Churchillian statesmanship.

Please accept as a token of my appreciation for your wise and courageous leadership in the Western alliance, the inscribed copy of The Apocalyptic Premise: Nuclear Arms Debated. My co-editor and I decided to accord your U.N. speech the honor of being the final essay in the volume. We also quoted you in our foreword and on the dust jacket, the only one of the 40 contributors so featured.

I have long admired your candor and forthrightness. I recall vividly your presentation to the Washington Institute of Foreign Affairs here in Washington several months before you became Prime Minister. It is my good fortune to know many of the people who work with you in national defense and foreign policy, including Lord Chalfont.

Incidentally, permit me to say a good word about Mr. Leonard Holihan of Coalition for Peace, whose effective work in combatting the divisive propaganda of unilateral disarmers on both sides of the Atlantic deserves support. He has also had the courage to expose the influence of the Soviet Union within certain "peace groups."

It is imperative that Britain and the United States cooperate even more closely in the never-ending effort to achieve, as you put it, "peace with freedom and justice."

In this connection, the Ethics and Public Policy Center would appreciate your informing the new Minister of Defence, Mr. Michael Heseltine, about the nature and purpose of the seminar. We understand that Mr. John Gummer, M.P., has been assigned liaison functions with the churches. The seminar will presumably be of special interest to him.

It is our hope that the British Seminar, and the parallel ones in Germany, the Netherlands, and Washington, D.C., will contribute to deeper understanding of the issues now threatening to divide our undermine the NATO alliance.

Further details are given in the attached note on the seminars.

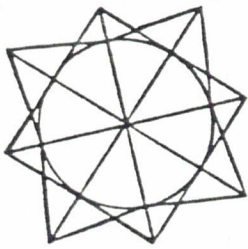
For public relations purposes, it is desirable that a share of the financial, logistical support for the seminars should be borne by an organization in the host country. We have been able to arrange for such shared support in Germany and in the Netherlands, but although our British co-sponsoring organizations are extremely cooperative in terms of time and personnel they are unable to provide any funds to cover hospitality and travel for British participants.

It would greatly improve the effectiveness of the seminar if we were able to announce that the expense was shared by some British source. Anything that you can do to make this possible will be deeply appreciated.

As you know, the seminar's importance lies in the opportunity it offers of improving understanding of the ethical and theological aspects of nuclear deterrence. The credibility of the speakers and of the whole proceedings may be jeopardized if the press is able to represent the occasion as entirely supported by American government funds.



PRINCETON, N.J. — British Prime Minister Margaret Thatcher and Mother Teresa of Calcutta top the list of women most admired by the American people.

The Nation's First Lady, Nancy Reagan, placed third in the 1982 Gallup Poll audit, followed by actress Jane Fonda, in fourth place.

Fifth-place honors go to the only newcomer on the list, Princess Diana, wife of Britain's Prince Charles. Television personality Barbara Walters is in sixth position, followed by Queen Elizabeth II, in seventh.

Rounding out the last three spots in the 1982 top 10 are former First Lady Betty Ford, eighth, U.S. Supreme Court Justice Sandra Day O'Connor, ninth, and Rosalynn Carter, the wife of another former President, in tenth place.

All but one of the 10 most admired women in the 1982 audit appeared in the 1981 list as well. As cited above, Princess Diana was in fifth place this year, but was not among the top 10 in the 1981 survey.

Absent from the 1982 top 10 was another former First Lady, Jacqueline Kennedy Onassis. As the wife of President John Kennedy and subsequently as his widow, Mrs. Onassis appeared in the top 10 in every Gallup audit from 1960 to 1981, a total of 17 times.

Receiving frequent mentions in the 1982 survey, but not included in the top 10, are (in alphabetical order): Chicago Mayor Jane Byrne, former U.S. Representative Shirley Chisholm, Indian Prime Minister Indira Gandhi, civil-rights activist Coretta King, and Mrs. Onassis.

These questions were asked:

"What women that you have heard or read about, living today in any part of the world, do you admire the most? Who is your second choice?"

Here are the 1982 results, based on first and second choices combined:

For the most part, men and women tend to admire the same individuals, but their ranking is frequently different. Thus, Princess Diana, Mrs. Ford, and Coretta King are among the top 10 choices of women but fare less well as favorites of men.

Appearing in the top choices of men, but not of women, are Prime Minister Gandhi, Mayor Byrne, and Miss Walters.

We would appreciate it very much if you would be able to be at our meeting on Monday, February 7th here in Washington at the Reserve Officers Association to assist in planning the overall anti-freeze Peace Through Strength effort. We will be discussing ways in which to join forces in order to have a much greater impact on the meetings of March 7 and 8, 1983.

I am also enclosing letters of endorsement for the Peace Through Strength resolution from President Reagan, Judge William P. Clark, Secretary Weinberger, John W. Vessey, Jr., Chairman, Joint Chiefs of Staff, and Assistant Secretary of the United States Department of State, Powell A. Moore.

We hope that this could be brought to the attention of the new Minister of Defense and the Prime Minister as a suggestion to establish similar resolutions in Great Britain.

With our groundwork and your pioneering conservative activism, we hope to accomplish a great deal in countering the forces both our countries face.

I am also aware of your worthy project to encourage Mrs. Thatcher that while on a visit to the United States, she would go to the heartland of America and deliver another Churchillian speech on this subject. This would rally conservatives and be both politically useful for the President and the Prime Minister.

This is in further reference to our discussion on the telephone the other day, relative to increasing the British presence in the United States.

It is more important these days than possibly anytime since the late 1930s. As you so well know, there is a tide of defeatism and fear (masked beneath the respectability of holy pacifism) sweeping not only Western Europe but, now, the United States.

If there is one blessing in all of this, it is that the philosophical underpinning of both the British and American administrations have much in common. Thus, each has both an unusual and timely opportunity to reinforce the other.

In short, we need some "heavy hitters" from Britain to visit some of the key high leverage areas of the United States to speak out not only about our common heritage but about our common struggle against tyranny.

As a case in point, supposing Winston Churchill could be persuaded to conduct a carefully constructed speaking and media tour of the United States? Considering what his grandfather did with the "Iron Curtain" speech of nearly 40 years ago, it is entirely possible that he could play both a dramatic and effective role in strengthening American resolve to resist the lures of defeatism. From what I have seen of Mr. Churchill (having met him casually several times) I know he would serve such a mission well, indeed.

And, of course, there is the Prime Minister. While she has visited Washington and New York, she has yet to visit the heartland. I think this is too bad for two reasons. The first is, I think she would be absolutely thunderstruck at the similarities in temperament and philosophy between her and heartland America. Secondly, because of the similarities in chemistry, I believe Mrs. Thatcher could help alleviate the sense of desolation and despair which many middle-Americans feel these days as they see themselves more and more isolated by the enveloping clouds of neutralism and vacillation.

When I talk middle-America, I am thinking more about temperament than geography. Thus, cities such as Boston, Pittsburgh, Chicago, Denver, San Francisco, Los Angeles, Dallas-Houston, Kansas City, and Atlanta are what comes to mind. Not that either Mr. Churchill or Mrs. Thatcher could visit all of these places but, at least, some.

Of course, were such visits to be scheduled, I would push very hard to include Pittsburgh in both cases. Our sister city is Sheffield (indeed a Pittsburgh delegation was in Sheffield just days before the destroyer was sunk). We are the third largest corporate headquarters in the United States. We have a World Affairs Council here that in many respects, at least, is regarded by many as the best in the nation in terms of its impact and outreach to young students. The enclosed background information speaks for itself.

Beyond this, you already are familiar with a number of institutions across the United States who could be brought into play to structure a truly effective speaking tour, ranging from major policy addresses to well organized private off-the-record sessions with some very key people.

If you think well of these notions, perhaps you could get a reading as to whether or not any of this would be possible.

By the way, I was with our Deputy U.N. Ambassador, Kenneth Adelman, on Monday, who was in Pittsburgh discussing the current disarmament doings at the U.N. He speaks very highly of you.

Nuclear Freeze Fairness Report

Dear Mr. Holihan:

The Fairness Committee has been set up by leading Conservatives to provide an umbrella for a variety of organizations interested in the serious problems of government subsidies to political groups. As Executive Director of the Fairness Committee, I officially confirm my invitation for you to be the Chairman and Chief Organizer responsible for the 'Nuclear Freeze Subcommittee'.

The purpose of this important new organization would be to lead the fight against the so-called 'peace movement's' Nuclear Freeze, by bringing together an active coalition of all other groups and key individuals concerned with countering this current psychological "war called peace". I note that under your guidance, this committee already has involved over 35 organizations who have a combined membership of several million people across the nation. In addition, you have the active participation of a number of Senators and Congressmen, as well as a liaison with the National Security Council and other excellent contacts at the White House.

I would hope you can extend this high level interest and cooperation to the organizations in Britain, and particularly the new Minister of Defense, Mr. Heseltine, whom I understand is very concerned about C.N.D. It was the C.N.D. U. S. Peace Tour led by Monsignor Kent, that you effectively warned us of and countered, that none the less catalyzed the Freeze here.

I'm sure that by working together we can prove U. S. 'Peace' funding goes back to Britain, and stop it; as we recently learned the movement here has raised over \$20 million dollars and is very 'international' in its outreach. Also I learned from you that in mid-February, CND and its fellow traveler END are holding a conference with the leaders of the American Nuclear Freeze Movement in Bradford, England to coordinate the allied assault in exporting the latest U.K. developed techniques of Direct Action, Civil Disobedience, and breaking the law for 'peace'.

Your organization then, is to produce a coherent overall strategy and coordinate effective information gathering, and take the actions to 'defrost' this dangerous unilateral freeze. As an adjunct of the Fairness Committee, we are to particularly 'defund' this movement wherever public money is being misused to support it. The fact that vast amounts of Federal funds actually wind up supporting various special interest and 'peace' groups programs not only in this country, but overseas as well,

should wake up many people with righteous indignation.

In these times of grave legitimate budgetary and fiscal concerns, the shocking scandal of any tax dollars raised for the Government, to secure the security of this great nation and her allies, being bled off for unquestionably one-sided political activism must be honestly recognized, exposed and stopped. Once this thought is put in the public's mind, the simple straightforward financial reality of actually paying for these 'peace campaigns' to any degree with publicly entrusted funds will ring as unsound, unwise, and unsavory.

Conscience, and sound financial responsibility demands an end to the 'peace pork barrel' giveaway of Federal funds to the few. Our Constitution and Bill of Rights guarantees the rare privilege of free speech for our opinions, but does not condone pick-pocketing the public's purse in the name of 'peace' propaganda, or on any other such controversial issue.

The overwhelming majority of our sensible fellow citizens, once they fully realize the extent of the shameful abuse, simply will not stand for these absurd special interest subsidies that have gradually infiltrated our system.

In fact, it can be reasonably argued these misplaced and generally unaudited grants actually undermine our national security, and that of our allies in NATO, while encouraging our enemies. As you have summed up, "It's not enough the 'peace' campaign is led by the 'Reds', but now we discover it's funded by the 'Feds'."

Only a week ago, the President's promise to begin to correct this situation surfaced with the new rules proposed by the Office of Management and Budget under David Stockman, to prevent use of Federal funds for the whole range of 'political advocacy'. I include the revealing article that is a breakthrough and golden opportunity for our whole Fairness program. OMB wants to meet with us and encourage our implementing their policies, particularly against the Freeze. I'm sure this will have wide implications on both sides of the Atlantic, and hope it encourages our British colleagues to also examine where subsidies might inadvertently be occurring, and turn off the spigots. I note your news of the public outcry in England over the state aid given for 'homeless unemployed' women at Greenham Common, paid for by the rate payers; and the quarter million pound budget by the Greater London Council to be wasted on its 'peace year' ploy.

The great advantage of the "Fairness-defunding" approach to your defense cause is that while a lot of people are basically unconcerned or bewildered by the strategic, technical and moral arguments of the one-side disarmament campaigns, they will definitely stand up and really protest when they learn that they have been duped into paying for it.

Beyond the Freeze issue, this reaches people where they feel it the most, in their pocket-books. And politicians, whether they are for or against the West disarming first, will find it politically embarrassing to advocate or allow the public to 'foot' the bill. So it is truly a

"double-edged sword" the Fairness Committee is offering to you in this fight, to help redress the imbalance, where the adversary seems to have taken all the initiatives, and possesses almost unlimited funds.

There is one other point in your behalf I would like to stress, that of coordinating the various segments in anti-unilateral freeze and pro-freedom work. All too frequently our own groups rising to these 'peace' problems are not having any real impact against the well orchestrated, funded, and International tidal wave of Western disarmament campaigns awash in Britain, Europe, and now here. The various conscientious private concerns often duplicate efforts, or leave other whole areas unguarded, or unique opportunities to strike back untaken, or concentrate overly on fundraising and not on achieving real results.

The urgency of this chilling challenge to our society and all our allies, demands bold initiatives, and dedicated, resourceful, and experienced leadership. For these reasons, I have called upon you and appreciate the sacrifices this means to you both personally and professionally. I also recognize that you have consistently spent your own and U.K. corporate funds in this Anglo-American fight.

I can offer you full access to office facilities and some resources when you are here, and will continue to work with you on how our "Real Peace Project" can secure a bigger fighting fund, either from my sponsors, our participating groups, through direct mail or by going directly to the few involved foundations for your work. I appreciate the cost of your many trips and that you currently draw no salary for your unselfish and sometimes unknown efforts.

In addition, I urge you to set up special projects sub-groups that can concentrate on particular freeze problem areas, such as the church, professional groups, and the media. I agree we should take on another full-time person as your day-to-day executive here, and get some additional researchers now that the Committee is well on its way and there is so much work to do. I acknowledge your choice of Anne Hurd's volunteer services as Secretary/Treasurer. She has been very helpful and I hope she can soon join the team, as I know your counter freeze and information gathering projects urgently need more full time people under your guidance.

I, meanwhile, will do all I can to facilitate and encourage your work, both here and back in Britain, since you have predicted and proved the continuing connections between CND and the movement here, and particularly in view of the forth-coming U.K. general elections, poised on the 'peace issue'. It is vital to Conservatives here and the Reagan administration that the Thatcher government overcomes the pacifists by winning significantly, and is able to deploy the cruise.

So your unique Anglo-American work is crucial and continues to be a catalyst for us here, and significant in raising most of the funds for your British ongoing activities against CND. I and my board hope your new position will be helpful, and you are able to let the right people over there know of the progress and possibilities.

One last point, I know that you have been working discreetly for

some time to get the Prime Minister, Mrs. Thatcher, and Winston Churchill, M.P., or possibly now, the new Minister of Defense, Michael Heseltine, to come over to the U.S. or while here on other business, and give a stirring and strategic 'heartland' speech to counter the one-sided disarmament hysteria. Besides hitting the Freeze between the eyes, this would rally conservatives, and remind people in both countries of the allied bond, and what is really at stake as we face the encroaching Soviet threat.

I can only applaud your far-sighted strategy, and echo my keen support along with others here, that it would be politically useful for both the President and the Prime Minister in the course of real peace with justice.

Meanwhile, I look forward to the U. S. Premiere of the film "Who Dares Wins" and its message that you brought to the attention of the President and many other key people in Washington. I agree with you, it will be one of our best shots in this fight before the widest audience, particularly powerful if followed up as planned. Again, I hope your Chairmanship of the Nuclear Freeze Fairness Committee will facilitate this, and I look forward to working closely with you.
