MEMORANDUM FOR ASSISTANTS TO THE PRESIDENT

FROM: MICHAEL K. DEEVER 
SUBJECT: Republican National Convention

This is directed to the members of your staffs attending the Republican National Convention as well as those already in Dallas.

As I am sure you are aware, many members of the staff are already in Dallas, with many more to soon join them. Therefore, you should be prepared for the fact that resources will be limited and many accommodations, which we have come to expect, will not be available.

Specific information and details will be provided to staff members by the Advance Staff upon arrival in Dallas. For those staff members already in Dallas, a memorandum will be distributed to hotel rooms Sunday evening.

TRANSPORTATION: Motorpool vehicles will be very limited in number. Staff members should plan on utilizing a shuttle system which will run between the Convention Center, the Hyatt Reunion (RNC Headquarters) and the Anatole Hotel. A limited number of vehicles will be available for senior staff use; those with access to this pool will be notified directly. All staff members should plan on finding their own means of transportation to and from personal appointments and private activities.

ACCESS: Staff access to Presidential events will be on a case-by-case basis. For example, some staff seating will be provided at the Prayer Breakfast, but most staff members should plan on purchasing tickets to that event if they care to attend. Staff members other than occupants of Control and Support cars will not be transported in Presidential motorcades. Any shuttle transportation to events will be announced.

HOTEL ACCESS: Access to the Tower of the Anatole will be limited. Access to other portions of the hotel will be unlimited, except in those areas where the President or other protectees might be attending an event at any given time.

Access to the Tower where the White House Staff will be quartered will be granted by displaying one of the following:

1. White House Pass
2. Traveling Staff or Guest Pin
3. Room Key (for Tower room numbers only)
4. Reagan-Bush Convention ID which you should now hold

Additionally, persons holding one of the above can escort a guest or appointment into the Tower by meeting that person at the security points and walking him/her into the secured area. As in the case of a West Wing appointment, the staff member who escorts the guest through security will take responsibility for remaining with that guest and for seeing that the guest leaves the Tower upon completion of his/her business.

Keys and registration cards for White House Staff arriving prior to August 21 will be in vehicles upon pick-up at the airport. White House Staff arriving August 21 can pick up room keys at the Tower Concierge area. All registration cards must be signed and returned to Brenda Riley (White House Advance Staff Office) in the Topaz Room.

Staff should be reminded to pay all incidental charges on departure from the hotel.
