A couple of additional thoughts for your consideration.

- 1. Jewish Voters As a result of the Jackson situation, we have a unique opportunity to win over Jewish voters who traditionally vote Democratic. We need to move quickly because the Democrats will try to repair this damage after the Convention. I suggest we try to get a number of our own Jewish supporters to contact major Jewish Democrats. The goal should be an effort within a "Democrats-for-Reagan" format, but starting with two or three announcements of major contributions who are supporting Reagan this time.
- 2. Women Voters In order to show support among women for the President, I believe it would be possible to have 6 8 womens' events in major cities on the same day. The events should be sponsored by private sector women who issue invitations to other private sector women to a meeting on why "you are better off today" because of Reagan policies.
- 3. Surrogates Although we have talked about some activity during the first two weeks of August on the theme of a do-nothing House of Representatives, this will essentially be vacation time for the President. This means we should get commitments now from major surrogates who can be active during this period. The Olympic games will take most of the TV and news coverage, but we shouldn't count on it. A surrogate program, including the V.P. as a follow-up to the do-nothing House should be organized now.
- 4. Mrs. Ortega We should plan a White House group review of the progress of Mrs. Ortega including tapes of her recent speeches. She cannot appear to be a token vs. Cuomo.

5. Senator D'Amato - Carefully schooled, the Senator could be a good person to put out front vs.

Mrs. Ferraro. He is Italian, Catholic, and the Senator from N.Y. He also has the most to lose from her ascendency in that even if Mondale loses she could be positioned to run against D'Amato. Particularly on her liberal record, pro-abortion and anti-defense spending he could be effective.

Reagan-Bush '84 is requesting your approval on the attached letter from the President to Mr. Sam Walton, Chairman and Chief Executive Officer of Walmart, Incorporated. Mr. Walton is a strong supporter of the President.

Mr. Walton contacted the campaign to ask for this letter to promote the nonpartisan voter registration activities of his company. He plans to write to approximately 75,000 of his employees, most of whom live in the mid-South, enclosing a copy of the President's letter and urging their participation in a voter registration program which he plans to implement.

Walmart, Inc. serves a 19-market area. Data developed by Walmart's Government Affairs Division projects at least 20,000 newly registered voters. About 65% of these are expected to be pro-Reagan.

Additionally, Walmart proposes to utilize county registrars in targeted rural areas. A majority of its 700-plus stores are now being selected for such programs, with an eye towards maximizing conservative voter registration.

We cannot afford to let that happen. We must be sure Walter Mondale, Ted Kennedy and Jesse Jackson are not given the chance to destroy all the progress we have made these past four years.

We both have a tough fight on our hands. That is why we must do everything we can to reach out to as many voters as possible.

Bill, I can't emphasize enough how critically important your leadership has been -- and will be -- to the economic prosperity, development and growth for the people of Colorado -- and the nation.

Let us work together to ensure victory in November -- and a better future for all America.
