SUBJECT: Trudeau-Reagan Differences at Summit

The media has reported that a "Senior American Official" present at the Summit meetings indicated that the President and Prime Minister Trudeau exchanged sharp words during a debate over East-West issues.

State indicates that a Canadian newspaper, the Ottawa Citizen, has identified Secretary Donald Regan as the individual who provided the information. The Canadian report (Tab A) goes beyond previous reporting in the Times and Post in describing the degree of hostility exhibited and is much more precise in quoting the official. It is not clear whether Secretary Regan, if he did provide the information, thought he was on background.

Prime Minister Trudeau has labeled the reports as "damn lies." State and I have recommended that we avoid comment on the reports to the extent possible, but I have asked them to prepare contingency press guidance.

Trudeau, Reagan in angry exchange over Soviet talks

Canadian news agencies

Prime Minister Trudeau arrived back Sunday from the London economic summit to a report that U.S. President Ronald Reagan blew up at him during a heated debate on relations with the Soviet Union.

U.S. Treasury Secretary Donald Regan was quoted as telling reporters in London that the American leader took off his glasses and said: "Damn it, Pierre... What the hell more can I do?"

At Uplands Airport, Trudeau did not dispute the reported statement, but might he told Reagan: "For heaven's sake, Ron, do a bit more."

Asked by a reporter whether Reagan gave him a "dressing down," the prime minister replied: "Tell them (U.S. officials) they are liars."

Trudeau acknowledged there were a lot of arguments among summit leaders, but indicated he held his own.

The treasury secretary described Trudeau as the odd man out on discussions over East-West relations during the seven-nation summit that ended Saturday.

Trudeau has been waging a personal campaign since the fall to try to improve the dialogue between the West and the Soviet Union.

And, as expected, he took that drive to the meeting rooms of the summit leaders.

By Reagan's account, Trudeau's

remarks were not well received by the others. The official said:

"He was way out. He was old hat out. Even (French President Francois) Mitterrand wouldn't agree with him."

"On East-West relations, (Trudeau) thought the United States was wrong and that we should be more forthcoming."

The president did not agree, Reagan said.

Reagan took off his glasses and said, "Damn it, Pierre, I have said everything. We have covered empty chairs... What the hell more can I do to get those guys back to the table? You're asking me we haven't done it."

At the initiative of Trudeau, the leaders issued a statement on East-West relations that says they are determined to seek dialogue with the Kremlin, especially through arms control negotiations.

At his post-summit news conference in London, Trudeau said he welcomed the "important change" in tone of East-West relations, especially by British Prime Minister Margaret Thatcher and Reagan.

Last year, Thatcher was "one of the liars," said Trudeau. "Now she speaks of dialogue."

ing. In a speech in the Irish republic last week: "A nuclear war cannot be won and should not be fought."

Trudeau conceded the shift since last year was "not as dramatic as I was fighting for when I began (the peace initiative) last September but certainly very noticeable."

While Trudeau declared himself satisfied with the final wording of the communique, Britain, West Germany and the United States had all demanded alterations of Trudeau's first draft which they found too soft.

Thatcher and Reagan insisted on a reiteration of western solidarity and a needling reminder that it was the Soviet Union that broke off arms talks, said Canadian and British officials.

West German Chancellor Helmut Kohl, after facing bitter domestic dissent over last year's NATO deploy-

ment of new U.S. medium-range nuclear missiles in his country, balked at any inclusion of a clause saying nuclear war could not be won.

But the concluding paragraph was essentially Trudeau's. It read: "We believe that East and West have important common interests preserving peace; in enhancing confidence and security; in reducing the risks of surprise attack or war by accident; in improving crisis management techniques and in preventing the spread of nuclear weapons."

Reagan held a brief post-summit news conference Sunday before flying to Washington, but did not mention the reported clash with Trudeau. However, he said he thinks Soviet leaders will start talking to him again if he were re-elected in November.

Treasury Secretary Regan said the Canadians and French opposed issuing the summit's declaration of democratic values because "they don't want to... have the East upset on what the West is saying and to raise the noise level any decibels more."

In Ottawa, External Affairs official John Noble said that as far as Canada is concerned: "That is an absolute

lie..." Canada supported the declaration.

The declaration reaffirms the summit leaders' commitment to the values of the democracies they govern and rejects the use of force as a way of settling disputes.

The official said Thatcher wanted the declaration and she was backed heavily by Reagan.

"Reagan," the official said, "thought it's high-time we in the western world put out a manifesto on what we do believe in."

At his London news conference, Trudeau suggested the declaration was a timely joint statement by former enemies of the Second World War.

Coming immediately after the 40th anniversary ceremonies marking the Allies' D-Day landings in Normandy, Trudeau said: "It was perhaps a good idea to make it quite clear that it was 40 years ago."

"We've come a long way" since Germany, Japan and Italy "were our bitter enemies," he added.

Still the prime minister acknowledged that the statement was "full of clichés and banalities."

Since our morning discussion, I have spoken with Jim Emery, the Seaway's U.S. Administrator, and Cary Brick, Congressman Martin's AA. Both assure me that the Seaway Corporation is eager and ready to sponsor a U.S. rededication ceremony on July 17, once the White House gives the green light. Brick told me that Jim Baker had spoken to Congressman Martin within the last few days to say Presidential participation is under active consideration. Brick has been told to keep a "tight lid" on this information. I also reinforced this latter point.

In response to your two memos regarding possible meetings between the President, the Queen and the Canadian PM, State informs you that it is not clear if the Queen will actually come to Canada nor is it known when Turner will call elections. I found out subsequent to State's dispatch of this memo that it now appears that the Queen will not, in any case, be participating in any St. Lawrence Seaway ceremony on July 17.

Per your verbal instructions, I have directed State not to proceed with any direct interventions until the situation becomes somewhat less murky.

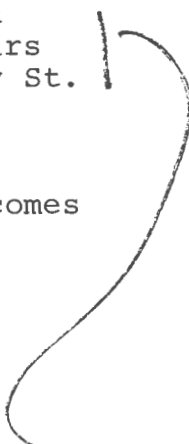

Subject: Possible Meeting With Queen and Canadian Prime Minister in July

With reference to Robert Kimmitt's memorandum of June 21, we propose to follow a two-track approach. Ambassador Robinson has already discussed with Prime Minister-designate Turner the possibility of an invitation to President Reagan to come to Canada during the Queen's visit. Turner would be delighted to do this but cannot at present for two reasons: (a) he does not assume office until the end of this month, and (b) he may well decide in early July to call new elections for late this summer, in which case the Queen will probably call off her visit. For Turner to respond to our request now would tip his hand regarding his election plans. He is understandably reluctant to do this.

While we await resolution of the Canadian problem, we believe that it would be worthwhile to approach the British informally concerning the possibility of the Queen's coming to a U.S.-sponsored event associated with the 30th Anniversary of the St. Lawrence Seaway project. The new Canadian Prime Minister could of course be invited, and it is our judgment he would almost certainly attend.

For the moment we recommend that the July 17 date be reserved on the President's calendar.

SUBJECT: St. Lawrence Seaway's 25th Anniversary Celebration

As we discussed, we are interested having Queen Elizabeth II participate in a ceremony with the President and the First Lady in the United States on July 17, 1984 to celebrate the 25th Anniversary of the St. Lawrence Seaway. This would be a rededication in the tradition of the initial dedication in 1959 when Queen Elizabeth II met with President Eisenhower in Montreal and with Vice President Nixon in Massena, New York.

We understand that the Queen will be in Canada during this time. Although we would prefer a ceremony to be held on July 17, if the Queen's schedule would prevent her from participating on this date, we would be happy to discuss alternate dates. The issues that need to be resolved are selecting the exact date and location and deciding who should issue the invitation to the Queen.

Pope, Queen To Touch North

Diocese Has 2,000 Tickets

OGDENSBURG — As the itinerary for a papal visit takes shape, more than 2,000 tickets have already been issued by the Diocese of Ogdensburg in anticipation of Pope John Paul's Canadian tour Sept. 9-19.

But demand in the northern section of the state may be double or triple that number, according to Msgr. Anthony A. Milia, pastor of St. Anthony's Church, Watertown. Monsignor Milia, who is coordinating participation in the western section of the diocese, estimated Monday that "anywhere from 5,000 to 7,000 people" from Watertown to Plattsburgh may travel to Ottawa and Montreal to hear the Pope say Mass.

The area's delegation, Monsignor Milia said, will include Bishop Stanislaus J. Brzana, the estimated 175 priests of the diocese, other members of the clergy, and lay people.

Already, arrangements are underway for 10 to 15 buses to carry 400-600 people to Ottawa from the Watertown area, while individual parishes are making similar plans, Monsignor Milia said. The eastern portion of the diocese, where Msgr. Morris L. Dwyer, St. John's Church, is coordinating travel, will send its own delegation to events in Montreal.

National organizers of the papal visit in Canada are hoping to avoid border stop crunches through early arrivals, said Richard A. Findlay, coordinator of logistics. Mr. Findlay pointed out the Ogdensburg diocese is not the only one taking part in the event: from Burlington, Vt., 40 buses have been reportedly chartered to bring an estimated 1,600 people to Montreal.

To relieve the traffic jams, Canadian organizers are urging U.S. visitors to arrive at least a day early, and churches on both sides of the border are being "paired" to help participants find lodging, parking and local transportation on a more individualized basis.

Royal Itinerary Firmed Up

Final plans were being firmed up Monday for Queen Elizabeth's and Prince Philip's two-week visit to Canada, which includes a stop at Cornwall, Prescott and Kingston.

The royal party will leave Great Britain and will land at Moncton Airport in New Brunswick July 14. The queen and prince will make short trips in New Brunswick for two days before arriving in Ottawa by airplane at 1:45 p.m. July 16.

The royalty will spend the afternoon in Ottawa at Parliament Hill and will visit Rideau Hall, the home of the Governor General Jeanne Sauve, before arriving at Chrysler Park Marina in Morrisburg at 7:10 p.m.

Queen Elizabeth and Prince Philip will be picked up by the royal barge and will be delivered to the majesty's yacht Britannia where they will spend the evening.

On Tuesday, July 17 the Queen will arrive at the Cornwall Civic Complex at 11:05 a.m. and will walk to Marina 200 to unveil a plaque for the new park at 11:35 a.m. At 11:55 a.m. she will arrive at Trinity Anglican Church in an open car escorted by Royal Canadian Mounted Police. At 12:40 p.m. she will board the royal train and arrive in Prescott at 2:30 p.m.

A tour of Fort Wellington is planned before the Queen and Prince Philip board the train at 4:00 p.m. and arrive at the Kingston Railway Station at 5:50 p.m. At 6:15 p.m. the royal couple will arrive at Amherst View, a small community 10-miles west of Kingston, to officially open the Loyalist Parkway (Highway 33). She will then walk through the Henderson Farm and see a display depicting Ontario's farming industry and will visit Fairfield White House, a historic home, at 6:55 p.m.

At 7:20 the Queen will visit the nearby Royal Mohawk site for a re-enactment of the landing of the loyalist Mohawk Indians.

The Queen will spend the night on Lake Ontario, aboard the royal yacht anchored at Fairfield Park. Motorists traveling Bath Road will get a glimpse of the yacht at anchor.

Plans are not complete, but Wednesday, July 18 is a scheduled day of rest for the royal passengers. The yacht is expected to leave Kingston the evening of the 17th or the early morning of the 18th.

It will arrive in Toronto sometime Wednesday morning. The Royal Couple will be making day trips throughout Ontario and will return to Toronto before leaving the country July 27. The queen will return to England and the prince will travel to Los Angeles, Calif., where he will take part in the opening ceremonies of the Summer Olympic Games.

The Britannia, with her navy blue hull and cream-colored decks, is expected to leave Cornwall in the late morning of July 17 and will travel the main shipping channel up river in the daylight hours.

When the Royal Couple traveled the St. Lawrence River 25 years ago to officially open the St. Lawrence Seaway, crowds gathered along the Brockville waterfront to wait for the arrival of the yacht and to watch the Queen and Prince Philip come ashore.

After a trip through the city in a limousine, the royal couple returned to the Britannia where they spent the night anchored off Brockville.

US, Canada set to rededicate Seaway

With considerable pomp and ceremony, the \$500 million, 400-mile St. Lawrence Seaway was dedicated on June 26, 1959, by Queen Elizabeth II and President Dwight Eisenhower at Montreal.

The Queen called the Seaway "one of the outstanding engineering achievements of modern times," and the President hailed it as a "magnificent monument to the enduring friendship of our two nations and to their partnership in the development of North America."

The Queen and Prince Philip and Ike and Mamie Eisenhower took a much-photographed sail on the royal yacht as it passed through the St. Lambert Lock and cruised for five hours.

Another impressive event took place the next day: In a double-header ceremony Queen Elizabeth and Vice-President Richard Nixon dedicated at Massena, N.Y., the two US-built Eisenhower and Snell locks and the \$650 million St. Lawrence power project.

Twenty-five years later another ceremony of somewhat less pomp will take place on June 27, 1984, at Massena, where officials of both nations will rededicate their ambitious joint venture and perhaps reflect on both the achievements and disappointments their long-delayed and still somewhat unfulfilled project engendered.

No royal yacht or heads of state are expected to be present at this year's event, but the US Coast Guard Cutter Chase will be on hand to accommodate ceremonial sails by a US delegation headed by Transportation Secretary Elizabeth Dole and an anticipated Canadian contingent of ministerial rank.

Much water has spilled over the hydroelectric power project's dams and through the two US and five Canadian locks of the Seaway since those original dedication ceremonies.

That the Seaway was built at all as a joint venture was something of a miracle. Although the idea for a "seaway" dates back to 1892, when Minnesota Congressman John Lind sponsored a resolution calling for a joint US-Canadian investigation into its

feasibility, the project suffered a long series of setbacks, particularly in the United States.

Opposition by the railroads and the ocean ports was determined and well financed, and it helped hand the project some stinging legislative defeats in Congress in 1918, 1934, 1942, 1944, 1948, and 1952, despite endorsements by a series of US presidents.

But the proponents would not give up, and they were helped in the 1950-60 decade by two developments. Canada — which had taken some backward steps in 1914 and 1922 and "procrastinated" on the project from 1920 to 1930, according to one historian — finally issued an ultimatum: If the US continued to block a joint project, Canada would construct the project on its own.

Eisenhower's secretary of the Treasury, George Humphrey — who in private life headed the Hanna Mining Company, which was interested in cheap transportation of iron ore — lobbied effectively for the measure. The combination of prospective loss of any US control over the project plus the determined backing of the Eisenhower administration changed enough votes so that in 1954 a Seaway bill passed Congress by a two-vote margin in the Senate and 241-158 in the House.

Thus the Seaway became a reality, an economical transport system that can move a ton of freight over 500 miles on a gallon of fuel. To match this, railroads would have to more than double their fuel efficiency, says a descriptive booklet issued by the St. Lawrence Seaway Development Corporation of the US Department of Transportation. "By its very existence," the booklet says, "the Seaway holds down rates charged by competing transportation systems. This results in significantly lower costs to users and consumers."

But even the Seaway's most enthusiastic backers admit that the first quarter-century of the St. Lawrence Seaway has been marked by a struggle to cope with a series of largely unforeseen problems.

In the final haggling in Congress over Seaway legislation,

The St. Lawrence Seaway's 25th Anniversary celebration this year presents the President's campaign with several excellent media and political opportunities. I am writing to advise you and other appropriate campaign officials of these opportunities and of my eagerness to cooperate with you in any way. Here are the most attractive options as we see them:

First, Queen Elizabeth of England is scheduled to be in Canada in the Seaway region in mid-July. Due to political turmoil in Canada her itinerary is in a state of flux. However, we feel it would be appropriate for the President to invite the Queen to join him in visiting Eisenhower Lock in Massena, New York to commemorate her opening of the Seaway with President Eisenhower at that site 25 years ago. 
Third, we would be happy to make arrangements for the President to preside at a Seaway Anniversary event/rally at one of the interior ports such as Chicago, Detroit, Cleveland, Toledo, Milwaukee, etc. The Seaway generates \$3 billion in economic activity at these ports each year. We could attract major industrial, labor, agricultural and maritime interests from throughout the Great Lakes system to this event.

In conclusion, Roger, I cannot stress strongly enough the visibility and public interest which the Seaway offers throughout the Midwest as reflected in the attached clip sample. This is particularly true in the contiguous states of Minnesota, Wisconsin, Illinois, Michigan, Indiana, Ohio, Pennsylvania and New York which together account for 161 electoral votes. The President's identification with the Midwest through the Seaway would help offset Mondale's roots in this region.

Also, key Senate races would be helped by a Seaway initiative, including Senators Boschwitz in Minnesota, Percy in Illinois and Lousma's candidacy in Michigan.

I am prepared to move immediately on any or all of the above.

The Seaway Act authorized U.S. participation in the navigation project and established the Saint Lawrence Seaway Development Corporation as the U.S. agency to work with a Canadian counterpart (the St. Lawrence Seaway Authority) in the construction, operation, maintenance and development of the water route. The legislation also contemplated that the Seaway would pay its own way through joint U.S.-Canadian tolls for transit of the Seaway.

From 1954 up until early 1959, most of the Seaway Corporation's activities were concentrated on building the U.S. portion of the Seaway between Massena, New York, and Lake Ontario.

The approximate cost of the navigation project was just over \$470 million, of which Canada paid \$336.5 million and the U.S. about \$133.8 million. (The power portion of the project cost some \$600 million and was shared equally by the two nations.)

On September 24, 1954, the Seaway Corporation, then under the direction and supervision of the Secretary of Defense, designated the U.S. Army Corps of Engineers as design and contracting agency for the U.S. project. Actual construction began in January 1955. In 1956, the Congress approved \$256.9 million for the Corps to deepen Great Lakes connecting channels to 27 feet, thereby opening the port cities of the Great Lakes to deep draft ocean commerce, turning them into true world ports.

A year before the Seaway opened, in 1958, the Seaway Corporation was transferred from the Department of Defense to the Department of Commerce. Six months later, on January 29, 1959, the U.S. and Canadian Seaway entities entered into their first joint agreement on tolls. Toll was levied both on St. Lawrence River locks and the Welland Canal, with a 29%-U.S., 71%-Canada division of St. Lawrence River revenues. The split was based upon the anticipated costs to be borne by each nation in the construction of the Seaway. Welland Canal tolls were not shared, and were suspended in 1962.

Deep-Draft Shipping Begins

Although the Seaway was officially dedicated on June 26-27, 1959, in Montreal and Massena, New York, the waterway was actually opened to traffic some three months earlier, on April 25—to iron out whatever “kinks” might exist in the complex system of locks before it officially came into existence. Included among the dignitaries at the opening ceremonies in June was Her Majesty Queen Elizabeth II representing Canada, and U.S. President Dwight D. Eisenhower and Vice President Richard M. Nixon.

Tonnage through the new Seaway in its first year was 18.7 million metric tons. It topped 20 million in 1961; 30 million in 1964; 40 million in 1966; and 50 million in 1973.

In October 1966, the U.S. Department of Transportation was formed and the Seaway Corporation was brought under the policy direction and supervision of the Secretary of Transportation. Canada initiated toll negotiations shortly thereafter, with the outcome that tolls were not increased on the St. Lawrence as Canada had desired, but the Canadian revenue share on the St. Lawrence was increased from 71% to 73%. The U.S. also agreed to a lockage fee assessment on the Welland. This Welland income was retained by Canada.

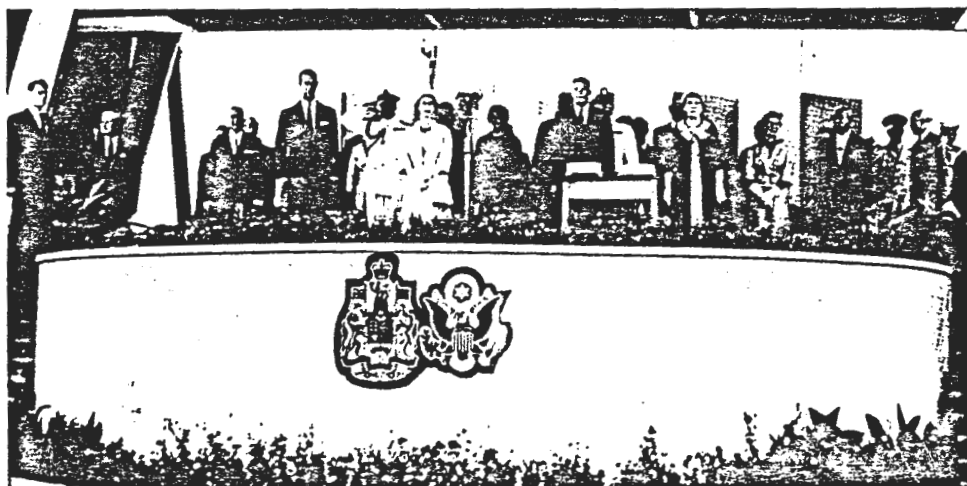
The Merchant Marine Act of 1970 relieved the Seaway Corporation

of the requirement that it pay interest on its construction debt, and established seacost status for the entire system. For the time, the Great Lakes-Seaway system was given equal status with other coastal ranges and/or maritime regions in the nation.

Later that year, the Rivers and Harbors Act of 1970 created the “Great Lakes-St. Lawrence Seaway Navigation Season Extension Demonstration Program.” This gave impetus to an 8-year effort which established a multi-agency Great Lakes/Seaway Winter Navigation Board to investigate the economic benefits and engineering feasibility of extending the shipping season in the system.

During 1976, Canada had again initiated talks concerning toll increases and on March 20, 1978, the U.S. and Canada exchanged diplomatic notes formalizing a new tolls agreement which restored the original St. Lawrence revenue split and incrementally raised tolls over a three-year period on both the St. Lawrence and Welland Canal (tolls replaced lockage fees on the Welland). This was the first toll increase since the Seaway opened.

The Seaway today is an important part of the Nation's transportation plan. It welcomes new challenges and opportunities with an enthusiasm born of struggle and matured by an ability to get things done. ■

Queen Elizabeth To Visit Prescott

Britain's Queen Elizabeth and Prince Philip will make a stop in Prescott, Ont. next summer as part of a two-week Canadian tour to mark bicentennial celebrations in the Provinces of Ontario and Manitoba.

The royal couple will visit Ogdensburg's Canadian neighbor the afternoon of July 17 as part of Prescott's Loyalist Days, which will be held July 14-22.

"It's really fortunate they are coming at that time because that's when when we have the Loyalist Days military pageant," said Marion Preston, chairman of Prescott's sesquicentennial celebration.

The Grand Encampment of the Brigade of the American Revolution will be staged then, which attracts thousands of visitors every year.

"With the royal couple visiting, I'm sure will have many more visitors from both sides of the border at that time," Miss Preston said.

Queen Elizabeth and Prince Philip will start their Canadian tour July 14 in New Brunswick and will be in Ottawa July 16 to begin the Ontario tour.

The royal couple will spend the night of July 16 aboard the Royal Yacht Britannia near Morrisburg and will travel by motorcade to Cornwall the morning of July 17. They will travel to Prescott by train shortly before noon.

"We learned officially that the Queen and Prince were coming this week," Miss Preston said. "I may be naive, but I really had no doubt the Queen would come since she is going to be Ontario during this time."

While Ontario is marking its 200th year, the communities of Cornwall, Toronto, Brantford and Prescott are noting their 150th years.

The royal couple's visit also will coincide with the 25th anniversary of the St. Lawrence Seaway.

Pope, Queen To Touch North

Diocese Has 2,000 Tickets

OGDENSBURG — As the itinerary for a papal visit takes shape, more than 2,000 tickets have already been issued by the Diocese of Ogdensburg in anticipation of Pope John Paul's Canadian tour Sept. 9-19.

But demand in the northern section of the state may be double or triple that number, according to Msgr. Anthony A. Milia, pastor of St. Anthony's Church, Watertown. Monsignor Milia, who is coordinating participation in the western section of the diocese, estimated Monday that "anywhere from 5,000 to 7,000 people" from Watertown to Plattsburgh may travel to Ottawa and Montreal to hear the Pope say Mass.

The area's delegation, Monsignor Milia said, will include Bishop Stanislaus J. Brzana, the estimated 175 priests of the diocese, other members of the clergy, and lay people.

Already, arrangements are underway for 10 to 15 buses to carry 400-600 people to Ottawa from the Watertown area, while individual parishes are making similar plans, Monsignor Milia said. The eastern portion of the diocese, where Msgr. Morris L. Dwyer, St. John's Church, is coordinating travel, will send its own delegation to events in Montreal.

National organizers of the papal visit in Canada are hoping to avoid border stop crunches through early arrivals, said Richard A. Findlay, coordinator of logistics. Mr. Findlay pointed out the Ogdensburg diocese is not the only one taking part in the event: from Burlington, Vt., 40 buses have been reportedly chartered to bring an estimated 1,600 people to Montreal.

To relieve the traffic jams, Canadian organizers are urging U.S. visitors to arrive at least a day early, and churches on both sides of the border are being "paired" to help participants find lodging, parking and local transportation on a more individualized basis.

Royal Itinerary Firmed Up

Final plans were being firmed up Monday for Queen Elizabeth's and Prince Philip's two-week visit to Canada, which includes a stop at Cornwall, Prescott and Kingston.

The royal party will leave Great Britain and will land at Moncton Airport in New Brunswick July 14. The queen and prince will make short trips in New Brunswick for two days before arriving in Ottawa by airplane at 1:45 p.m. July 16.

The royalty will spend the afternoon in Ottawa at Parliament Hill and will visit Rideau Hall, the home of the Governor General Jeanne Sauve, before arriving at Chrysler Park Marina in Morrisburg at 7:10 p.m.

Queen Elizabeth and Prince Philip will be picked up by the royal barge and will be delivered to the majesty's yacht Britannia where they will spend the evening.

On Tuesday, July 17 the Queen will arrive at the Cornwall Civic Complex at 11:05 a.m. and will walk to Marina 200 to unveil a plaque for the new park at 11:35 a.m. At 11:55 a.m. she will arrive at Trinity Anglican Church in an open car escorted by Royal Canadian Mounted Police. At 12:40 p.m. she will board the royal train and arrive in Prescott at 2:30 p.m.

A tour of Fort Wellington is planned before the Queen and Prince Philip board the train at 4:00 p.m. and arrive at the Kingston Railway Station at 5:50 p.m. At 6:15 p.m. the royal couple will arrive at Amherst View, a small community 10-miles west of Kingston, to officially open the Loyalist Parkway (Highway 33). She will then walk through the Henderson Farm and see a display depicting Ontario's farming industry and will visit Fairfield White House, a historic home, at 6:55 p.m.

At 7:20 the Queen will visit the nearby Royal Mohawk site for a reenactment of the landing of the Loyalist Mohawk Indians.

The Queen will spend the night on Lake Ontario aboard the royal yacht anchored off Fairfield Park. Motorists traveling Bath Road will get a glimpse of the yacht at anchor.

Plans are not complete, but Wednesday, July 18 is a scheduled day of rest for the royal passengers. The yacht is expected to leave Kingston the evening of the 17th or the early morning of the 18th.

It will arrive in Toronto sometime Wednesday morning. The Royal Couple will be making day trips throughout Ontario and will return to Toronto before leaving the country July 27. The queen will return to England and the prince will travel to Los Angeles, Calif., where he will take part in the opening ceremonies of the Summer Olympic Games.

The Britannia, with her navy blue hull and cream-colored decks, is expected to leave Cornwall in the late morning of July 17 and will travel the main shipping channel up river in the daylight hours.

When the Royal Couple traveled the St. Lawrence River 25 years ago to officially open the St. Lawrence Seaway, crowds gathered along the Brockville waterfront to wait for the arrival of the yacht and to watch the Queen and Prince Philip come ashore.

After a trip through the city in a limousine, the royal couple returned to the Britannia where they spent the night anchored off Brockville.

SUBJECT: Possible Presidential Participation in Queen
Elizabeth's St. Lawrence Seaway Visit, July 17 (C)

We agree with your recommendation that the President accept an invitation, if extended, from the Canadian Government to participate in ceremonies on July 17 at Cornwall, Ontario, honoring the St. Lawrence Seaway and have so informed Presidential Scheduling. The day of July 17 has been tentatively set aside for that purpose. (C)

We understand that the President might meet with Queen Elizabeth II and the new Canadian Prime Minister during the ceremonies. We request that State provide us, as soon as possible, with further information on the modalities of invitations to the event and meetings, particularly with respect to who would issue the invitations. Should meetings with the Queen and/or the Canadian Prime Minister be scheduled, we would need briefing memorandums by July 11. (C)

SUBJECT: Possible Invitation to the President to Meet with Queen Elizabeth at the St. Lawrence Seaway -- July 17

State has forwarded a memorandum (Tab A) in response to an NSC request that they evaluate the advisability of the President accepting a possible invitation to participate in ceremonies on July 17 at Cornwall, Ontario, honoring the St. Lawrence Seaway. The Canadians may invite the President to take part in the event and to meet with Queen Elizabeth II, who is scheduled to participate in the ceremonies.

State and I strongly recommend that the President accept such an invitation if extended. The modalities of such an invitation (whether it would be issued by Canada or would be a joint U.S.-Canadian proposal) is uncertain at this time. In the interim, I recommend that you look into the possibility of reserving time on the President's calendar on July 17 for this event and that we o.k. State to begin coordination with the Canadians for the event via a Kimmitt-Hill memo (Tab I).

Jack Matlock *[Signature]* concurs.

RECOMMENDATION

That you sign the attached memorandum from you to State and that you lay down a preliminary marker with the Presidential schedulers that a possible invitation to the President to meet with Queen Elizabeth (and the new Canadian Prime Minister) on July 17 may be extended.

THE WHITE HOUSESubject: Possible Presidential Participation in Queen Elizabeth's
St. Lawrence Seaway Visit, July 17

As part of a two-week visit to Canada this summer, Queen Elizabeth II is scheduled to take part in ceremonies on July 17 at Cornwall, Ontario honoring the St. Lawrence Seaway. (The bilateral treaty which led to the Seaway's construction and which still governs its operations was signed 30 years ago during the Eisenhower Administration.) The Canadians may invite the President to take part in this event given the Seaway's highly visible symbolism of U.S.-Canadian cooperation and interdependence and the waterway's importance to both countries.

We strongly recommend that the President accept such an invitation if extended. There is a possibility that the new Canadian Prime Minister, who will be chosen June 16 by the ruling Liberal Party just before Pierre Trudeau retires, will call an early election for late August or early September, creating problems for a Presidential visit during a hotly contested campaign in which we must remain scrupulously neutral. However, we expect that the Queen would cancel her Canada trip altogether in such an eventuality because of her firm policy of avoiding any hint of electoral involvement. Otherwise, participation by the President would provide a most welcome opportunity to demonstrate the strength and durability of U.S.-Canadian relations and the broad range of bilateral cooperation which the Seaway so dramatically exemplifies.
