3. OECD MINISTERIAL:

TODAY'S SESSION FOCUSED ON MACROECONOMIC POLICY, WITH DON REGAN CARRYING THE BALL FOR US. THE CONCLUSION OF THE DISCUSSION OF EAST-WEST ECONOMIC RELATIONS WAS A SUCCESS FOR US, WITH THE COMMUNIQUE STATING THAT GOVERNMENTS SHOULD ALLOW MARKET FORCES TO DETERMINE TRADE FLOWS, REFRAIN FROM PREFERENTIAL TREATMENT OF THE USSR, AND KEEP EAST-WEST TRADE AND FINANCIAL QUESTIONS UNDER REVIEW IN THE OECD. ONE IMPORTANT ASPECT OF THIS SECTION OF THE COMMUNIQUE IS THAT IT REPRESENTS THE FIRST TIME THE OECD, WHICH INCLUDES THE EUROPEAN NEUTALS AS WELL AS THE NATO ALLIES, JAPAN, NEW ZEALAND, AND AUSTRALIA, AHS ADOPTED A POSITION ON EAST-WEST TRADE.

SUMMARY: AGAINST THE BACKGROUND OF THE RAPIDLY DE-2. TERIORATING INTERNAL ECONOMIC AND POLITICAL SITUATION (REFTELS). MITTERRAND IS NOW PREPARING HIS OWN APPROACH TO THE WILLIAMSBURG SUMMIT. HIS SPEECH OF MAY 9 SUGGESTS THE ATTITUDE HE WILL TAKE. WE DOUBT THAT ANY OF HIS ADVISORS KNOW WHAT HE HAS IN MIND. AND THE SHERPA PREPARATIONS ARE ONLY PARTIALLY RELEVANT. MITTERRAND WILL BE LOOKING TO WILLIAMSBURG FOR THE POLITICAL BENEFITS HE CAN DERIVE FROM IT AND WHICH HE DESPERATELY NEEDS. IF HE CAN GAIN AT LEAST TOKEN APPROVAL OF SOME MEASURES -- SUCH AS HIS IDEA FOR A CONFERENCE ON A NEW BRETTON WOODS AGREEMENT -- WHICH HE CAN PORTRAY AS IMMEDIATELY RELEVANT TO FRANCE'S ECONOMIC PLIGHT, HE WILL BE ABLE TO RETURN TO FRANCE IN A MODERATELY TRIUMPHANT MODE. IF HE CANNOT, THERE ARE INDICATIONS THAT HE MAY SEEK TO PLAY A RIGHTEOUS DAVID TO OUR GOLIATH. IN SUCH CIRCUMSTANCES. MITTERRAND COULD SEEK TO PORTRAY WILLIAMSBURG AS A FAILURE IN WHICH FRANCE'S ALLIES, ESPECIALLY THE U.S., TURNED A DEAF EAR TO FRANCE'S PLIGHT. DESPITE MITTERRAND'S CRIES OF ALARM. THE POLITICAL ADVANTAGE FOR MITTERRAND WOULD BE THAT IT WOULD FREE HIS HANDS FOR MORE DRASTIC MEASURES, SUCH AS TARIFF BARRIERS AND/OR A DEPARTURE FROM THE EUROPEAN MONETARY SYSTEM (EMS). 3. MITTERRAND'S SPEECH OF MAY 9 STANDS IN SHARP CONTRAST TO THE THEMATIC PAPER ON WILLIAMSBURG SENT TO HIM A FEW DAYS EARLIER BY PRESIDENT REAGAN. THE THEMATIC PAPER ASSERTS THAT THIS IS THE "RECOVERY SUMMIT." WITH THE ECONOMIES OF MANY COUNTRIES GETTING MOVING, AND THOSE WHICH ARE NOT RECEIVING FALLOUT BENEFITS. MITTERRAND'S SPEECH IS AN ANGUISHED CRY THAT FRANCE IS IN THE PRESS OF A WORLD ECONOMIC CRISIS. THIS IS NOT SURPRISING, AND IT WOULD BE NAIVE TO THINK THAT MITTERRAND COULD RETURN FROM WILLIAM SBURG TO A FRANCE WHICH IS IN SUCH A DEEP ECONOMIC CRISIS WITH AN OPTIMISTIC MESSAGE. WORSE. THE THEMATIC MESSAGE SUGGESTS THAT FRANCE MIGHT GET A FEW CRUMBS FROM THE RECOVERY TABLES OF THE U.S.. JAPAN, THE UK AND GERMANY. CHAUVINISTIC FRANCE CANNOT ACCEPT SUCH IMPLICATIONS. 4. IT IS IRRELEVANT THAT A FRENCH SHERPA MAY HAVE PERMITTED WORK ON THESE THEMES TO ADVANCE WITHOUT OBJECTION. THE FACT IS THAT EVEN MITTERRAND'S CLOSEST ADVISORS DO NOT KNOW HOW HIS THINKING EVOLVES FROM ONE DAY TO THE NEXT. NO ONE OUTSIDE THE ELYSEE HAD ANY KNOWLEDGE OF HIS "NEW BRETTON WOODS" PROPOSAL UNTIL HE HAD MADE IT -- SENIOR OFFICIALS STILL DO NOT KNOW WHAT IT ENTAILS. IN MEETING ON MAY 19 WITH SPECIAL ADVISOR TO THE PRESIDENT JACQUES ATTALI, I RAISED THE FUNDAMENTAL QUESTION OF WHAT HE EXPECTS TO COME OUT OF WILLIAMSBURG. NOT VERY MUCH, HE QUICKLY REPLIED. HE EXPECTED ALL THE ITEMS AGREED BY THE SHERPAS TO BE ADDRESSED. BUT HE DID NOT THINK THERE WOULD BE ANY SIGNIFICANT AGREEMENTS OR CONTEN-TIOUS DISAGREEMENTS. FRANCE WANTS EVERYTHING TO REMAIN CORDIAL THROUGHOUT. I NOTED THAT MITTERRAND'S RECENT STATEMENT THAT THE U.S. WAS MAKING EUROPE PAY THE BILL FOR ITS BUDGET DEFICIT WASN'T HELPFUL AND TO MY SURPRISE I HAD TO SPEND TEN MINUTES DEMONSTRATING TECHNICALLY WHY MITTERRAND'S VIEW WAS INACCURATE. ATTALI STRESSED THAT THE FRENCH WERE ANNOYED AND CONCERNED BY PRESS REPORTS STATING MITTERRAND INTENDED TO START AN ARGUMENT AT WILLIAMSBURG. HE DENIED THESE ALLEGATIONS STRONGLY AND SAID UNLESS ONE OR MORE OF THE FOLLOWING THINGS HAPPEN. ALL SHOULD GO WELL AS FAR AS FRANCE IS CONCERNED. AREAS WHICH MIGHT PRECIPITATE DIFFICULTY ARE:

- (A) FRANCE IS SENSITIVE TO BEING SINGLED OUT AS THE

3. IN SUM, ATTALI ASSURED ME THAT WHILE MITTERRAND WILL WISH TO DISCUSS THE DOLLAR, INTEREST RATES AND EXCHANGE RATES, HE IS NOT LOOKING FOR AN ARGUMENT AND ABOVE ALL DOES NOT WANT A PUBLIC DISPLAY OF DISAGREEMENT. HE WANTS SOME DOMESTIC BROWNIE POINTS FOR HIS MONETARY INITIATIVE BUT NO MORE.

WHICH SHOULD BE WARMLY ENDORSED IN THE NATO COMMUNIQUE ON FRIDAY. I NOTED THAT THE NATO MEETING IS THE FOURTH IN A SERIES OF WESTERN GATHERINGS, INCLUDING THE OECD. WITH REGARD TO THE MADRID CSCE, IT WAS CLEAR THAT THE FRENCH AND GERMANS WOULD LIKE AN EARLY AGREEMENT, BUT I DETECTED NO EFFORT TO RETREAT FROM OUR AGREEMENT TO SEEK IMPROVEMENTS IN HUMAN RIGHTS LANGUAGE AND IN SOVIET PERFORMANCE ON HUMAN RIGHTS.

6. TOWARDS THE END OF THE MEETING, THE QUESTION OF THE REPLACEMENT OF JOSEPH LUNS AS SATO SECRETARY GENERAL CAME UP. BOTH THE FRENCH AND BRITISH FELT THAT FORMER UK FOREIGN SECRETARY PETER CARRINGTON WOULD BE A SUPERB CANDIDATE. GENSCHER AND I AGREED THAT HE WAS OF VERY HIGH CALIBER. WE ALL AGREED THAT IT WOULD BE USEFUL TO FORM A CONSENSUS OF ONE CANDIDATE EARLY RATHER THAN ALLOW THE SUCCESSION QUESTION TO DETERIORATE INTO AN OPEN COMPETITION. I MADE NO COMMITTMENT ON CARRINGTON, OTHER THAN TO CONSULT PROMPTLY WITHIN OUR GOVERNMENT. I PLAN TO DISCUSS THE QUESTION OF LUNS' SUCCESSOR WITH CAP WEINBERGER, JUDGE CLARK, AND BILL CASEY AND THEN GIVE YOU OUR VIEWS.

Speech

An NSC Schedule Proposal which recommends that the President deliver an address at a dinner hosted by the National Committee for the Bicentennial of the Treaty of Paris on September 28 at the National Portrait Gallery in Washington, for diplomats and historians, is pending (Tab A). We strongly recommend approval of this proposal and encourage your support.

The event is part of a year-long schedule of events which celebrate the bicentennial by which the U.S. became sovereign. The President and Queen Elizabeth II are co-chairpersons of the honorary organizing committee. The President is already participating in several bicentennial events (radio address in April and a proclamation (based on HJR 321) on September 3).

The proposed September 28 dinner speech is a superb target of opportunity which offers numerous advantages:

- o The theme of the overall celebration for this specific dinner is "The Waging of Peace." The Portrait Gallery will have just opened its 2½ month exhibit of portraits and memorabilia titled "Blessed are the Peacemakers." The dinner kicks off a two-day Smithsonian symposium for diplomats and historians on "The Work of Peace." In sum, just the right image.
- o Prime Minister Thatcher will be in town and the British Embassy has stated that Mrs. Thatcher would accept an invitation to attend the event with the President.
- o UNGA will be meeting in New York at the time. A strong guest list is assured. Combined with the peace theme, the event will play extraordinarily well.
- o The timing is just right. The MX-Peacekeeper appropriations vote is scheduled about this time. The arms control portion of the MX package is crucial and would be a key part of the speech. Congressional approval is not assured. On other fronts, the INF deployment/negotiations issue will again be front burner in Europe, and the nuclear freeze proposition may be in the spotlight.

When you sum it all up, the proposal is just right for the President and our programs. The message will be peace and peacemaking and cannot but be a real winner.

The event deserves your strong support. Request that the proposal be approved.
