

Heavy Gold Sales by Soviets, S. Africans Drive Price Down

By Louis Nevin Associated Press

LONDON, Jan. 6—Seeking hard cash to buy grain and prop up the Polish economy, the Soviet Union more than tripled the amount of gold it sold on world markets last year and helped to drive down the price of bullion by one-third, according to dealers and analysts in Europe.

South Africa, which was faced with balance-of-payments difficulties, also increased its sales in 1981 but by a considerably smaller percentage, experts in London and Zurich have reported.

The two countries together account for 75 percent of world gold output, according to Consolidated Gold Fields Ltd., a London mining finance corporation.

A Consolidated analyst, who requested anonymity, estimated that Soviet sales of gold jumped from 80 metric tons in 1980 to nearly 250 tons in 1981, worth \$3.5 billion at current prices. A metric ton is 2,204 pounds.

David Marsh, bullion expert for London's authoritative Financial Times newspaper, said the Soviets were faced with a need for hard currency to finance "high grain imports after the disastrous 1981 harvest, soft prices for oil exports, aid to Poland and the cost of occupying Afghanistan."

South African sales were said to have risen from around 600 tons in 1980 to 675 tons last year, worth \$9.5 billion. These heavy sales helped drive down the price of gold over the year from \$602 a troy ounce at the start of January to \$400.50 on Dec. 31 4
