SUBJECT: Procedures for Picking a New  
Prime Minister of Spain

You inquired about the method of picking a new Prime Minister of Spain, now that Prime Minister Suarez has resigned. I was unable to answer accurately at the time, but have since learned that these are the steps:

1. The King consults with the political leaders.
2. The nomination of the new Prime Minister is sent to the Lower House.
3. If the Lower House approves by a majority, the person selected is confirmed.
4. If it does not approve there may have to be general elections.
