Spanish Ambassador Jose Llado is trying to put together in Suarez honor a dinner for Monday, March 2 and hopes to get you and the Vice President.

As a further signal of our support for Spanish democracy, your presence, I feel, would be very appropriate and timely at such a dinner. The imagery so far as US-Spanish relations are concerned would be very positive. If you can possibly fit the invitation into your schedule (I understand Llado may have already called) I would urge you to go.
