BARBADOS FOLLOWED BY A REGIONAL MEETING. IN ADDITION, ADAMS SAID THAT HE COULD NOT GO TO TRINIDAD AT THIS TIME. CHAMBERS SAID, HOWEVER, THAT HE ALSO COULD NOT LEAVE HIS COUNTRY. MANLEY, HE BELIEVES, COMMITTED A BLUNDER BY ALSO SEVERING HIS TIES WITH THE NATIONAL REVOLUTION COUNCIL. THIS WILL MAKE IT MORE DIFFICULT FOR HIM TO CRITICIZE GOJ COLLECTIVE ACTION. SEAGA INTENDS TO SEEK URGENTLY THAT OTHER CARIBBEAN COUNTRIES ALSO SEVER RELATIONS WITH THE PRG. 9. 1. SY SUMMARY: BREAKING A WEEK-LONG SILENCE, THE CUBAN COMMUNIST PARTY AND GOVERNMENT RELEASED A FORMAL DECLARATION EVENING OF OCTOBER 20, CLAIMING THAT CUBA HAD NO ADVANCE KNOWLEDGE OF THE POWER STRUGGLE WITHIN THE NEW JEWEL MOVEMENT AND DENYING THAT CUBA HAD PLAYED ANY ROLE IN THE EVENTS IN GRENADA. STATEMENT ADMITS, HOWEVER, THAT CASTRO COMMUNICATED WITH THE CENTRAL COMMITTEE OF THE NEW JEWEL MOVEMENT OCTOBER 15, OUTLINING CUBA'S POSITION AND PROMISING CONTINUED CUBAN SUPPORT FOR THE GRENADIAN PEOPLE, REGARDLESS OF ANY CHANGES IN THE PARTY, WHICH CUBA CONSIDERED PURELY AN "INTERNAL MATTER". THE CUBAN GOVERNMENT HAS DECLARED THREE DAYS OF MOURNING OVER BISHOP'S DEATH, THE CIRCUMSTANCES OF WHICH IT SAID MUST BE "CLARIFIED" AND IF IT TURNS OUT TO HAVE BEEN A COLD BLOODED EXECUTION, THE GUILTY SHOULD BE GIVEN EXEMPLARY PUNISHMENTS. COMMENT: IT SOUNDS AS THOUGH CASTRO, AFTER HAVING GIVEN A CLEAR SIGNAL OF CUBAN ACQUIESENCE IN BISHOP'S OUSTER. WAS STUNG BY UNEXPECTED KILLINGS AND IS CONCERNED THAT THE AFTERMATH MAY BE A SET-BACK FOR CUBAN-INSPIRED REVOLUTIONARY MOVEMENTS. END SUMMARY. 2. LET IN A LENGTHY STATEMENT READ ON NATIONWIDE TELEVISION AT 8:00 P.M. OCTOBER 20 (PRESUME FBIS HAS TEXT) AND PUBLISHED THE FOLLOWING MORNING IN THE OFFICIAL DAILY OF THE CENTRAL COMMITTEE OF THE CUBAN COMMUNIST PARTY (PCC), THE CUBAN GOVERNMENT FINALLY BROKE ITS WEEK-LONG SILENCE ON THE EVENTS IN GRENADA (REFTEL). STATEMENT CLAIMS THAT WHEN BISHOP AND A GRENADIAN DELEGATION SPENT 36 HOURS IN CUBA OCTOBER 6-8 (FOLLOWING THEIR TRIP TO HUNGARY AND CZECHOSLOVAKIA), BISHOP NEVER TOLD CASTRO ABOUT THE "SERIOUS ARGUMENTS AND DIFFERENCES" WHICH WERE TAKING PLACE WITHIN THE NEW JEWEL MOVEMENT (NJM). (THE STATEMENT SAYS THAT CASTRO ACCOMPANIED BISHOP ON A TOUR THROUGH THE CIENFUEGOS AREA, WHERE THEY VISITED PLANTS AND TALKED WITH WORKERS. SO THE TWO MEN APPARENTLY SPENT A GREAT DEAL OF TIME TOGETHER. PREVIOUSLY, THE CUBANS HAD ONLY ANNOUNCED THAT THE GRENADIAN DELEGATION TOURED THE AREA, WITH NO INDICATION THAT CASTRO AND BISHOP HAD SPENT MUCH TIME TOGETHER). 3. Les ON OCTOBER 12, ACCORDING TO THE STATEMENT, CUBA FIRST HEARD FROM ITS EMBASSY IN GRENADA THE "SURPRISING AND DISAGREEABLE NEWS" THAT THERE WERE PROFOUND DIVISIONS WITHIN THE CENTRAL COMMITTEE OF THE NEW JEWEL MOVEMENT. SAYING THAT THIS WAS A "PURELY INTERNAL MATTER." STATEMENT CLAIMS THAT THE PCC, "DESPITE OUR FRIENDSHIP WITH BISHOP AND OUR CONFIDENCE IN HIS INTEGRITY AND GOVERNING CAPACITY," GAVE STRICT INSTRUCTIONS TO THE CUBAN REPRESENTATIVES IN GRENADA NOT TO BECOME INVOLVED IN AN INTERNAL PARTY MATTER. ON OCTOBER 15, FIDEL CASTRO SENT THE NEW JEWEL MOVEMENT'S CENTRAL COMMITTEE A MESSAGE OUTLINING CUBA'S POSITION IN TERMS OF NON-INVOLVEMENT IN INTERNAL PARTY MATTERS. FIDEL WENT ON TO SAY. HOWEVER. THAT CUBA WAS CONCERNED THAT DIVISIONS WITHIN THE NJM COULD DAMAGE THE "IMAGE OF THE GRENADIAN REVOLUTIONARY PROCESS." AND RECALLING THE HIGH ESTEEM IN WHICH CUBA HELD BISHOP--HE WARNED THAT IT WOULD BE DIFFICULT TO EXPLAIN THESE EVENTS TO THE CUBAN PEOPLE. MOREOVER, FIDEL'S MESSAGE POINTEDLY SAID THAT CUBA'S COLLABORATION WITH GRENADA "WOULD BE MAINTAINED AS A COMMITMENT TO THE GRENADIAN PEOPLE" REGARDLESS OF HOW THE INTRA-PARTY

STATING THAT NO REVOLUTIONARY DOCTRINE OR PRINCIPLE, NOR ANY INTERNAL DIVISIONS WITH THE NJM CAN JUSTIFY "ATROCIOUS PROCEEDINGS SUCH AS THE PHYSICAL ELIMINATION OF BISHOP AND THE GROUP OF WELL-REGARDED. A MESSAGE WAS PASSED TO US BY THE BRITISH HIGH COMMISSION THIS MORNING THAT THEY HAD ALSO BEEN ADVISED FROM THEIR GRENADA OFFICE THAT MICHELLE GIBBS HAD BEEN ARRESTED AND ASKED US TO INFORM MR. GEORGE CERMAN, A STUDENT AT WAYNE STATE UNIVERSITY IN DETROIT. WHO THEY BELIEVE IS THE HUSBAND OF MICHELLE GIBBS, IMMEDIATELY OF HER ARREST. THE SPELLING MAY OR MAY NOT BE ACCURATE. 4. LATE DEVELOPMENTS: CONSUL GENERAL BUDEIT CALLED THE GRENADA POLICE AT 10:50 THIS MORNING. ACTING COMMISSIONER PATRICK MACLAISH SAID HE HAD NO INFORMATION ON "WHAT'S GOING ON UP THERE" (FORT RUPERT AND RICHMOND HILL PRISON). HE GAVE FOUR PHONE NUMBERS. DISPATCHED TO MFA IN GRENADA: "THE EMBASSY OF THE UNITED STATES OF AMERICA PRESENTS ITS COMPLIMENTS TO THE MINISTRY OF FOREIGN AFFAIRS AND WISHES TO NOTE THAT THE EMBASSY HAS JUST LEARNED THROUGH A BROADCAST OF RADIO FREE GRENADA THAT DIPLOMATIC PERSONNEL HAVE BEEN ISSUED PASSES SO THAT THEY MAY TRAVEL ABOUT FREELY TO CONFIRM THE SAFETY OF THEIR CITIZENS IN GRENADA. WISHING TO AVAIL ITSELF OF THIS OPPORTUNITY TO ASCERTAIN THE WELFARE OF UNITED STATES CITIZENS CURRENTLY IN GRENADA, THE EMBASSY WISHES TO SEND COUNSELOR FOR POLITICAL AND ECONOMIC AFFAIRS (AND CONSUL) KENNETH A. KURZE AND NEWLY ARRIVED THIRD SECRETARY OF EMBASSY (AND VICE CONSUL) LINDA C. FLOHR TO GRENADA. THE EMBASSY HAD ATTEMPTED TO DO THIS ON OCTOBER 19, BUT PEARLS AIRPORT HAD BEEN CLOSED. "IF THEY ARE UNABLE TO COME TO GRENADA ON A SPECIAL FLIGHT WHICH THE EMBASSY UNDERSTANDS IS BEING ORGANIZED FROM BRIDGETOWN, WE PROPOSE TO SEND THEM USING THE EMBASSY'S CHARTERED AIRCRAFT. THE EMBASSY DESIRES THAT MR. KURZE AND MRS. FLOHR ARRIVE IN GRENADA AS SOON AS POSSIBLE. THE EMBASSY WOULD APPRECIATE BEING ADVISED BY TELEX OR TELEPHONE THAT PERMISSION IS GRANTED FOR THIS TRAVEL." THE PEOPLE'S NATIONAL PARTY HAS HAD A CLOSE RELATION—
SHIP WITH THE NEW JEWEL MOVEMENT WHICH GOES BACK TO
ITS EARLIEST DAYS MORE THAN TEN YEARS AGO.
THE NEW JEWEL MOVEMENT AND ITS LEADERS FACED TERRIBLE

MR. MULRONEY: NOR DO I HOLD THE VIEW THAT ONE MUST NECESSARILY REFLECT THE POLITICAL PHILOSOPHY OF THE DONOR NATION SO AS TO BENEFIT FROM FOREIGN AID - NOT BY A LONG SHOT.

MR. BRIAN MULRONEY: MADAM SPEAKER, THE INSTIGATOR OF THE MURDER AND REVOLUTION ON THE ISLAND WAS A MEMBER OF THE GOVERNMENT TO WHICH THE PRIME MINISTER REFERS. THE TAKE—OVER HAS BEEN ABSOLUTE AND MURDEROUS. 2. BETWEEN 1330 AND 1350 THIS AFTERNONN, WE HAD TELEX CONTACT WITH THE ST. GEORGE'S UNIVERSITY SCHOOL OF MEDICINE (BETWEEN GARY SOLIN, ADMIN OFFICER, AND POL COUNSELOR KURZE). THE FOLLOWING IS THE TEXT OF THAT EXCHANGE:

-- GRENADA: KEN, THIS IS GARY SOLIN. DR. BOURNE AND I JUST MET WITH GENERAL AUSTIN HERE. HE WANTS US TO EXPRESS TO YOU HIS DESIRE TO MEET WITH A REPRESENTATIVE OF THE STATE DEPARTMENT, HERE.
