FOLLOWING STATEMENT RELEASED BY THE WHITE HOUSE ON BEHALF OF THE PRESIDENT ON JANUARY 18. REMARKS BY THE DEPARTMENT SPOKESMAN AT DAILY PRESS BRIEFING SENT SEPTEL.

BEGIN TEXT: STATEMENT BY THE PRESIDENT

IT WAS WITH THE GREATEST SHOCK AND SADNESS THAT WE LEARNED EARLY THIS MORNING OF THE DEATH OF DR. MALCOLM KERR, THE PRESIDENT OF THE AMERICAN UNIVERSITY OF BEIRUT. HE WAS A HIGHLY RESPECTED MEMBER OF THE ACADEMIC WORLD WHO, AS PRESIDENT OF AN AMERICAN INSTITUTION IN LEBANON, WORKED TIRELESSLY AND COURAGEOUSLY TO MAINTAIN THE PRINCIPLES OF ACADEMIC FREEDOM AND EXCELLENCE IN EDUCATION. HIS WORK STRENGTHENED THE HISTORICAL, CULTURAL AND ACADEMIC TIES BETWEEN THE U.S. AND LEBANON AND OTHER COUNTRIES OF THE MIDDLE EAST. DR. KERR CARRIED ON A FAMILY TRADITION -- HE HIMSELF WAS BORN IN BEIRUT TO PARENTS ALSO DEDICATED TO THE SERVICE OF MANKIND.

DR. KERR'S UNTIMELY AND TRAGIC DEATH AT THE HANDS OF THESE DESPICABLE ASSASSINS MUST STRENGTHEN OUR RESOLVE NOT TO GIVE IN TO THE ACTS OF TERRORISTS. TERRORISM MUST NOT BE
