HIS WORK STRENGTHENED THE HISTORICAL, CULTURAL AND ACADEMIC TIES BETWEEN THE U.S. AND LEBANON AND OTHER COUNTRIES OF THE MIDDLE EAST. DR. KERR CARRIED ON A FAMILY TRADITION — HE HIMSELF WAS BORN IN BEIRUT TO PARENTS ALSO DEDICATED TO THE SERVICE OF MANKIND.
