1. (U) PRIME MINISTER P.W. BOTHA, SPEAKING IN TZANEEN FEBRUARY 8 DURING THE SOUTPANSBERG BY-ELECTION CAMPAIGN QUOTED THE BIBLICAL KING SOLOMON TO UNDERSCORE SOUTH AFRICA'S PACIFIC INTENTIONS. "THERE WAS A TIME FOR WAR AND A TIME FOR PEACE AND THAT IS WHY I AM NOW WORKING FOR PEACE BECAUSE I DON'T WANT SOUTH AFRICA'S SONS SHOT UNNECESSARILY." THE PRIME MINISTER ADDED

## MESSAGE / ANNOTATION:

THAT HE HOPED TO CONCLUDE SECURITY TREATIES WITH "MORE" NEIGHBORING COUNTRIES IN THE NEAR FUTURE. AN AUDIENCE OF 1,500 PERSONS HEARD THE PM UNDERSCORE THAT COOPERATION WITH NEIGHBORING COUNTRIES HAD ALREADY PREVENTED SOUTH AFRICA FROM BEING SWAMPED BY COMMUNISM AND TERRORISM.

2. (U) ON NAMIBIA, THE PRIME MINISTER SAID THAT HE WOULD NOT THROW SOUTH WEST AFRICA TO THE WOLVES. BUT THE TIME MUST COME WHEN THAT COUNTRY HAD TO STAND ON ITS OWN FEET. WHILE THE GOVERNMENT WOULD NOT FALTER IN THE PROTECTION OF SOUTH AFRICA, IT WOULD NOT MISS AN OPPORTUNITY TO CONCLUDE PEACE WHERE IT WAS POSSIBLE, THE PM SAID.

3. (U) IN A SIMILAR NOTE, FOREIGN MINISTER PIK BOTHA SAID FEBRUARY 8 IN CAPE TOWN (REF B) TO THE FOREIGN CORRESPONDENTS ASSOCIATION THAT A CEASEFIRE WAS "IN PRACTICE AT THIS MOMENT" IN SOUTHERN ANGOLA AND THAT A "VERY PROMISING CLIMATE" EXISTED FOR AN EXTENSION OF THE HALT TO THE BUSH WAR. HE ADDED THAT "STEPS ARE BEING TAKEN BY THE SOUTH AFRICAN GOVERNMENT (SAG) AND, I BELIEVE, THE ANGOLAN GOVERNMENT TO PUT INTO EFFECT A CEASEFIRE FOR 30 DAYS AND, I HOPE, BEYOND." PIK WARNED THAT SOUTH AFRICA STILL INSISTED ON THE WITHDRAWAL OF CUBAN TROOPS FROM ANGOLA BEFORE IMPLEMENTATION OF STEPS TO NAMIBIAN INDEPENDENCE.

4. (U) COMMENT. THE TWO CAMPAIGN SPEECHES IN SOUTHPANSBERG THIS WEEK BY THE SEPARATE BOTHAS (REF A) CLEARLY EMPHASIZE THE SAG EXERCISE IN A PUBLIC RELATIONS PEACE OFFENSIVE. THE GOVERNMENT SEEKS TO SHIFT WHITE PUBLIC OPINION TOWARD ACCEPTANCE OF A SETTLEMENT IN ANGOLA AND NAMIBIA. SO FAR, LITTLE PUBLIC OPPOSITION TO THE EFFORT HAS APPEARED, EVEN FROM THE CONSERVATIVE PARTY WHICH SAG OFFICIALS HAD FEARED WOULD ATTACK THE ANGOLA/NAMIBIA INITIATIVES.

6. THE USE OF THE FIAT 128 IS SYMBOLIC, ACCORDING TO POLICE, AS THIS IS THE SAME TYPE OF VEHICLE USED IN THE MORO KIDNAPPING. THE POLICE AS YET DO NOT HAVE ANY MOTIVATION FOR THE ATTACK, BUT BELIEVE THE RED BRIGADE IS RESPONSIBLE AND ARE WAITING FOR A COMMUNIQUE FROM THE BR GIVING THE REASON FOR THE ASSASSINATION.
