2. BY NOW YOU SHOULD HAVE SEEN ROME 4358 WHICH RAISES, AT LEAST AT THIS EARLY STAGE, THE POSSIBILITY OF A MIDDLE EASTERN TERRORIST CONNECTION WITH A REINVIGORATED RED BRIGADES. PLEASE HOLD THIS INFORMATION CLOSELY. ALTHOUGH FURTHER ANALYSIS IS NEEDED, OTHER PRELIMINARY INDICATIONS BASED ON STATEMENTS BY TERRORIST GROUPS IN BEIRUT AND ELSEWHERE TEND TO SUBSTANTIATE THIS POSSIBILITY. THE COMMUNIQUE OPENS WITH THE FIRST SECTION WHICH CLAIMS RESPONSIBILITY FOR THE TERRORIST ACT, IDENTIFIES THE PRECISE JOB OF THE VICTIM, AND PUTS THIS IN THE PERSPECTIVE OF THE VICTIM BEING AN ENEMY OF THE PROLETARIAT.

6. THE SECOND SECTION, OPENING WITH THE PHRASE "COMRADES, PROLETARIANS" IS A MARXIST-LENINIST DIATRIBE, IDEOLOGICALLY RELATED TO THE VICTIM, BUT CONTAINING NO REFERENCES TO THE VICTIM OR TO THIS OR ANY OTHER TERRORIST ACT. THIS SECTION IN BOTH CASES ENDS WITH A SERIES OF SLOGANS -- THE SIMILARITIES OF WHICH ARE STRIKING. ALTHOUGH BOTH THESE IDEOLOGICAL DIATRIBES CAN BE CONSIDERED SOPHOMORIC, THEY REFLECT THE RED BRIGADES' TRADITIONAL EMPHASIS ON RELATING THEIR ACTS OF VIOLENCE TO CAREFULLY RESEARCHED ACADEMIC ANALYSES BASED ON RESEARCH AS WELL AS MARXIST-LENINIST THEORIZING.

1. X - ENTIRE TEXT.

2. THREE BOMBS WERE EXPLODED ON GROUNDS OF SOVIET U.N. MISSION RIVERDALE HOUSING COMPLEX AT APPROXIMATELY 3:30 AM FEBRUARY 23. TWO WERE PLACED JUST INSIDE FENCE AND DID LITTLE DAMAGE. THIRD WAS APPARENTLY TOSSED OVER FENCE AND DID SUBSTANTIAL DAMAGE TO ONE SOVIET VEHICLE, MINOR DAMAGE TO A COUPLE OF OTHERS. NO ONE WAS INJURED. AN ORGANIZATION CALLED JEWISH DIRECT ACTION HAS REPORTEDLY CLAIMED RESPONSIBILITY FOR THE BOMBINGS.

3. DEPARTMENT SPOKESMAN READ STRONG STATEMENT AT NOON PRESS BRIEFING FEBRUARY 23 CONDEMNING BOMBING AS TERRORIST ACT AND PROMISING FULL EFFORTS TO BRING PERPETRATORS TO JUSTICE. WORLD JEWISH CONGRESS HAS ALSO ISSUED CONDEMNATORY STATEMENT SAYING ACT HAD NOT HELPED EAST-WEST RELATIONS AND HAD CERTAINLY HARMED CAUSE OF SOVIET JEWS. UCSJ, NCSJ AND OTHER ORGANIZATIONS MAY ALSO BE ISSUING STATEMENTS.

4. SOVIET EMBASSY COUNSELOR VADIM KUZNETSOV DELIVERED DIPLOMATIC NOTE TO EUR/SOV DIRECTOR SIMONS PROTESTING U.S. FAILURE TO PROVIDE ADEQUATE PROTECTION. SIMONS REJECTED ACCUSATIONS OF U.S. CONNIVANCE OR COMPLICITY, BUT REITERATED U.S. OUTRAGE OVER ACT AND PROVIDED TEXT OF PRESS STATEMENT. 5. DEPARTMENT HAS BEEN IN CONTACT WITH FBI, WHICH IS CONDUCTING ACTIVE INVESTIGATION OF BOMBING.

6. TEXT OF DEPARTMENT'S STATEMENT FOLLOWS:

BEGIN TEXT: LAST NIGHT, A BOMB WAS THROWN OVER THE FENCE OF THE SOVIET U.N. MISSION'S HOUSING COMPLEX IN NEW YORK. THE BOMB EXPLODED, DOING EXTENSIVE DAMAGE TO A VEHICLE IN THE PARKING LOT AND CAUSING A FIRE. THERE ARE REPORTS THAT A GROUP WHICH CALLS ITSELF JEWISH DIRECT ACTION IS CLAIMING RESPONSIBILITY FOR THIS ACT OF TERRORISM.

THIS DISGRACEFUL, COWARDLY ATTACK BRINGS DISREPUTE UPON THE UNITED STATES. IF IT WAS IN FACT COMMITTED BY A GROUP WHICH PURPORTS TO SUPPORT JEWISH EMIGRATION FROM THE SOVIET UNION, THE GROUP IS DOING A DISSERVICE TO THAT CAUSE. THE UNITED STATES GOVERNMENT HAS LONG SUPPORTED, AND CONTINUES TO SUPPORT THE RIGHT OF SOVIET JEWS TO EMIGRATE TO THE COUNTRY OF THEIR CHOICE. WE HAVE NOTHING BUT RESPECT FOR THE COURAGE OF THOSE SOVIET JEWS WHO, AT THE RISK OF THEIR HOMES, THEIR CAREERS AND IN SOME CASES THEIR FREEDOM, ATTEMPT PEACEFULLY AND OPENLY TO EXERCISE THE BASIC HUMAN RIGHT OF FREEDOM TO TRAVEL.

THE UNITED STATES GOVERNMENT CONDEMNS THIS ACT OF TERRORISM AGAINST THE SOVIET U.N. MISSION COMPLEX. WE HAVE NOTHING BUT CONTEMPT FOR ANYONE WHO WOULD ATTACK THE ACCREDITED REPRESENTATIVES OF A FOREIGN GOVERNMENT ON OUR SOIL. THEY UNDERSTAND NOTHING OF HUMAN RIGHTS AND ARE AKIN TO THE FANATICS WHO HAVE COMMITTED TERRORIST ATTACKS ON OUR OWN DIPLOMATS AND MILITARY PERSONNEL ABROAD.

THERE IS NO PLACE IN THIS COUNTRY FOR TERRORISM AND FOREIGN DIPLOMATS MUST BE ALLOWED TO CARRY OUT THEIR ACTIVITIES WITHOUT A TERRORIST THREAT AGAINST THEM. THE RESOURCES OF THE FEDERAL GOVERNMENT WILL BE BROUGHT TO BEAR TO FIND OUT WHO COMMITTED LAST NIGHT'S BOMBING AND TO PROSECUTE THE PERPETRATORS TO THE FULL EXTENT OF
