1. FOLLOWING IS TEXT OF THREAT LETTER RECEIVED AT
BRITISH EMBASSY, MARCH 10, 1984, IN NOON DELIVERY OF
EGYPTIAN-DELIVERED MAIL. ORIGINAL ENVELOPE AND LETTER
HAVE BEEN TURNED OVER TO EGYPTIAN COUNTER-TERRORIST
GROUP IN MOI. AMEMBASSY HAS NOT RECEIVED SUCH A LETTER.
FRENCH EMBASSY ADVISED RSO THEY HAD NOT RECEIVED SUCH
A LETTER, BUT HAVE COPY OF BRITISH LETTER.

2. TEXT FOLLOWS:

QTE IN THE NAME OF ALLAH, THE COMPASSIONATE, THE MERCIFUL
BLOODY IMPERIALISTS:

WE CHARGE YOU WITH THE MURDER OF THOUSANDS OF MUSLIMS AT
THE HANDS OF YOUR BUTCHER - OUR ZIONIST ENEMY IN LEBANON
AND PALESTINE, ON THE GOLAN HEIGHTS AND SINAI. YOU HAVE
SUPPLIED TEL AVIV WITH FUNDS, MODERN WEAPONS AND
GUARANTEED INTERNATIONAL POLITICAL SUPPORT FOR ITS
ACTIONS. NOWADAYS YOUR TROOPS IN LEBANON ARE MURDERING
WOMEN, OLD PEOPLE AND CHILDREN ONLY BECAUSE THEY ARE
FAITHFUL MOSLIMS.

WE CANNOT TREAT YOUR BLOODY CRIMES WITH INDIFFERENCE.
THEREFORE, WE SHALL WAGE A MERCILESS WAR AGAINST YOU WITH
YOUR METHODS. FROM NOW ON NEITHER YOU NOR YOUR WIVES
AND CHILDREN WILL FIND PEACE ON MUSLIM SOIL. ANY U.S.,
