1. (U) UNKNOWN ASSAILANTS SHOT AND KILLED MARXIST "UNITED LEFT" (IU) MAYOR SAUL MUNOZ MENACHO OF CENTRAL SIERRA CITY OF HUANCAYO IN EARLY MORNING, JULY 24 ASSAILANTS INTERCEPTED MAYOR WHILE HE WAS ENGAGED IN DAILY EXERCISE ROUTING (JOGGING) IN PUBLIC STREET.
2. (LOU) DETAILS OF ASSASSINATION PUBLISHED IN LIMA PRESS JULY 25 CONFLICT. "EXPRESO" ATTRIBUTED KILLING TO "TWO YOUNG PEOPLE, PRESUMABLY MEMBEERS OF SENDERO LUMINOSO." "REPUBLICA" DES RIBED ASSASSINS AS "THREE ADULTS BETWEEN 40 AND 50 YEARS OLD." SAME NEWSPAPER SPECULATED THAT KILLERS USED GUN WITH SILENCER. "EXPRESO" STORY INCLUDED DEALI THAT NEIGHOBORS WHO HASTENED TO SITE OF KILLINGS WERE "ALARMED BY GUNSHOTS."
3. (LOU) INITIAL CONCLUSIONS AS TO KILLERS' IDENTITY SIMILARLY VARY. PRESS HEADLINES ATTRIBUTED ASSASSINATION TO SENDERO LUMINOSO TERRORISTS. SOME OF DEAD MAYORS PARTY CONFRERES ACCUSE "RIGHTIST FORCES" (SENATOR CARLOS MALPICA) OF RESPONSIBLITY. MOSCOW- LINING COMMUNIST PARTY (PCP), IN PAID AD PUBLISHED JULY 25. ACCUSED " REACTIONARY FORCES" THAT ARE CARRYING OUT IN PERU "A POLICY OF ANTI-COMMUNIST TERROR PURSUED BY

IMPERIALISM ON A WORLD LEVEL." IU'S "NATIONAL DIRECTIVE COMMITTEE" (TOP POLICY ORGAN), HOWEVER, SIMPLY CONDEMNED ASSASSINATION WITHOUT ATTEMPTING TO LEAP TO CONCLUSIONS CONCERNING RESPONSIBILITY.

4. (U) GOP AUTHORITIES QUICKLY CONDEMNED KILLING, WITH PRESIDENT BELAUDE SENDING PERSONAL CONDOLENCES TO LIMA MAYOR/IU PRESIDENT ALFONSO BARRANTES. INTERIOR MINISTER PERCOVICH DENIED ANY ROLE IN KILLINGS BY "RIGHTISH PARAMILITARIES" BUT, AT SAME TIME, DECLINED TO SAY THAT SENDERO IS GUILTY. HE ASSURED THAT POLICE WILL INVESTIGATE EVENT FULLY.

5. (C) COMMENT: KILLING COULD BE WORK OF SENDERO. SENDERO'S DISLIKE OF LEGAL MARXISTS, WHO VOLUNTARILY PARTICIPATE IN DEMOCRATIC "ELECTORALIST" POLITICS, IS WELL KNOWN. KILLING ALSO WOULD FIT INTO PATTERN OF PREVIOUS TERRORIST ASSASSINATIONS OF LOCAL GOVERNMENT OFFICIALS (E.G., NOVEMBER 8 SLAYING OF MAYOR OF CERROR DE PASCO-REFTEL). AT SAME TIME HOWEVER, ALTERNATIVE EXPLANATIONS CANNOT YET BE RULED OUT. EMBASSY WILL REPORT RESULTS OF GOP INVESTIGATION, WHEN KNOWN.

1. ~~SECRET~~ - ENTIRE TEXT.
2. EMBASSY INFORMED BY GOS TODAY (JULY 28) THAT IT MAY ANNOUNCE THIS AFTERNOON APPREHENSION OF A "LIBYAN TRAINED TERRORIST". WE UNDERSTAND THAT THE AMERICAN EMBASSY IS TO BE MENTIONED AS ONE OF THE ALLEGED TERRORIST TARGETS. WE BELIEVE THE ALLEGED TERRORIST IS A SUDANESE NATIONAL.
3. WE ARE ALSO INFORMED THAT THE GOS IS CONSIDERING MAKING SOME STATEMENT EXPRESSING ITS SATISFACTION AT RECENT U.S. NAVAL MANEUVERS IN THE GULF OF SIRTE, PERHAPS LINKING THE EXERCISE TO THE LIBYAN THREATS AGAINST SUDAN.
4. SHOULD WE BE QUESTIONED ABOUT THE GOS ANNOUNCEMENT AND THE TERRORIST THREAT, WE WILL REFER MEDIA REPRESENTATIVES TO THE SUDANESE MINISTRY OF INFORMATION.
5. EMBASSY COMMENT: GOS SEES OUR NAVAL EXERCISE AS HELPING TO DETER LIBYAN AGGRESSION AGAINST IT OF VARIOUS SORTS. WE HAVE PREVIOUS KNOWLEDGE OF THIS ARREST; INFORMATION WAS COMMUNICATED TO THE DEPARTMENT  IN THE PAST YEAR THERE HAVE BEEN OTHER WELL-FOUNDED REPORTS OF TERRORIST PLANNING
