1. A POWERFUL BOMB EXPLODED AT THE ANTWERP COURTHOUSE (PALAIS DE JUSTICE) EARLY SUNDAY MORNING, CAUSING HEAVY DAMAGE BUT NO INJURIES. LOCAL OFFICIALS SUSPECT THE BASQUE TERRORIST ORGANIZATION ETA-M FOR COMMITTING THE BOMBING IN RETALIATION FOR THE EXTRADITION TO SPAIN OF TWO SUSPECTED ETA MEMBERS ARRESTED IN ANTWERP. THERE IS NO EVIDENCE AT THIS POINT OF AN ANTI-SEMITIC MOTIVE FOR THE BOMBING.
2. NO ONE HAS YET CLAIMED RESPONSIBILITY FOR THE BOMBING, BUT THE RED CROSS HEADQUARTERS IN BRUSSELS RECEIVED A CALL FROM A WOMAN SPEAKING FRENCH WITH A SPANISH ACCENT WARNING OF THE EXPLOSION MINUTES BEFORE IT OCCURRED. THE 2 KILOGRAM BOMB, ATTACHED TO A CLOCK AS A TIMING MECHANISM, DESTROYED PARTS OF THE SECOND AND THIRD FLOORS AND DAMAGED THE ROOF OF THE COURTHOUSE. IT EXPLODED AT 4:27 AM SUNDAY MORNING, WHEN THE COURTHOUSE AND THE SURROUNDING AREA WERE DESERTED. DAMAGE IS ESTIMATED TO BE SEVERAL HUNDRED THOUSAND DOLLARS OR MORE. PARTS OF THE BOMB WERE FOUND IN THE RUINS BUT WE HAVE AS YET NO FURTHER DETAILS ON THE MECHANISM.
3. IN RECENT WEEKS THE LOCAL PRESS HAS REPORTED ETA-M THREATS AGAINST THE BELGIAN GOVERNMENT IN REVENGE FOR THE EXTRADITION OF THE TWO ETA SUSPECTS ON JULY 14. ALTHOUGH THE POLICE HAVE NO LEADS AS YET ON THE PERPETRATORS, THE ANTWERP CHIEF PROSECUTOR STATED THAT HE BELIEVES ETA-M CARRIED OUT THE BOMBING TO FULFILL THEIR THREATS.
4. POST WILL REPORT FURTHER DETAILS AS THEY COME TO LIGHT.
