THEIR CAR EXPLODED IN ISTANBUL HAVE BEEN IDENTIFIED AS LEBANESE.  
(REPORTED IN ATACSUMS 129 AND 132) DOCUMENTS WRITTEN IN ARMENIAN  
AND PHOTOS FOUND IN THEIR HOTEL ROOM ALLEGEDLY INDICATE  
RECONNAISSANCE OF AT LEAST SIX TURKISH INSTALLATIONS AND BUSINESSES  
IN ISTANBUL. TURKISH AUTHORITIES BELIEVE THESE TWO WERE MEMBERS OF

ATAC COMMENT:(S/NF/NC) THE ARA IS MOST LIKELY LINKED WITH THE  
EXTREME RIGHT WING ARMENIAN REVOLUTIONARY FEDERATION (DASHNAG PARTY)  
(ARF) VICE THE ARMENIAN SECRET ARMY FOR THE LIBERATION OF ARMENIA  
(ASALA), A LEFTIST-MARXIST ORGANIZATION AS WAS THEORIZED IN ATACSUM  
129-84. THE ARF FORMED THE RIGHTIST TERRORIST GROUP, THE JUSTICE  
COMMANDOS FOR THE ARMENIAN GENOCIDE (JCAG) IN 1975 AS A COUNTER TO

A. (U) PERU: DURING THE EVENING OF 13 SEPTEMBER, FIFTEEN  
"SUBVERSIVES" IN A HIGH SPEED BOAT ATTACKED THE SAN LORENZO NAVAL  
BASE ACROSS FROM CALLAO PORT, AND FIRED SUBMACHINE GUNS AT THE  
GUARDS. AFTER A SHORT SHOOT-OUT THE BOAT SLIPPED INTO FOG AND WAS  
CHASED BY PERUVIAN NAVY BOATS IN THE FIRST ATTACK EVER ON A NAVAL

REPUBLICAN GUARD DETACHMENT AT THE PRISON ASKED FOR REINFORCEMENTS TO GUARD AGAINST POSSIBLE ATTACKS. ELSEWHERE, THE SHINING PATH (SL) CONTINUED ITS REIGN OF TERROR IN THE COUNTRYSIDE ON 12 AUGUST WHEN 17 PEASANTS WERE MURDERED BY A SL GROUP IN PAMPANA SETTLEMENT, 55 KM NORTHEAST OF AYACUCHO. THE TERRORISTS ALSO LOOTED AND SET FIRE

ATAC COMMENT: (C) THE SPEED BOAT ATTACK HAS NOT BEEN ATTRIBUTED TO ANY SPECIFIC GROUP, BUT IT MOST LIKELY WAS CARRIED OUT BY SL MEMBERS. IF SO, THIS ATTACK PROBABLY MARKS THE FIRST TIME THAT THE SL HAS CONDUCTED A WATERBORNE ATTACK ON GOVERNMENT PROPERTY AND WOULD REPRESENT A NEW TACTIC ON THE PART OF THE SL. THE ATTACK ALSO COULD BE A TEST OF DIVERSIONARY TACTICS WITH THE ACTUAL TARGET ULTIMATELY BEING FRONTON PRISON. SL ACTIVITY, WHICH HAS BEEN HEAVY IN RECENT WEEKS, WILL PROBABLY CONTINUE AT CURRENT LEVELS AS EVIDENCED BY THE ATTACK ON PAMPANA SETTLEMENT.

## B. PHILIPPINES (U)

1. (FOUO) NAVINVSERVRA SAN MIGUEL REPORTS THAT APPROXIMATELY 5 SEP 84, A MARINE WAS SHOT WHILE ON GUARD DUTY AT NAVCOMMSTA SAN MIGUEL. SUBJECT REPORTED THAT HE WAS ASSAULTED AND SHOT BY FILIPINO NATIONALS.

ATAC COMMENT: (FOUO) SUBSEQUENT INTERROGATION REVEALED NO GUNSHOT BY PHILIPPINE NATIONALS OR ANY TERRORIST INVOLVEMENT. THE WOUND WAS SELF INFLICTED.

2. (C/NF) A RELIABLE SOURCE HAS REPORTED THAT THE AUGUST TWENTY ONE MOVEMENT (ATOM) ASKED THE COMMUNIST PARTY OF THE PHILIPPINES (CPP)  
 PAGE 06 RULYS662749 ~~SECRET~~ NOFORN  
 TO ASSIST IN THE ATOM-SPONSORED "TARMAC TO TARLAC" RALLY (SEP 11-17) BY PROVIDING BOARD, LODGING, AND REFRESHMENTS TO RALLY PARTICIPANTS. THE CPP REPORTEDLY AGREED AFTER SOME HESITANCY BUT INSISTED THAT CPP PROPAGANDISTS BE ALLOWED TO SPEAK TO RALLY PARTICIPANTS AT SELECTED TOWNS ALONG THE ROUTE. THIS IS THE FIRST INSTANCE CPP TO ASSISTANCE TO AN ORGANIZATION CREATED TO PERPETUATE THE MEMORY OF BENIGNO AQUINO. IT IS UNLIKELY, HOWEVER, THAT THE CPP HAS INFILTRATED ATOM OR OTHER AQUINO INSPIRED ORGANIZATIONS DUE TO THE CPP'S DEMANDS AND THEIR HESITANCY IN EXTENDING HELP IN THE RALLY. PEOPLE COULD SEE THAT LOCAL INDUSTRY (THROUGH BOMBINGS AND ARSON FROM TIME TO TIME) AS WELL AS THE TOURIST INDUSTRY WERE BEING AFFECTED. IN A RECESSIONARY PERIOD WHEN EFFORTS ARE UNDERWAY TO CREATE EMPLOYMENT, THE TERRORISTS WERE CREATING A BACKLASH.

7.A. (U) LEBANON; AT ABOUT 0844Z, 20 SEP 84 A VEHICLE BOMB EXPLODED OUTSIDE OF THE AMERICAN EMBASSY ANNEX IN EAST BEIRUT WHERE THE MAJORITY OF U.S. EMBASSY PERSONNEL ARE LOCATED. U.S. PAGE 03 RULYS669421 ~~SECRET~~ NOFORN WNINTEL AMBASSADOR BARTHOLOMEW AND BRITISH AMBASSADOR MIERS WERE SLIGHTLY INJURED AND TWO AMERICANS (INCLUDING ONE USN MEMBER) HAVE BEEN CONFIRMED DEAD. PRESS REPORTS INDICATE MORE THAN TWENTY LEBANESE WERE KILLED AND SCORES OF OTHERS, BOTH AMERICAN AND LEBANESE, WERE WOUNDED. VARIOUS REPORTS INDICATE THE BOMB MAY HAVE BEEN CARRIED IN A STATION WAGON WITH DIPLOMATIC PLATES THAT WAS PART OF A MOTORCADE. ACCORDING TO PRESS REPORTS, AS THE VEHICLE STOPPED AT THE BARRICADES NEAR THE FRONT OF THE ANNEX, A LEBANESE SECURITY GUARD CHALLENGED THE DRIVER'S IDENTIFICATION. REPORTEDLY THE GUARD WAS SHOT DEAD AND THE VEHICLE THEN ACCELERATED AND ZIG-ZAGGED THROUGH THE CONCRETE BARRICADES TOWARD THE EMBASSY ENTRANCE. LEBANON RADIO REPORTED THAT U.S MARINE GUARDS FIRED AT THE VEHICLE BEFORE IT EXPLODED ABOUT 5-10 METERS FROM THE BUILDING ENTRANCE. LOCAL SOURCES HAVE VARIOUSLY ESTIMATED THE FORCE OF THE BLAST AS EQUIVALENT TO 150-500KG OF EXPLOSIVE. IT CREATED A CRATER TWO AND ONE HALF METERS DEEP AND FOUR METERS WIDE, AND HURLED METAL DEBRIS AND MASONRY UP TO 300 METERS AWAY. MAJOR DAMAGE WAS REPORTED TO THE FRONT OF THE U.S. EMBASSY ANNEX BY THE PRESS. ATAC COMMENT: ~~(S/NF)~~ THE ISLAMIC JIHAD, A TERM USED BY IRANIAN-SUPPORTED SHIA EXTREMIST GROUPS, IS THE SAME ORGANIZATION THAT CLAIMED RESPONSIBILITY FOR THE APRIL 1983 CAR BOMB EXPLOSION THAT DESTROYED THE FORMER U.S. EMBASSY IN WEST BEIRUT KILLING 63 PEOPLE AND BOMBED THE U.S. MARINE BUILDING NEAR THE BEIRUT INTERNATIONAL AIRPORT IN OCTOBER 1983 WHICH RESULTED IN THE DEATHS OF 241 U.S. MARINES AND SAILORS. THIS SAME GROUP THREATENED ON 7 SEP 84 TO ATTACK AMERICANS IN THE MIDDLE EAST IN RETALIATION FOR A U.S. VETO OF A UNITED NATIONS SECURITY COUNCIL RESOLUTION

CONDEMNING ISRAEL FOR ITS ROLE IN LEBANON. NAVATAC ADVISORY 007-84 (DIRNAVINSERV 110105Z SEP 84) ASSESSED THE IRANIAN SUPPORTED TERRORIST THREAT TO DEPARTMENT OF THE NAVY ASSETS IN THE MIDDLE EAST, NORTH AFRICA AND SOUTHERN EUROPE AS MODERATE-TO-HIGH BASED ON THE ISLAMIC JIHAD THREAT AND OTHER INDICATORS. TODAY'S BOMBING IN BEIRUT SHOULD NOT BE VIEWED AS THE FINAL OR ONLY TERRORIST ACTION IN FULFILLMENT OF THE ISLAMIC JIHAD THREAT. INDEED, ACTIONS BY ISRAELI BACKED MILITIA UNITS IN SOUTHERN LEBANON ON 20 SEP 84 WHICH RESULTED IN THE DEATHS OF 12 UNARMED LEBANESE CIVILIANS IN THEIR HOMES IN THE VILLEGE OF SOHMOR CAN ONLY SERVE TO EXACERBATE LEBANESE MOSLEM SENSITIVITIES TO THE PRESENCE OF ISRAELI SOLDIERS IN LEBANON. THE U.S IS INTIMATELY LINKED TO THE ISRAELI PRESENCE IN THE VIEW OF MANY LEBANESE. ALTHOUGH, THERE IS NO INTELLIGENCE TO IDENTIFY SPECIFIC AMERICAN TARGETS, THERE ARE INDICATORS THAT AMPLE JUSTIFICATION EXISTS FOR THE ISLAMIC JIHAD ORGANIZATION OR SIMILAR FACTIONS TO STRIKE OUT AT "THE GREAT SATAN" IN RETALIATION FOR PERCEIVED WRONGS. B.A. (U) JAPAN: THE JAPANESE LIBERAL-DEMOCRATIC PARTY (LDP) OFFICE IN TOKYO WAS SET ABLAZE ON WEDNESDAY EVENING, 19 SEP. SEVERAL MEN DROVE A TRUCK INTO THE LDP PARKING LOT AND, USING A HOME-MADE FLAMETHROWER MOUNTED ON TOP OF THE TRUCK, SET FIRE TO THE THIRD FLOOR OF THE BUILDING. THE FIRE BURNED FROM THE THIRD TO THE SECOND AND ALL THE WAY UP TO THE SEVENTH FLOOR BEFOR BEING EXTINGUISHED. TWO GROUPS HAVE CLAIMED RESPONSIBILITY FOR THE ATTACKS. THE FIRST GROUP, IDENTIFYING ITSELF AS "KYUKOKU REIDAN" (NFI), PHONED A TOKYO MASS MEDIA OUTLET AND SAID THE ATTACK WAS IN REVENGE FOR THE POSTWAR STRUCTURE AFTER THE POTSDAM DECLARATION. THE SECOND GROUP, "CHUKAKU-HA", PHONED A TOKYO NEWSPAPER OFFICE AND CLAIMED RESPONSIBILITY. THE CHUKAKU-HA DID NOT STATE THE PURPOSE OF THE ATTACK. TOKYO POLICE ARE OF THE OPINION THAT THE CHUKAKU-HA ARE THE PERPETRATORS OF THE FIRE. (VARIOUS FBIS, AMEMBASSY TOKYO 200903Z SEP 84)

ATAC COMMENT: (S) THIS ATTACK IS VERY SIMILAR TO THE MARCH 83 CHUKAKU-HA ATTACK AGAINST THE TOKYO INTERNATIONAL AIRPORT AUTHORITY OFFICE. IN BOTH ATTACKS, HOME-MADE FLAMETHROWER DEVICES WERE USED. THE CHUKAKU-HA IS A RADICAL LEFTIST TERRORIST ORGANIZATION THAT AMONG OTHER CAUSES, OPPOSES THE CONSTRUCTION OF THE INTERNATIONAL AIRPORT AT NARITA, JAPAN. THE LDP (WHICH IS THE RULING PARTY IN JAPAN) IS FORMULATING A PLAN FOR THE "SECOND PHASE" OF CONSTRUCTION
