SUBJECT: BOMBINGS IN LYON

1. DURING THE NIGHT OF OCTOBER 3-4, SIX BOMBS EXPLODED IN VARIOUS LOCATIONS IN LYON. FOUR OTHERS WERE DISCOVERED AND DEFUSED BY POLICE. EXPLOSIONS CAUSED EXTENSIVE PROPERTY DAMAGE BUT ONLY A FEW VERY MINOR INJURIES. AS BOMBS WERE ALL TIMED TO EXPLODE BETWEEN 1 AM AND 2 AM, IT IS CLEAR THAT THEY WERE NOT SET WITH INTENT TO KILL. TARGETS INCLUDED THE PALACE OF JUSTICE, TWO OFFICES OF AIR FRANCE, ELECTRICITE DE FRANCE, CREDIT LYONNAIS, AND A POST OFFICE.

2. NO ONE HAS CLAIMED CREDIT FOR BOMBINGS BUT POLICE STATE THEY ARE SURE THAT FLNC (CORSIKAN TERRORISTS) IS RESPONSIBLE.

BOMBINGS BEAR ALL THE MARKS OF FLNC STYLE AND LYON, PARTICULARLY PALACE OF JUSTICE, IS A LOGICAL TARGET BECAUSE SUSPECTS IN SUMMER SHOOTOUT AT AJACCIO PRISON ARE BEING HELD HERE.

3. POLICE AND OTHER SOURCES DISMISS ANY CONNECTION BETWEEN THE EXPLOSIONS AND DEMONSTRATIONS IN LYON DURING THE LATE AFTERNOON OF OCTOBER 3. THE DEMONSTRATIONS BY SMALL BUSINESSMEN, MERCHANTS AND TRUCK DRIVERS PROTESTING GENERAL ECONOMIC CONDITIONS (THE DOLLAR TOOK A BEATING AS THEY PASSED OUR OFFICE ON THE WAY TO THE PREFECTURE) INVOLVED NO MORE THAN 250 PERSONS BUT CREATED CHAOS DURING RUSH HOUR TRAFFIC.
