1. (U) SUMMARY AND COMMENT: DURING OCTOBER 4 PRESS CONFERENCE ARMED FORCES COMMANDER MOERDANI PLEDGED INDONESIA WOULD NEVER GIVE IN TO "TERRORIST BLACKMAIL." WARNING THE MILITARY WOULD DO WHATEVER IS NECESSARY TO PROTECT THE NATION, HE DENIED ITS ACTIONS WERE MERELY AIMED AT PROTECTING ETHNIC CHINESE AGAINST OTHER INDONESIANS. IN OTHER REMARKS, MOERDANI CAUTIONED HUMAN RIGHTS ACTIVISTS AGAINST "ACTING LIKE THEIR COLLEAGUES ABROAD," SHOULD IT PROVE NECESSARY TO DETAIN "100 INDIVIDUALS IN ORDER TO PROTECT 150 MILLION INDONESIANS," CALLED ON ALL CITIZENS TO AID THE GOVERNMENT IN COMBATTING TERRORISM AND INDICATED THE GOI WAS

## MESSAGE / ANNOTATION:

INVESTIGATING POSSIBLE LINKS BETWEEN THE OCTOBER 4 BOMBINGS AND LAST MONTH'S TANJUNG PRIOK RIOTS. JAKARTA MILITARY COMMANDER SUTRESNO TOLD THE PRESS THE BOMBS HAD BEEN SET TO EXPLODE AT TEN MINUTE INTERVALS AND INDICATED CASUALTIES HAD TOTALED TWO DEAD AND 16 INJURED. ONE SUSPECT IS BEING HELD, ACCORDING TO SUTRISNO.

2. (S) LIKE GOVERNMENT PRESS STATEMENTS ISSUED SHORTLY AFTER THE TANJUNG PRIOK RIOTS, MOERDANI AND SUTRISNO'S REMARKS STRIKE US AS BEING UNUSUALLY CANDID, AND PARALLEL FOR THE MOST PART INFORMATION WE HAVE RECEIVED FROM OTHER SOURCES (REFTEL). AS SUCH, THEY APPEAR TO REFLECT THE POLICY DECISION TAKEN AFTER TANJUNG PRIOK TO ATTEMPT TO COMBAT INEVITABLE RUMORS BY QUICKLY MAKING PUBLIC A DETAILED ACCOUNT OF CIRCUMSTANCES SURROUNDING INCIDENTS OF THIS TYPE, (A NUMBER OF THEORIES ARE NONETHELESS CIRCULATING AROUND TOWN, WHICH WE ARE REPORTING SEPTTEL.) JUDGING FROM THE TONE OF MOERDANI'S REMARKS, IT SEEMS CLEAR THE GOVERNMENT PLANS TO CRACK DOWN HARD ON INDIVIDUALS AND GROUPS SUSPECTED OF INVOLVEMENT IN THE BOMBINGS. END SUMMARY AND COMMENT.

3. (U) OCTOBER 5 JAKARTA PRESS GAVE EXTENSIVE COVERAGE TO YESTERDAY'S BOMBING ATTACKS ON CHINESE BUSINESS ESTABLISHMENTS HERE. MOST ARTICLES CONCENTRATED ON STATEMENTS BY ARMED FORCES COMMANDER MOERDANI AND JAKARTA MILITARY COMMANDER TRY SUTRISNO MADE AT AN OCTOBER 4 PRESS CONFERENCE AT WHICH THEY DISCUSSED THE INCIDENTS.

4. (U) MOERDANI WAS QUOTED AS REACTING STRONGLY TO THE BOMBINGS, WARNING THE GOI WOULD NEVER GIVE IN TO "TERRORIST BLACKMAIL." HE PLEDGED THE ARMED FORCES WOULD DEFEND NATIONAL DEVELOPMENT WITH "ALL THE MEANS AT THEIR DISPOSAL." WHILE CAUTIONING THAT THIS MIGHT BE COSTLY, MOERDANI INSISTED THE MILITARY HAD NO OTHER CHOICE IF IT WERE TO DEFEND "150 MILLION" INDONESIANS AGAINST THIS THREAT. IN THIS CONNECTION, MOERDANI RECALLED INDONESIA HAD FACED TERRORISM BEFORE, AS IN 1981 WHEN ITS FORCES KILLED GARUDA AIRLINE HIJACKERS IN BANGKOK, AND ASSURED HIS LISTENERS THE MILITARY WAS PREPARED TO DO SO AGAIN.

5. (U) MOERDANI VIGOROUSLY DENIED ALLEGATIONS, WHICH HE SAID HAD BEEN PUBLISHED IN ILLEGAL PAMPHLETS
