2. WE INFORMED THE HELLENIC CIVIL AVIATION AUTHORITY (HCAA) ABOUT THE PROPOSED VISIT OF THE JOINT GOVERNMENT/INDUSTRY TEAM ON EXTRAORDINARY SECURITY MEASURES, INCLUDING THE TEAM'S OFFER OF TECHNICAL ASSISTANCE FOR SUPERVISORS, MANAGERS, AND SCREENING PERSONNEL INVOLVED IN CIVIL AVIATION SECURITY. THE HCAA'S DEPUTY GOVERNOR, KOMPOLIS, AGREED TO THE TEAM'S VISIT AND SUGGESTED THAT IT TAKE PLACE SOMETIME DURING THE LAST 10 DAYS OF JANUARY.

3. AS THE GREEK POLICE HAVE DIRECT RESPONSIBILITY FOR SECURITY AT ATHENS AIRPORT AND FOR IMPLEMENTING ALL COUNTER-TERRORIST MEASURES IN GREECE, THE EMBASSY MULTANEOUSLY RAISED THE TEAM'S VISIT WITH THE SECRETARY GENERAL OF THE MINISTRY OF PUBLIC ORRDER, KOSTAS TSIMAS. TSIMAS WELCOMED SUCH A VISIT AND HOPED IT COULD OCCUR AROUND FEBRUARY 10.

CITATION FROM THE DECLARATION BY THE RAF PRISONERS ON HUNGER STRIKE: "AFTER THE FRG SUCCEEDED WITH THE INTEGRATION OF THE WESTERN EUROPEAN POLICE FORCES, AN OPENLY MILITARY MEASURE, AS PREVENTION AGAINST THE ARMED ANTAGONISTS WITHIN THE METROPOLITAN AREAS, THE IMPERIALISTIC AIM IS NOW THE TRANSFORMATION OF THESE POLICE FORCES (NOTE: VERBAL TRANSLATION: STATE SECURITY BLOC. END NOTE) INTO THE "EUROPEAN SUPPORT COLUMN OF NATO."

"THE STRUCTURE, WHICH SHALL FUNCTION INDEPENDENTLY FROM THE CONSENSUS OF THE NATIONAL GOVERNMENTS FOR THE INTEREST OF THE STRATEGIC POWER BLOCK . . . (INCOMPLETE SENTENCE)

THE FRENCH IMPERIALISTS -- PRESENTLY THE SOCIAL DEMOCRATS AT THE FRONT LINE HAVE RECOGNIZED THE SIGNIFICANCE OF THIS REACTIONARY PROJECT. KOHL AND MITTERAND MAKE EVERY EFFORT TO CARRY THROUGH THE POLITICAL UNIFICATION OF WESTERN EUROPE BY ELIMINATING INTERNAL EUROPEAN DISCREPANCIES.

THEREFORE, THE FRENCH SOCIALISTS ARE ON THE FRONT LINE: "BECAUSE SOCIAL DEMOCRACY HISTORICALLY DERIVES FROM THE BETRAYAL OF THE WORKERS' MOVEMENT, ITS FEELING FOR THE BASIC PROBLEMS OF LEGITIMIZING THE CAPITALISTIC SYSTEM IS ESPECIALLY STRONG." CITED FROM THE PRISONERS STATEMENT DURING COURT PROCEEDINGS, DEC. 84.

WE CALL IT LIQUIDATION OF THE EUROPEAN DISCREPANCIES, BECAUSE IMPERIALISM CANNOT OFFER A PERSPECTIVE FOR PEOPLE, ITS (EMPHASIZED) CONSENSUS IS POWER.

"THEIR POWER IS MILITARY STRATEGY, FIGHT AGAINST REVOLUTION, MACHINES, BUT IT HAS NO CONTENT, ONLY POWER, NOTHING ELSE. IT IS THEIR REACTION TO THE UNIFYING STRENGTH OF THE INTERNATIONAL FIGHTERS FOR LIBERATION, ALSO IN WESTERN EUROPE." (FROM THE DECLARATION FOR HUNGER STRIKE BY THE PRISONERS OF THE RAF DATED DECEMBER 4, 1984).

WITH OUR ACTION WE JOIN THE DEVELOPING ANTI-IMPERIALISTIC FRONT IN WESTERN EUROPE.

THE VISION OF THE RESISTANCE IN WESTERN EUROPE IS TO GAIN THE CAPABILITY TO FIGHT FOR FREEDOM, TO DEVELOPE A STRATEGY OF RESISTANCE IN THE CAPITAL REGIONS OF WESTERN EUROPE BY STUDYING THE GROWTH OF CLASS WARFARE TOGETHER.
