AS REPORTED IN REFTELS A AND B, THE BUNDESKRIMINALAMT (BKA) HAS DETERMINED THROUGH AN ANALYSIS OF DOCUMENTS SEIZED DURING ARRESTS OF MEMBERS OF THE RED ARMY FACTION (RAF) THAT THE RAF WAS PREPARING FOR A THREE PRONGED OFFENSIVE WHICH WAS TO INCLUDE 1) A HUNGER STRIKE BY THE RAF MEMBERS IN PRISON, 2) LOW LEVEL TERRORIST ATTACKS AGAINST NATO GOVERNMENTAL AND ECONOMIC INSTITUTIONS BY RAF PERIPHERY GROUPS AND SUPPORTERS, AND 3) A HIGH LEVEL TERRORIST ATTACK BY THE RAF HARD CORE. THEIR ANALYSIS ALSO LED THEM TO THE CONCLUSION THAT THIS HIGH LEVEL ATTACK BY THE HARD CORE MIGHT WELL BE A KIDNAPPING ATTEMPT ON AMBASSADOR BURNS. THEY HAVE ALSO SAID THAT THE PROBABILITY OF SUCH AN ATTEMPT WILL BECOME MORE CRITICAL AS THE CONDITION OF THE HUNGER STRIKERS WORSENS AND MAY REACH A PEAK IF AND WHEN SOME OF THEIR MEMBERS DIE.

## MESSAGE / ANNOTATION:

TO DETERIORATE. GERMAN PRISON AUTHORITIES, WHO HAD EARLIER MADE PREPARATIONS FOR THE FORCE FEEDING OF THE HUNGER STRIKERS BY SHIFTING THEM TO PENITENTIARIES WITH ADEQUATE MEDICAL FACILITIES, HAVE REPORTED THAT TWO HUNGER STRIKERS ARE PRESENTLY BEING "ARTIFICIALLY FED."
