1. CONSULATE GENERAL S FRONT OUTSIDE WALL WAS PAINTED DURING THE NIGHT OF JANUARY 30-31 WITH GRAFFITTI. THERE WAS A DESIGN OF A BLACK CIRCLE CONTAINING A STAR, WITHIN WHICH THERE IS A BLACK SUBMACHINE GUN. THE DESIGN APPEARS TO HAVE BEEN PAINTED WITH THE AID OF A STENCIL. UNDER THE DESIGN ARE THE INITIALS A.D ALSO IN BLACK PAINT. THE DESIGNS WERE PAINTED TO THE

MESSAGE / ANNOTATION:

LEFT OF THE ENTRANCE, PRESUMABLY TO AVOID POSSIBLE SURVEILLANCE BY OUR SIDEWALK SCANNING CAMERA. ACCORDING TO THE GIPN SPECIAL POLICE WHO CONVOY THE VICE CONSUL AND CONSUL GENERAL TO THE OFFICE, THE DESIGN DID INDEED APPEAR TO BE THE LOGO OF THE TERRORIST ASSASSINATION GROUP DIRECT ACTION. PICTURES WERE TAKEN AND AS SOON AS WE HAVE THEM WE WILL SEND THEM TO THE EMBASSY PARIS FOR SY.

2. FIVE INSPECTORS CAME IMMEDIATELY TO THE CONSULATE GENERAL FROM POLICE COMMISSIONER TOCHEPORT'S OFFICE TO DISCUSS THE INCIDENT AND TO TAKE OUR REQUESTS FOR FURTHER SECURITY PROTECTION. THEY TOLD US THAT THERE HAD BEEN NO OTHER DIRECT ACTION GRAFFITTI REPORTED AROUND TOWN (AND THEY PROMISED TO LET US KNOW IF ANY APPEARED). THEY CONFIRMED THAT THE LOGO DID APPEAR TO BE THAT OF DIRECT ACTION. PERHAPS EVEN MORE OMINOUS, THEY ADDED THAT DIRECT ACTION HAS NEVER BEFORE MANIFESTED ITSELF IN THIS CITY. THEY SAID THAT DIRECT ACTION DOES CLAIM RESPONSIBILITY FOR ITS ACTS SYSTEMATICALLY, AND SAID THEY WOULD LET US KNOW IF THEY HEARD ANY SUCH CLAIM.

3. CONSUL GENERAL STRESSED OUR CONCERN TO THE INSPECTORS. WE REQUESTED ON THE SPOT THAT THE GRAFFITTI BE ERASED (AFTER THE PICTURES ARE GIVEN TO US TODAY), THAT THE PATROLS BE MADE MORE FREQUENT AT THE CONSULATE GENERAL, AND AT THE RESIDENCES OF BOTH THE CONSUL GENERAL AND THE VICE CONSUL. WE ALSO ASKED FOR A STATIC GUARD AT THE CONSULATE GENERAL FOR AT LEAST THE NEXT MONTH. CONSUL GENERAL IS FOLLOWING UP IN WRITING WITH THE PREFET DE POLICE AND THE POLICE COMMISSIONER.

4. COMMENT. THIS IS THE SECOND POSSIBLE TERRORIST WARNING (REFTEL) AT THIS CONSULTE GENERAL IN THREE WEEKS. THIS SEEMS THE MORE OMINOUS OF THE TWO. END COMMENT
